BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	several disturbing incidents have occurred relating to school
3	safety. In March 2018, a boy at Kipapa elementary school
4	reported that a man approached him in a school restroom and
5	tried to grab his hand. On December 12, 2019, a police manhunt
6	in Waipahu prompted officials at Waipahu high school and August
7	Ahrens elementary school to place those schools on lockdown. On
8	February 27, 2020, Ilima intermediate school, Pohakea elementary
9	school, Kaimiloa elementary school, and Campbell high school
10	initiated a lockdown after report of an armed man in Ewa Beach.
11	The legislature further finds that young children often
12	lack the capacity to properly assess and identify the potential
13	dangers posed by the presence of individuals who are not
14	authorized to be present on a school or program's campus. The

- 19 that shall be assigned to each public elementary school or state
- 20 prekindergarten program, the department shall consider:

1	SECTION 4. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so
3	much thereof as may be necessary for fiscal year 2025-2026, and
4	the same sum or so much thereof as may be necessary for fiscal
5	year 2026-2027 for the provision of school resource officers and
6	guards at public elementary schools and state prekindergarten
7	programs under the pilot program established under section 3.
8	The sums appropriated shall be expended by the department
9	of education.

11	SECTION 6. This Act shall take effect on July 1, 2025.
