A BILL FOR AN ACT

RELATING TO ELECTRIC BICYCLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

Section 249-1, Hawaii Revised Statutes, is amended by amending the definition of "moped" to read as 2 3 follows: 4 ""Moped" means a device upon which a person may ride that 5 has: 6 (1) Two or three wheels in contact with the ground; 7 (2)A motor having a maximum power output capability 8 measured at the motor output shaft, in accordance with 9 SAE International standards, of two horsepower (one 10 thousand four hundred ninety-two watts) or less and, 11 if it is a combustion engine, a maximum piston or 12 rotor displacement of 3.05 cubic inches (fifty cubic 13 centimeters) and that will propel the device, 14 unassisted, on a level surface at a maximum speed no 15 greater than thirty miles per hour; and

Section 291C-141, Hawaii Revised Statutes, is amended by amending subsection (c) to read as follows: 13 14 "(c) [These] Except as otherwise provided in section 15 291C-143.5, these regulations applicable to bicycles shall apply 16 whenever a bicycle is operated upon any highway or upon any 17 bicycle path set aside for the preferential or exclusive use of 18 bicycles subject to those exceptions stated herein." 19 SECTION 6. Section 291C-143, Hawaii Revised Statutes, is 20 amended by amending subsection (b) to read as follows:

3	(h) Any person who operates a low-speed electric bicycle
4	recklessly in disregard for the safety of persons or property
5	shall be assessed penalties as set forth in section 291C-161(b).
6	(i) In addition to any requirements provided under section
7	291C-150(b), each entity that provides low-speed electric
8	bicycles for hire shall provide to each renter or lessee a copy
9	of the low-speed electric bicycle ordinances or rules that have
10	been adopted by the applicable county.
11	(j) Low-speed electric bicycles shall only be stored or
12	docked at specific locations that shall be authorized by the
13	counties."
14	SECTION 8. Section 291C-147, Hawaii Revised Statutes, is
15	amended by amending subsection (b) to read as follows:
16	"(b) Every bicycle, except low-speed electric bicycles,
17	shall be equipped with a red reflector at least four square
18	inches in size [which] <u>that</u> shall be visible for six hundred
19	feet to the rear when directly in front of lawful lower beams of
20	head lamps on a motor vehicle. Every low-speed electric bicycle

1 shall be equipped with a lighted lamp that is visible from the 2 rear." SECTION 9. Section 291C-148, Hawaii Revised Statutes, is 3 4 amended by amending subsections (b) and (c) to read as follows: 5 "(b) [Unless] Except as otherwise provided in section 6 291C-143.5 or otherwise prohibited [-7] by law, rule, or 7 ordinance, a bicycle may be driven at a speed of ten miles per 8 hour or less on a sidewalk or sidewalk area; provided that the 9 driver of the bicycle shall yield the right-of-way to any pedestrian and that bicycle riding shall be prohibited on 10 11 sidewalks in business districts. This section shall not be construed as preempting the 12 (C) 13 director of transportation's or counties' authority to control 14 parking on sidewalks under [section] sections 291C-114[-] and 15 291C-143.5. Nor shall this section be construed as prohibiting 16 the director or a county from authorizing parking on sidewalks 17 when the authorization is promulgated in accordance with 18 [section] sections 291C-114[-] or 291C-143.5." 19 SECTION 10. Section 707-700, Hawaii Revised Statutes, is

amended by amending the definition of "vulnerable user" to read

Report Title:

Transportation; Low-Speed Electric Bicycles; Regulations

Description:

Amends various definitions of "moped" throughout the Hawaii Revised Statutes to exclude low-speed electric bicycles. Deletes an unused term from Chapter 286, Hawaii Revised Statutes. Establishes regulations for low-speed electric bicycles and clarifies the applicability of certain conflicting regulations that are applicable to all bicycles.
