## A BILL FOR AN ACT

RELATING TO CESSPOOLS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the health of 2 Hawaii's people and quality of Hawaii's waters are being harmed 3 by pollution from cesspools. Hawaii has more than eighty 4 thousand cesspools that discharge about fifty million gallons of 5 wastewater into the State's groundwater every day. Cesspools 6 are antiquated, substandard systems that damage public health; 7 pollute drinking water; and lower water quality in streams, ground waters, nearshore marine areas, and the ocean. Cesspool 8 9 pollution also harms public recreation and the precious coral 10 reefs on which Hawaii's economy, shoreline, fisheries, and native species depend. The United States Geological Survey has 11 12 estimated that coral reefs in Hawaii provide flood protection 13 benefits to 6,800 people and \$836,000,000 annually in averted 14 damages to property and economic activity. To protect public 15 health, property, and the environment including coral reefs, 16 cesspools should be replaced by connecting homes to sewerage 17 systems or, in areas that are too remote to be feasibly

connected, upgraded either with individual on-site wastewater
 disposal systems or cluster wastewater treatment systems.

3 The legislature recognizes that maintaining the cleanliness
4 of the State's waters is a matter of statewide concern that
5 falls under the legislature's obligation to enact laws pursuant
6 to article XI, section 7, of the Hawaii State Constitution.

7 The legislature further finds that the department of health 8 needs additional personnel to facilitate compliance with the 9 mandate of section 342D-72, Hawaii Revised Statutes, and to 10 administer thousands of cesspool upgrades in the coming years.

11 Accordingly, the purpose of this Act is to:

12 (1) Establish a new cesspool conversion section within the
13 department of health's wastewater branch that is
14 dedicated to facilitating the conversion of cesspools

15 within the State; and

16 (2) Establish and appropriate funds for new positions17 within the new cesspool conversion section.

18 SECTION 2. Chapter 342D, Hawaii Revised Statutes, is
19 amended by adding a new section to part IV to be appropriately
20 designated and to read as follows:

1	SECTION 3. There is appropriated out of the general		
2	revenues of the State of Hawaii the sum of \$ or so		
3	much thereof as may be necessary for fiscal year 2025-2026 and		
4	the same sum or so much thereof as may be necessary for fiscal		
5	year 2026-2027 to establish three full-time equivalent (3.0 FTE)		
6	permanent positions within the cesspool conversion section		
7	established pursuant to section 342D- , Hawaii Revised		
8	Statutes.		
9	The sums appropriated shall be expended by the department		
10	of health for the purposes of this Act.		
11	SECTION 4. New statutory material is underscored.		
12	SECTION 5. This Act shall take effect on December 31,		
13	2050; provided that section 3 shall take effect on July 1, 2025.
