### A BILL FOR AN ACT

RELATING TO HOUSING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that there are SECTION 1. 2 approximately fifteen thousand affordable housing units in the 3 State whose affordability restrictions will expire by the year In one prominent example, Kukui Gardens was built in 1970 4 2100. 5 with subsidized federal loans, however, when the affordability 6 restrictions expired, the State was compelled to buy back the 7 project from the owner for \$132.5 million in 2006 to preserve the tenants in place. The owner of Kukui Gardens then used the 8 9 proceeds of the sale to fund other non-housing-related 10 charitable donations. The legislature further finds that action 11 is needed to ensure that the value generated by 12 taxpayer-financed housing development is recycled to build more 13 housing. 14 Accordingly, the purpose of this Act is to require that, to

15 be eligible for funds from the rental housing revolving fund, 16 applicants shall be either governmental agencies or 17 organizations that are required to use all financial surplus,
