## A BILL FOR AN ACT

RELATING TO COMMUNITY SCHOOLS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that in Hawai'i, community
2	schools are innovative, thriving hubs of learning, in which
3	partnerships and collaboration create a'o mai, a'o aku, places to
4	learn, teach, or impart knowledge, and establish reciprocal
5	relationships between learners and place, content and context,
6	and schools and communities. Community schools are needed to
7	help align and leverage resources already in the community to
8	address students' barriers to learning. Through inclusive
9	decision-making, a shared vision, actionable data, and trusting
10	pilina, community schools focus on supporting students and
11	families through the following key practices:
12	(1) Expanded enriched learning opportunities;
13	(2) Rigorous community-connected classroom instruction;
14	(3) Culture of belonging, safety, and care;
15	(4) Powerful family and student engagement;
16	(5) Integrated systems of support;
17	(6) Collaborative leadership, shared voice, and power; and

(7) Grounded in Hawai'i. 1 2 The legislature further finds that community schools are a proven, time-tested strategy that can produce short-term results 3 4 like improving family engagement and attendance and decreasing behavioral referrals. It is also proven to produce long-term 5 6 results like improving academic scores, school culture and climate, student enrollment, teacher retention, and graduation 7 8 rates. A study on community schools in Albuquerque, New Mexico 9 found that for every dollar invested in a community school coordinator returned approximately \$7.11 of net benefits. 10 11 Another study on community schools in New York City found that 12 community schools had positive and significant effects on ontime grade progression for elementary and middle school 13 14 students, and high school graduation rates. A recent report by 15 the Learning Policy Institute cited community schools as a 16 promising approach to improving attendance because they can 17 create the conditions needed for learning. 18 Accordingly, the purpose of this Act is to appropriate funds to the department of education to support community 19
