## A BILL FOR AN ACT

RELATING TO WORKERS' COMPENSATION MEDICAL BENEFITS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 386-21.9, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "§386-21.9 Medical care, services, and supplies for 4 firefighters suffering from cancer. (a) If a claim for [leukemia, multiple myeloma, non-Hodgkin lymphoma, or cancer of 5 6 the lung, brain, stomach, esophagus, intestines, rectum, kidney, 7 bladder, prostate, breast, female reproductive organs, or 8 testes] any form of cancers or diseases covered under subsection 9 (b) filed by an employee with five or more years of service as a 10 firefighter is accepted or determined to be compensable, section 11 386-21 shall remain applicable [ $\neq$ ], unless the employer proves 12 that the cancer or disease was not associated with the 13 firefighting duties; provided that the employer shall be liable 14 for medical care, services, and supplies for a minimum of one 15 hundred ten per cent, and not to exceed one hundred fifty per 16 cent of fees prescribed in the Medicare Resource Based Relative

Specifies that an employer may prove that the cancer or disease was not associated with the firefighting duties to deny medical benefits under workers' compensation law. Effective 7/1/3000. (HD1)
