A BILL FOR AN ACT

RELATING TO DESALINATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. The purpose of this Act is to establish a
2	desalinat	ion planning task force to determine whether the use of
3	desalinat	ion for large-scale water consumption in the State is
4	feasible.	
5	SECT	ION 2. (a) There is established within the department
6	of land a	nd natural resources a desalination planning task force
7	for admin	istrative purposes.
8	(b)	The task force shall comprise the following members:
9	(1)	The director of health or the director's designee;
10	(2)	The chairperson of the board of agriculture or the
11		chairperson's designee;
12	(3)	The chairperson of the commission on water resource
13		management or the chairperson's designee, who shall
14		serve as chair;
15	(4)	The chief executive officer of the office of Hawaiian
16		affairs or the chief executive officer's designee;

1	(5)	The chairs of the senate and house of representatives
2		standing committees on water and land or their
3		designees; and
4	(6)	The director or manager and chief engineer of each
5		county's department or board of water supply.
6	(c)	The task force shall:
7	(1)	Conduct a study to determine the water demand for
8		housing, agriculture, and industrial uses throughout
9		the State, including in high-need areas;
10	(2)	Examine the feasibility of using desalination as a
11		source of clean and safe drinking water to supplement
12		the State's existing groundwater and surface water
13		resources;
14	(3)	Determine the extent to which the use of desalination
15		will:
16		(A) Assist the State in meeting its projected future
17		water needs; and
18		(B) Improve the resiliency of the State's water
19		systems, considering in particular the impacts of
20		the water crisis caused by the contamination at
21		the Red Hill Bulk Fuel Storage Facility;

1	(4)	Determine whether it is feasible for the commission or
2		water resource management to integrate desalination
3		into its overall water management plans;


- Consider the extent to which the construction of (5) desalination plants may affect or interfere with historical sites and Native Hawaiian cultural sites and practices, including burial sites; and
- Address environmental concerns associated with the 8 (6) operation of desalination plants, including high 10 energy consumption.
- The members of the task force shall serve without 11 (d) compensation but shall be reimbursed for expenses, including 12 travel expenses, necessary for the performance of their duties. 13
- No member of the task force shall be subject to 14 chapter 84, Hawaii Revised Statues, solely because of the 15 16 member's participation in the task force.
- The department of land and natural resources shall 17 provide administrative assistance to the task force. 18
- The task force shall submit a report of its findings 19 (a) 20 and recommendations, including any proposed legislation, to the

- 1 legislature no later than twenty days prior to the convening of
- 2 the regular session of 2026.
- 3 (h) The task force shall cease to exist on June 30, 2026.
- 4 SECTION 3. This Act shall take effect upon its approval.
