A BILL FOR AN ACT

RELATING TO STUDENT TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that school bus service
- 2 provided by the department of education is essential for getting
- 3 students to and from school, particularly for students who lack
- 4 other transportation options or face hardship in obtaining
- 5 school transportation services due to economic difficulty.
- 6 However, chronic bus driver shortages have led to the
- 7 cancellation or consolidation of many school bus routes,
- 8 reducing transportation options for families across the State.
- 9 The legislature additionally finds that at the beginning of
- 10 the 2024-2025 school year, the department of education reported
- 11 that among six bus service contractors statewide, an estimated
- 12 eighty-seven additional drivers were needed to fully staff
- 13 school bus routes. The department also noted that over the last
- 14 school year, one hundred seventy-five school bus drivers have
- 15 vacated their positions.
- 16 The legislature further finds that in August 2024, the
- 17 department of education announced plans to temporarily suspend

- 1 one hundred eight bus routes serving middle and high school
- 2 students in central Oahu and students of all grade levels on the
- 3 east side of the island of Hawaii. The announcement marked the
- 4 third year in a row that the department has canceled bus
- 5 services at the start of the school year.
- **6** The legislature also finds that a lack of adequate school
- 7 bus transportation service exacerbates chronic absenteeism and
- 8 undermines student achievement, especially in rural, remote, and
- 9 socioeconomically disadvantaged school communities.
- 10 Accordingly, the purpose of this Act is to establish and
- 11 appropriate funds for student transportation coordinators for
- 12 each county to strengthen student transportation services across
- 13 the State.
- 14 SECTION 2. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$400,000 or so much
- 16 thereof as may be necessary for fiscal year 2025-2026 and the
- 17 same sum or so much thereof as may be necessary for fiscal year
- 18 2026-2027 for four full-time equivalent (4.0 FTE) permanent
- 19 student transportation coordinator positions to strengthen
- 20 student transportation services across the State; provided that
- 21 each county shall have one student transportation coordinator.



- 1 The sums appropriated shall be expended by the department
- 2 of education for the purposes of this Act.
- 3 SECTION 3. This Act shall take effect on July 1, 2025.
