A BILL FOR AN ACT

RELATING TO COMMUNITY OUTREACH BOARDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that county neighborhood 2 and advisory boards provide local communities with opportunities to participate in government. Likewise, community outreach 3 boards serve as an intermediary between residents and government 4 leaders to understand local concerns, gather and disseminate 5 6 information, and create solutions in a collaborative environment. As community outreach boards serve as a grassroots 7 8 tool, ensuring open access to board activities is essential to 9 thriving communities statewide. 10 Therefore, the purpose of this Act is to: Define "community outreach board"; 11 (1) 12 Include community outreach boards in existing (2) provisions of the sunshine law that relate to 13 14 neighborhood boards; and 15 Authorize neighborhood board and community outreach (3) 16 board members to attend meetings or presentations 17 related to official board business statewide.

neighborhood board or community outreach board meeting has been 1 issued, but before the scheduled meeting, may be the subject of 2 discussion at the scheduled meeting if timely action on the 3 matter is necessary for public health, welfare, and safety. At 4 a duly noticed meeting, a board may take action on an 5 6 unanticipated event in the public interest that is not on the 7 agenda in the same manner as if the board had held an emergency meeting to take action on the issue, pursuant to section 92-8." 8 9 SECTION 7. Statutory material to be repealed is bracketed 10 and stricken. New statutory material is underscored. SECTION 8. This Act shall take effect January 1, 2491. 11
