A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that persons born with 1
- 2 variations in their physical sex characteristics in the United
- 3 States are subject to medical practices that can inflict
- 4 irreversible physical and psychological harm on them starting in
- infancy, harms that can last throughout their lives. Many of 5
- 6 these procedures are done with the stated aim of making it
- 7 easier for children to grow up "normal" and integrate more
- 8 easily into society by helping them conform to a particular sex
- 9 assignment. The results are often catastrophic as the supposed
- 10 benefits are largely unproven, and there are generally no urgent
- 11 health considerations at stake.
- The legislature further finds that persons with variations 12
- 13 in their physical sex characteristics, many of whom identify
- 14 with the term "intersex", are subjected to nonemergency
- 15 surgeries and justified by generalized assumptions about
- 16 people's preferences about their bodies' appearance and
- 17 function. These assumptions perpetuate gender stereotypes and

- 1 may not reflect an individual's actual preferences when the
- 2 individual is capable of articulating the individual's wishes.
- 3 The legislature recognizes that leading pediatric hospitals
- 4 have begun to institute partial bans on these surgeries on
- 5 patients who are too young to participate in a meaningful
- 6 discussion of the implications of these surgeries.
- 7 The legislature also recognizes the importance of ensuring
- 8 the bodily autonomy of persons in Hawaii, including those who
- 9 are trans or gender nonconforming and are born with variations
- 10 in their sex characteristics.
- 11 The legislature hereby finds and declares that the State
- 12 has a compelling interest in protecting the physical and
- 13 psychological well-being of children, including those born with
- 14 variations in their physical sex characteristics. The enactment
- 15 of legislation is necessary to safeguard the bodily autonomy of
- 16 people born with variations in their physical sex
- 17 characteristics and to ensure patient-centered care that
- 18 conforms with best practices in the medical profession.
- 19 Accordingly, the purpose of this Act is to prohibit the
- 20 performance of certain procedures on individuals born with
- 21 variations in their physical sex characteristics who are under

1	one year of age, unless the procedure is a surgery required to
2	address an immediate risk of physical harm.
3	SECTION 2. Chapter 453, Hawaii Revised Statutes, is
4	amended by adding a new section to be appropriately designated
5	and to read as follows:
6	"§453- Prohibited procedures on infants. (a) No
7	physician or surgeon shall authorize or perform the following
8	procedures on an individual born with variations in the
9	individual's physical sex characteristics who is under one year
10	of age, unless the procedure is a surgery required to address an
11	immediate risk of physical harm:
12	(1) Clitoroplasty, clitoral reduction, and clitoral
13	recession, including corporal-sparing procedures;
14	(2) Gonadectomy;
15	(3) Any procedure that lengthens or reroutes a urethra
16	from its native orifice; or
17	(4) Vaginoplasty, urogenital sinus mobilization, and
18	vaginal exteriorization.
19	(b) As used in this section:
20	"Individual born with variations in the individual's
21	physical sex characteristics" means an individual born with

1	physical	traits, including genitals, gonads, hormone function,
2	or chromo	somal patterns, that vary from stereotypical notions
3	regarding	the development, appearance, or function of sex
4	character	istics, including those variations resulting from
5	androgen	insensitivity syndrome and congenital adrenal
6	hyperplas	ia.
7	"Sur	gery required to address an immediate risk of physical
8	harm" mea	ns any of the following:
9	(1)	Surgery to remove tissue that poses a significant
10		heightened clinical risk of malignancy relative to
11		that of the general population;
12	(2)	Surgery to allow urine to exit the body, to treat
13		urinary incontinence, or to make a minimally invasive
14		adjustment to urinary function in order to decrease a
15		risk of infection or renal complication in a patient
16		whose current urinary function puts them at a
17		demonstrated clinical risk of infection or renal
18		complication;
19	(3)	Surgery that is required to treat complications of a
20		previous surgery and cannot be delayed without
21		increasing physical health risks to the patient; and



1	(4) Any other surgery necessary to preserve life in the
2	event of a medical emergency."
3	SECTION 3. New statutory material is underscored.
4	SECTION 4. This Act shall take effect on July 1, 2025.

Report Title:

Prohibition; Procedures; Individuals Born with Variations in Physical Sex Characteristics; Infants

Description:

Prohibits physicians and surgeons from performing certain procedures on individuals born with variations in their physical sex characteristics who are under one year of age, unless the procedure is a surgery required to address an immediate risk of physical harm.
