A BILL FOR AN ACT

RELATING TO BIRTH CERTIFICATES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 338-17.7, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: 2 3 "(a) The department of health shall establish, in the 4 following circumstances, a new certificate of birth for a person 5 born in this State who already has a birth certificate filed with the department and who is referred to below as the "birth 6 7 registrant": 8 (1) Upon receipt of an affidavit of paternity, a court 9 order establishing paternity, or a certificate of 10 marriage establishing the marriage of the natural 11 parents to each other, together with a request from 12 the birth registrant, or the birth registrant's parent 13 or other person having legal custody of the birth 14 registrant, that a new birth certificate be prepared 15 because previously recorded information has been

16 altered pursuant to law;
