A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE FIFTEENTH SENATORIAL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The director of finance is authorized to issue
- 2 general obligation bonds in the sum of \$38,700,000 or so much
- 3 thereof as may be necessary and the same sum or so much thereof
- 4 as may be necessary is appropriated for fiscal year 2025-2026
- 5 for the purpose of capital improvement projects for the
- 6 fifteenth senatorial district, as follows:
- 7 1. Moanalua High School
- 8 A. Plans, design, and construction
- 9 for new weight room; equipment and
- 10 appurtenances.

- 12 Construction \$16,000,000
