SENATE CONCURRENT RESOLUTION

URGING THE COUNTIES TO ADOPT LOCAL ZONING ORDINANCES TO REQUIRE OWNERS OF AGRICULTURAL-ZONED LANDS TO EXECUTE AND RECORD DECLARATIONS THAT ACKNOWLEDGE STATE AND COUNTY AGRICULTURAL LAND USE REGULATIONS AND REQUIREMENTS AND PENALTIES FOR NONCOMPLIANCE.

1 WHEREAS, while nearly half of the State's 4,100,000 acres
2 is designated for agricultural use, approximately eight percent
3 of these lands is being used for actively growing crops and 18.5
4 percent of these lands is being used for grazing animals; and
5

6 WHEREAS, according to the Department of Agriculture's 2020
7 Update to the Hawaii Statewide Agricultural Land Use Baseline
8 study, between 2015 and 2020, the overall statewide acreage of
9 planted crops decreased by twenty-one percent, or 31,207 acres,
10 in large part due to the closure of the Hawaiian Commercial and
11 Sugar Company on Maui; and
12

13 WHEREAS, during this time, there was an overall seven
14 percent increase in other crop types, or an additional 7,588
15 acres, including a notable twenty-two percent increase in
16 diversified agriculture, which added 3,695 acres, demonstrating
17 that farming is still a viable industry in Hawaii; and
18

19 WHEREAS, the study also provided the following statewide
20 statistics:
21

22 (1) For the island of Hawaii, there are 62,461 crop acres
23 and 552,091 pasture acres;
24

25 (2) For the island of Kauai, there are 23,191 crop acres
26 and 42,345 pasture acres;

1 (3) For the island of Maui, there are 7,718 crop acres and
2 115,241 pasture acres;

4 (4) For the island of Molokai, there are 3,880 crop acres
5 and 37,867 pasture acres;

7 (5) For the island of Lanai, there are 105 crop acres and
8 0 pasture acres; and

9
10 (6) For the island of Oahu, there are 23,227 crop acres
11 and 18,035 pasture acres; and

12
13 WHEREAS, while the statewide totals are 120,632 crop acres
14 and 765,579 grazing acres, for a total of 886,211 acres, this
15 total is less than one-half of the nearly 2,000,000 acres
16 statewide designated for agriculture use; and

17
18 WHEREAS, while state and county agricultural land use
19 regulations seek to require or at least encourage active
20 agricultural use of agricultural-zoned lands, it is clear that a
21 significant amount of these lands is not being used for
22 agricultural production; and

23
24 WHEREAS, the Hawaii State Plan, pursuant to chapter 226,
25 Hawaii Revised Statutes, includes objectives and policies for
26 the economy related to agriculture, including the objectives of
27 "growth and development of diversified agriculture throughout
28 the State" and "an agriculture industry that continues to
29 constitute a dynamic and essential component of Hawaii's
30 strategic, economic, and social well-being", along with eighteen
31 companion policies; and

33 WHEREAS, each of the counties' general plans also calls for
34 supporting local agriculture industries and promoting food
35 sustainability; and

37 WHEREAS, the Department of Agriculture and Hawaii Farmers
38 Union run farm apprentice mentoring programs, and the University
39 of Hawaii's GoFarm Hawaii Program offers a Farmer-to-Farmer
40 Mentorship series of webinars and other training programs, among
41 other opportunities to grow local farmers; and

1 WHEREAS, it is in the best interest of the State and the
2 counties to pursue policies and take actions that result in an
3 increase in the number of acres that are in active farming and
4 ranching use and that increase the production of local
5 agricultural products, which will promote food security and
6 sustainability while increasing the number of agricultural jobs,
7 thus promoting economic diversity; and
8

9 WHEREAS, Maui County currently requires owners of
10 agricultural-zoned lands to submit a declaration of compliance
11 when obtaining a building permit, acknowledging state and county
12 land use requirements and penalties for violations; and
13

14 WHEREAS, such declarations should be utilized by all four
15 counties and should be recorded so that future owners are also
16 aware of these requirements; and
17

18 WHEREAS, the counties should also make available to owners
19 of agriculture lands information on local agricultural
20 resources, including farm bureaus and farm apprenticeship and
21 mentoring programs, so that owners can readily put their lands
22 into production; now, therefore,
23

24 BE IT RESOLVED by the Senate of the Thirty-third
25 Legislature of the State of Hawaii, Regular Session of 2025, the
26 House of Representatives concurring, that the counties are urged
27 to adopt local zoning ordinances to require owners of
28 agricultural-zoned lands to execute and record declarations that
29 acknowledge state and county agricultural land use regulations
30 and requirements and the penalties for noncompliance; and

32 BE IT FURTHER RESOLVED that the counties are encouraged to
33 promote the active use of agricultural lands by making
34 information available on farm apprenticeship and mentoring
35 programs to owners of agricultural lands; and

37 BE IT FURTHER RESOLVED that certified copies of this
38 Concurrent Resolution be transmitted to the Chairperson of the
39 Board of Agriculture, Director of the Office of Planning and
40 Sustainable Development, Mayor of the County of Hawaii, Mayor of
41 the City and County of Honolulu, Mayor of the County of Kauai,
42 Mayor of the County of Maui, Planning Director of the County of



1 Hawaii, Director of Planning and Permitting for the City and
2 County of Honolulu, Planning Director of the County of Kauai,
3 Planning Director of the County of Maui, President of the Hawaii
4 Farm Bureau, and President and Chief Executive Officer of the
5 Hawaii Farmers Union.
