SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF HEALTH TO CONVENE A WORKING GROUP
TO ASSESS THE FEASIBILITY OF ALLOWING BUSINESS OWNERS IN
THE STATE TO UTILIZE FILTERED WATER COLLECTED BY WATER
CATCHMENT SYSTEMS FOR BUSINESS ACTIVITIES.

1 WHEREAS, there is an imminent potable water shortage threat
2 that has left many individuals across the State without direct
3 or convenient access to safe drinking water; and
4

5 WHEREAS, due to recent high-profile petroleum leaks coupled
6 with drought conditions, the Board of Water Supply of the City
7 and County of Honolulu was forced to take precautionary measures
8 and shut down the Hālawā Shaft, Hālawā Wells, and Aiea Wells,
9 further restricting access to potable water for local
10 communities; and
11

12 WHEREAS, access to water is a prerequisite to addressing
13 many of the State's current problems relating to developing
14 affordable housing, empowering local businesses, diversifying
15 the economy, and improving the economic stability of the State's
16 most vulnerable residents; and
17

18 WHEREAS, pursuing innovative solutions to decrease use of
19 the State's limited aquifers is critical to addressing the
20 fragility of the State's water system; and
21

22 WHEREAS, water catchment systems are one innovative
23 solution that can supplement potable water systems and conserve
24 natural resources by efficiently capturing and utilizing
25 rainwater while maintaining existing state water infrastructure,
26 including both municipal water and stormwater systems; and
27

28 WHEREAS, while a significant number of people in the State
29 are dependent on rainwater catchment as their primary domestic
30 water source, existing law allows captured water for personal



1 use only and prohibits the use of captured water for business
2 activities; and
3

4 WHEREAS, revised guidelines from the College of Tropical
5 Agriculture and Human Resiliency at the University of Hawai'i at
6 Manoa outline a safe process for utilizing water captured for
7 personal use that can be appropriately applied to business
8 activities under certain regulatory conditions; and
9

10 WHEREAS, studying the feasibility of allowing business
11 owners in the State to utilize filtered water collected by water
12 catchment systems for business activities is critical to
13 decrease Hawaii's dependency upon stressed aquifer and water
14 systems and assist in the diversification of the State's water
15 sources; now, therefore,
16

17 BE IT RESOLVED by the Senate of the Thirty-third
18 Legislature of the State of Hawaii, Regular Session of 2025, the
19 House of Representatives concurring, that the Department of
20 Health is requested to convene a Business Activity Water
21 Catchment System Working Group for business activities; and
22

23 BE IT FURTHER RESOLVED that the working group is requested
24 to consist of the following members:
25

- 26 (1) One member of the Senate, appointed by the President
27 of the Senate, who is requested to serve as co-chair
28 of the working group;
29
- 30 (2) One member of the House of Representatives, appointed
31 by the Speaker of the House of Representatives, who is
32 requested to serve as co-chair of the working group;
33
- 34 (3) Director of Health, or the Director's designee;
35
- 36 (4) One representative from each county's board or
37 department of water supply or department of water;

- 39 (5) One member representing the public, appointed or
40 invited by the President of the Senate; and

- 1 (6) One member representing the public, appointed or
2 invited by the Speaker of the House of
3 Representatives; and
4

5 BE IT FURTHER RESOLVED that the working group is requested
6 to assess and make recommendations on:
7

- 8 (1) The feasibility of allowing business owners in the
9 State to utilize filtered water collected by water
10 catchment systems for business activities, including
11 the types and sizes of businesses that are best suited
12 to implement water catchment systems for business
13 activities;
14

- 15 (2) The feasibility of establishing a Business Activity
16 Water Catchment System Testing Program within the
17 Department of Health that provides or otherwise
18 assists business owners in conducting annual testing
19 of filtered water produced from a water catchment
20 system for business activities, including determining
21 the types of chemicals or substances, in addition to
22 lead and copper, that need to be tested to ensure the
23 safety of the filtered water for business activities;
24

- 25 (3) How the State and counties can cooperate in ensuring
26 that water catchment systems utilized for business
27 activities are in compliance with applicable plumbing
28 codes; and
29

- 30 (4) Possible means by which the State can assist business
31 owners in safely utilizing filtered water from a water
32 catchment system for business activities; and
33

34 BE IT FURTHER RESOLVED that the Business Activity Water
35 Catchment System Working Group is requested to report its
36 findings and recommendations, including any proposed
37 legislation, to the Legislature no later than twenty days prior
38 to the convening of the regular session of 2027; and
39

40 BE IT FURTHER RESOLVED that the Business Activity Water
41 Catchment System Working Group is requested to dissolve on
42 June 30, 2027; and

2 BE IT FURTHER RESOLVED that certified copies of this
3 Concurrent Resolution be transmitted to the Director of Health,
4 President of the Senate, Speaker of the House of
5 Representatives, Mayors of each county, Manager and Chief
6 Engineer of the Board of Water Supply of the City and County of
7 Honolulu, Director of the Department of Water Supply of the
8 County of Maui, Manager-Chief Engineer of the Department of
9 Water Supply of the County of Hawaii, and Manager and Chief
10 Engineer of the Department of Water of the County of Kauai.
