## SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION TO PROVIDE A DETAILED REPORT TO THE LEGISLATURE ON THE TRUE COST OF PRODUCING SCHOOL MEALS TO ENSURE TRANSPARENCY AND AVOID UNNECESSARY PRICE INCREASES.

WHEREAS, the Department of Education is responsible for ensuring that students have access to nutritious and affordable meals; and

WHEREAS, the State receives federal reimbursement for school meals through participation in the School Breakfast Program, National School Lunch Program, and other school meal reimbursement programs; and

WHEREAS, the Department of Education has proposed an increase in school meal prices, which would lead to an increase in the price of student lunch from \$2.50 to \$4.75 for grades K-8 and from \$2.75 to \$5.00 for grades 9-12 by the 2028-2029 school year; and

WHEREAS, the Department of Education cites the current cost of producing a student lunch at \$9.00; and

WHEREAS, section 302A-405, Hawaii Revised Statutes, requires the Department of Education to ensure that monies received from the sale of school meals are at least one-half the cost of preparing the meals; and

WHEREAS, there is currently no reporting system in the Department of Education's budgeting process to provide itemized cost breakdowns for school meals; and

WHEREAS, increasing prices for school meals negatively impacts Hawaii's working families and students that receive free or reduced-price meals; and
