SENATE CONCURRENT RESOLUTION

REQUESTING THE OFFICE OF THE AUDITOR TO CONDUCT A FINANCIAL AND PERFORMANCE AUDIT OF THE UNIVERSITY OF HAWAII AT MANOA ATHLETICS DEPARTMENT.

WHEREAS, the University of Hawaii at Manoa Athletics 1 Department is responsible for the operations of various student 2 sports teams, their training and performance, travel as 3 4 necessary, and for providing educational and mental health support for their athletes; and 5 6 7 WHEREAS, the Athletics Department includes student athletes as well as department support staff to coordinate domestic and 8 national events, manage operations, and provide assistance to 9 10 student athletes; and 11 WHEREAS, the Athletics Department receives funding through 12 private donors, the university, legislative appropriations, and 13 various sport-specific distributions for the purpose of 14 supporting department operations and programs; and 15 16 WHEREAS, the effective use and management of funds and 17 resources to promote increased interest and participation in 18 collegiate sports should be a priority of the department; and 19 20 WHEREAS, ensuring that existing support programs are 21 effective in encouraging student athletes' continued improvement 22 and success in both the educational and athletic sectors should 23 also be a priority of the department; and 24 25 WHEREAS, the University of Hawaii at Manoa Athletics 26 Department does not have a master plan to address the various 27 needs of the Athletics Department; and 28 29 WHEREAS, the University of Hawaii does not have a clear 30 plan to address the potential of, nor implement, the Name, 31 Image, and Likeness program for the purpose of department and 32

athlete exposure, as well as development of a new source of 1 2 revenue; and 3 WHEREAS, an audit conducted in Fiscal Year 2024 shows a 4 \$2,100,000 deficit between revenues and expenditures for the 5 University of Hawaii at Manoa Athletics Department; and 6 7 WHEREAS, the University of Hawaii at Manoa Athletics 8 Department does not have a sustainable funding plan to address 9 the deficit nor the overall needs of the department; and 10 11 WHEREAS, evaluation of the department's operations, program 12 offerings, and effectiveness is necessary for the improvement 13 and efficiency of the department as a whole; now, therefore, 14 15 BE IT RESOLVED by the Senate of the Thirty-third 16 Legislature of the State of Hawaii, Regular Session of 2025, the 17 House of Representatives concurring, that the Office of the 18 Auditor is requested to conduct a financial and performance 19 audit of the University of Hawaii at Manoa Athletics Department 20 to ensure that the department is operating in an effective, 21 fiscally responsible, and comprehensively supportive manner for 22 the success of the program and its student athletes; and 23 24 BE IT FURTHER RESOLVED that certified copies of this 25 Concurrent Resolution be transmitted to the Auditor and Director 26 of Athletics of the University of Hawaii at Manoa. 27 28 OFFERED BY: DIN LINE 29 30
