## SENATE CONCURRENT RESOLUTION

REQUESTING THE COMPTROLLER TO COOPERATE WITH THE HAWAII STATE PUBLIC LIBRARY SYSTEM, OFFICE OF PLANNING AND SUSTAINABLE DEVELOPMENT, AND HAWAII BROADBAND AND DIGITAL EQUITY OFFICE TO IDENTIFY RURAL AND UNDERSERVED COMMUNITIES IN THE STATE WITH A NEED FOR BETTER TELECOMMUNICATION ACCESS FOR RESIDENTS TO PARTICIPATE IN THE STATE LEGISLATIVE PROCESS.

WHEREAS, providing access for residents to participate in 1 2 the state legislative process is a basic right of citizenship in the State and should continue to be a priority; and 3 4 5 WHEREAS, ensuring equitable access to the state legislative process for nearly four hundred fifty thousand residents on the 6 7 neighbor islands, as well as those in rural O'ahu, is essential 8 to strengthening civic engagement, enhancing the effectiveness 9 of the legislative process, and ensuring fair and accurate representation on issues impacting the entire State; and 10 11 WHEREAS, with the rising costs of airfare, gas, and 12 lodging, providing designated locations or state offices on 13 14 neighbor islands and in rural O'ahu where citizens can participate remotely in the state legislative process will help 15 reduce the financial burden of participation and further boost 16 17 civic engagement; and 18 19 WHEREAS, the Hawaii State Public Library System has long provided free public access to broadband internet and computer 20 equipment and is therefore well-prepared to serve as a conduit 21 for facilitating remote legislative participation; and 22 23 WHEREAS, with a network of fifty-one libraries across the 24 25 State, all of which have broadband capabilities and various 26 electronic devices, including Chromebooks, the Hawaii State 27 Public Library System has the infrastructure and resources to

1 support public access to the Internet and videoconferencing, making it uniquely well-suited to assist individuals in 2 participating in the state legislative process; now, therefore, 3 4 5 BE IT RESOLVED by the Senate of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, the 6 7 House of Representatives concurring, that the Comptroller is 8 requested to cooperate with the Hawaii State Public Library 9 System, Office of Planning and Sustainable Development, and 10 Hawaii Broadband and Digital Equity Office to identify rural and underserved communities with a need for better telecommunication 11 12 access for residents, including those with developmental 13 disabilities, to participate in the state legislative process; 14 and 15 16 BE IT FURTHER RESOLVED that the Comptroller is requested to

17 submit to the Legislature a report of its findings and 18 recommendations, including any proposed legislation, no later 19 than twenty days prior to the convening of the Regular Session 20 of 2026; and

BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Comptroller, State Librarian, Director of the Office of Planning and Sustainable Development, Strategic Broadband Coordinator of the Hawaii Broadband and Digital Equity Office, and Executive Director of the Disability and Communication Access Board.
