## SENATE CONCURRENT RESOLUTION

URGING THE STADIUM AUTHORITY TO FINALIZE A CONTRACT FOR THE CONSTRUCTION OF THE NEW ALOHA STADIUM AND TO CONTINUE ITS EFFORTS IN EARNEST TO CREATE THE NEW ALOHA STADIUM ENTERTAINMENT DISTRICT.

WHEREAS, in 2019, the Legislature found that the Aloha Stadium and lands under the jurisdiction of the Stadium Authority and Department of Accounting and General Services have been underutilized, and that the stadium facility has been in dire need of significant repair and maintenance for many years; and

WHEREAS, the Legislature further found that redeveloping, 8 renovating, or improving these public lands in a manner that 9 will provide suitable recreational, residential, educational, 10 and commercial areas, where the public can live, congregate, 11 12 recreate, attend schools, and shop, as part of a thoughtfully integrated experience, is in the best interests of the State and 13 its people and, accordingly, established the Stadium Development 14 District pursuant to Act 268 (2019) to make optimal use of 15 public land for the economic, residential, educational, and 16 social benefit of the people of Hawaii; and 17 18

19 WHEREAS, since 2019, the Stadium Authority has been 20 overseeing the development of a masterplan of the Stadium 21 Development District, including a new stadium facility, that 22 focuses on reducing negative impacts on surrounding 23 neighborhoods while offering amenities that benefit the broader 24 community; and

26 WHEREAS, the location of a new stadium facility was 27 carefully selected and strategically located in Halawa for its 28 proximity to transportation infrastructure, including highways 29 and the Honolulu rail system, ensuring accessibility and 30 minimizing traffic disruptions; and

WHEREAS, the Stadium Authority finalized the environmental 1 2 impact statement for the New Aloha Stadium Entertainment District (NASED) Project in September 2022; and 3 4 5 WHEREAS, the NASED Project consists of the demolition of the existing Aloha Stadium; design and construction of a new 6 multi-use stadium facility with a variety of amenities and a 7 minimum of twenty-five thousand seats; and mixed-use development 8 of some or all of the surrounding areas within the district, 9 such as housing, retail, hotel, and public spaces, creating a 10 vibrant community hub for both everyday use and major events; 11 12 and 13 14 WHEREAS, the NASED Project will provide community and recreational benefits by offering modern sports and 15 entertainment facilities, enhancing the quality of life for 16 residents and visitors; and 17 18 WHEREAS, the smart urban design of the NASED Project aligns 19 20 with United Nations' Sustainable Development Goals, with considerations for environmental impact and energy-efficient 21 22 designs; and 23 24 WHEREAS, the construction and ongoing operation of a new state-of-the-art stadium facility and mixed-use entertainment 25 district will also create numerous jobs, including construction, 26 hospitality, and retail positions, furthering economic growth 27 and development; and 28 29 30 WHEREAS, the new stadium facility is crucial for supporting the University of Hawaii's football program and other athletic 31 events, which rely on modern facilities for competitive and 32 financial viability; and 33 34 WHEREAS, the new stadium facility and entertainment 35 district is also expected to attract large-scale events such as 36 concerts, sporting events, and festivals, which will boost 37 tourism and generate significant income for local businesses; 38 39 and 40 41 WHEREAS, the new stadium facility positions Hawaii to attract national and international sporting events, and will 42

create opportunities to host marguee events like college 1 football championships, soccer matches, and cultural 2 celebrations, which can boost Hawaii's reputation as a global 3 destination and diversify the State's economy beyond traditional 4 tourism; and 5 6 7 WHEREAS, the procurement method of the NASED Project leverages private investment to reduce the financial burden on 8 the State while ensuring professional development and 9 management, and its mixed-use development model will generate 10 additional revenue beyond ticket sales from retail, dining, and 11 housing, making the development of the Stadium Development 12 District more financially sustainable; and 13 14 WHEREAS, the NASED Project is in its final stages of 15 planning and procurement, having already selected Aloha Halawa 16 17 District Partners as a preferred developer, and the Halawa site has already undergone extensive environmental and planning 18 review and completed an environmental impact study, streamlining 19 the process and ensuring readiness for construction; and 20 21 WHEREAS, the timely procurement and successful delivery of 22 23 the NASED Project is critical to avoid delays and to leverage the years of work and investment to support Hawaii's economic 24 25 future, sports culture, and community development; now, therefore, 26 27 BE IT RESOLVED by the Senate of the Thirty-third 28 29 Legislature of the State of Hawaii, Regular Session of 2025, the House of Representatives concurring, that the Stadium Authority 30 31 is urged to finalize a contract for the construction of the new Aloha Stadium and to continue its efforts in earnest to create 32 33 the New Aloha Stadium Entertainment District; and 34 35 BE IT FURTHER RESOLVED that a certified copy of this Concurrent Resolution be transmitted to the Chairperson of the 36 37 Stadium Authority. 38 39 40 OFFERED BY:
