SENATE CONCURRENT RESOLUTION

AUTHORIZING THE ISSUANCE OF A PERPETUAL, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT WAIALAE, HONOLULU, OAHU, FOR THE EXISTING DRAINAGE OUTLETS, AND FOR THE USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON.

1 WHEREAS, when the Kahala Hotel and Resort was developed, 2 three drainage outlets were also installed from the hotel 3 property, identified as Tax Map Key: (1) 3-5-023: 039, and 4 beneath a parcel owned by the State, identified as Tax Map Key: 5 (1) 3-5-023: 41, which lies between the hotel property and the 6 beach area and ocean; and

8 WHEREAS, the construction of the Kahala Hotel and Resort 9 pre-existed the Conservation District and Special Management 10 Area laws that require authorization from the Legislature by 11 Concurrent Resolution and the approval of the Governor for the 12 lease of state submerged lands; and

14 WHEREAS, over the years, the Kahala Hotel and Resort made 15 improvements to the existing structures and obtained the 16 required conservation use district permits for the drainage 17 outlets; however, the Board of Land and Natural Resources did 18 not grant any easements to Kahala Hotel and Resort for the 19 drainage outlets; and

21 WHEREAS, Resorttrust Hawaii, LLC, purchased the Kahala 22 Hotel and Resort in 2018, and has been working diligently with 23 the Department of Land and Natural Resources to determine the 24 easement areas; and

WHEREAS, on September 27, 2024, under agenda item D-7, the Board of Land and Natural Resources approved a grant of a perpetual, non-exclusive easement for drainage purposes; and

1	WHEREAS, the total easement area was determined to be
2	12,700 square feet subject to review and approval by the Survey
3	Division of the Department of Accounting and General Notes; and

5	WHEREAS, before the execution of the non-exclusive
6	easement, the grantee shall pay the State the fair market value
7	of the non-exclusive easement as consideration for the use of
8	state submerged lands to be determined by independent appraisal,
9	subject to approval by the Chairperson of the Board of Land and
10	Natural Resources; and
11	
12	WHEREAS, section 171-53, Hawaii Revised Statutes, requires
13	the prior approval of the Governor and prior authorization of
14	the Legislature by Concurrent Resolution to lease state
15	submerged lands; now, therefore,
16	
17	BE IT RESOLVED by the Senate of the Thirty-third
18	Legislature of the State of Hawaii, Regular Session of 2025, the
19	House of Representatives concurring, that the Board of Land and
20	Natural Resources is hereby authorized to issue a perpetual,
21	non-exclusive easement covering portions of and seaward of state
22	submerged lands identified as Tax Map Key: (1) 3-5-023: 041,
23	Waialae, Honolulu, Oahu, for the existing drainage outlets, and
24	for the use, repair, and maintenance of the existing
25	improvements constructed thereon pursuant to section 171-53,
26	Hawaii Revised Statutes; and

28	BE IT FURTHER RESOLVED that a certified copy of this
29	Concurrent Resolution be transmitted to the Chairperson of the
30	Board of Land and Natural Resources.
