#### SENATE RESOLUTION

REQUESTING THE OFFICE OF HAWAIIAN AFFAIRS TO CONVENE A WORKING GROUP TO EXAMINE AND CONSIDER THE TRANSFER OF NATIVE HAWAIIAN BURIAL SITE MANAGEMENT UNDER CHAPTER 6E, HAWAII REVISED STATUTES, FROM THE STATE HISTORIC PRESERVATION DIVISION TO THE OFFICE OF HAWAIIAN AFFAIRS.

WHEREAS, the Legislature recognizes that it is the State's
duty to protect the Native Hawaiian cultural and religious
practice of caring for iwi kūpuna pursuant to article XII,
section 7, of the Hawaii State Constitution; and

WHEREAS, in enacting Act 104, Session Laws of Hawaii 1976, 6 7 which established chapter 6E, Hawaii Revised Statutes, to codify the State's Historic Preservation program, the Legislature 8 9 recognized and declared that historic properties and burial sites are included in the State's public trust, stating that "it 10 shall be the public policy of this State to provide leadership 11 12 in preserving, restoring, and maintaining historic and cultural property, to ensure the administration of such historic and 13 cultural property in a spirit of stewardship and trusteeship for 14 future generations, and to conduct activities, plans, and 15 programs in a manner consistent with the preservation and 16 enhancement of historic and cultural property"; and 17

WHEREAS, in 1990, the Legislature amended section 6E-43, Hawaii Revised Statutes, to include language stating that "at any site, other than a known, maintained, actively used cemetery where human skeletal remains are discovered or are known to be buried and appear to be over fifty years old, the remains and their associated burial goods shall not be moved without the department's approval"; and

WHEREAS, the amendments made to section 6E-43 also included language stating that "all burial sites are significant and shall be preserved in place until compliance with this section is met"; and

WHEREAS, chapter 10H, Hawaii Revised Statutes, formally
recognizes Native Hawaiians as the "only indigenous, aboriginal,

maoli people of Hawaii" and facilitates and furthers Native 1 2 Hawaiian self-governance; and 3 WHEREAS, the United Nations Declaration on the Rights of 4 5 Indigenous Peoples states that "[i]ndigenous peoples have the right to self-determination", the "right to maintain, protect, 6 7 and have access...to their religious and cultural sites", and "repatriation of their human remains"; and 8 9 WHEREAS, the State and Legislature recognize that the 10 Office of Hawaiian Affairs was constitutionally established as a 11 12 trust vehicle to act on behalf of Native Hawaiians until a Native Hawaiian governing entity could be reestablished; and 13 14 15 WHEREAS, the State Historic Preservation Division of the 16 Department of Land and Natural Resources was established to administer a comprehensive historic preservation program 17 pursuant to chapter 6E, Hawaii Revised Statutes; and 18 19 20 WHEREAS, the State Historic Preservation Division is tasked with the identification and protection of historic burial sites, 21 and, with respect to Native Hawaiian burial sites, is tasked 22 with sharing decision-making over relocation or preservation in 23 place, transfer, or other disposition of previously identified 24 Native Hawaiian burial sites, with the State's island burial 25 councils that were established pursuant to section 6E-43.5, 26 Hawaii Revised Statutes; and 27 28 WHEREAS, pursuant to H.R. No. 113, HD1 (2021), and S.R. 29 No. 171, SD1 (2021), the Office of Hawaiian Affairs convened a 30 31 Burial Sites Working Group in 2022 to investigate the matter of burial site treatment and to offer recommendations for 32 improvements; and 33 34 WHEREAS, the Burial Site Working Group took extensive 35 community testimony as part of its fact-finding mandate and in 36 its final report dated February 2023, made three key findings: 37 38 The State had failed to adequately manage its burial 39 (1)law responsibilities, including a failure to provide, 40 or advocate for the provision of, adequate resources 41 to administer burial laws and a failure to adequately 42

administer laws intended to protect Native Hawaiian burial sites;

(2) The State has demonstrated a lack of will to fulfill its burial law responsibilities; and

(3) There are fundamental inadequacies in the laws affecting burial sites; and

10 WHEREAS, an opinion editorial entitled "Place the Kuleana with OHA", authored by Dr. Kehaulani Abad and Edward Halealoha 11 Ayau, a burial site expert and one of three authors of the 1990 12 amendments made to chapter 6E, Hawaii Revised Statutes, that 13 established the island burial councils, was published in the 14 June 1 issue of Ka Wai Ola and opined that the most effective 15 manner by which to improve the care and protection of unmarked 16 burial sites over fifty years old and the Hawaiian human remains 17 inadvertently discovered is to transfer the burial site program 18 from the State Historic Preservation Division to the Office of 19 20 Hawaiian Affairs; and

WHEREAS, section 10-3(3), Hawaii Revised Statutes, requires that the Office of Hawaiian Affairs serve as "the principal public agency in this State responsible for the performance, development, and coordination of programs and activities relating to native Hawaiians and Hawaiians"; and

WHEREAS, section 10-3(4), Hawaii Revised Statutes, requires that the Office of Hawaiian Affairs advance the betterment of Native Hawaiians by assessing the effects of policies and practices of other state agencies on Native Hawaiians; and 32

33 WHEREAS, the State Historic Preservation Division and 34 Office of Hawaiian Affairs have identified several reoccurring 35 challenges regarding both the Burial Sites Program and the 36 Island Burial Councils; and

38 WHEREAS, occasionally, the State Historic Preservation
39 Division faces potential conflicts of interest, or the
40 appearance of conflicts of interest, resulting from historic
41 preservation reviews, inadvertent discoveries, descendancy

claims, and making recommendations to the Island Burial 1 2 Councils; and 3 WHEREAS, these potential conflicts of interest may be 4 5 resolved by transferring parts of the Burial Sites Program to another agency; now, therefore, 6 7 8 BE IT RESOLVED by the Senate of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, 9 that the Office of Hawaiian Affairs is requested to convene a 10 working group to examine and consider the transfer of Native 11 Hawaiian burial site management under chapter 6E, Hawaii Revised 12 13 Statutes, from the State Historic Preservation Division to the Office of Hawaiian Affairs; and 14 15 16 BE IT FURTHER RESOLVED that the working group is requested 17 to: 18 19 (1) Identify and determine which duties and responsibilities of the State Historic Preservation 20 21 Division regarding the protection of Native Hawaiian burial sites and administration of the Island Burial 22 Councils under chapter 6E, Hawaii Revised Statutes, 23 may be shared with or assumed by the Office of 24 Hawaiian Affairs; 25 26 Consider the staff and financial resources of the 27 (2) Office of Hawaiian Affairs, legal requirements, 28 technological needs, and other relevant factors, in 29 determining whether it is feasible for the Office of 30 Hawaiian Affairs to assume these duties and 31 32 responsibilities; 33 (3) Develop and recommend an implementation plan and 34 associated timeline for the transfer of any duties, 35 including any necessary statutory and administrative 36 amendments to effectuate the transfer; 37 38 Consider in its discussions whether implementing the (4) 39 recommendations made in the final report of the Burial 40 Sites Working Group may improve the operation of the 41
