SENATE RESOLUTION

URGING THE MED-QUEST DIVISION OF THE DEPARTMENT OF HUMAN SERVICES AND DEVELOPMENTAL DISABILITIES DIVISION OF THE DEPARTMENT OF HEALTH TO AMEND THE ELIGIBILITY CRITERIA FOR THE MEDICAID 1915(C) HOME AND COMMUNITY-BASED SERVICES WAIVER.

WHEREAS, individuals with intellectual and developmental disabilities who are eligible for services from the Developmental Disabilities Division of the Department of Health, are eligible for Medicaid, and who meet the level of care criteria, can apply for the Medicaid 1915(c) Home and Community-Based Services Waiver; and

8 WHEREAS, the Med-QUEST Division of the Department of Human 9 Services works in partnership with the Developmental 10 Disabilities Division of the Department of Health to design a 11 waiver for Hawaii residents with intellectual and developmental 12 disabilities that is compliant with all waiver requirements, 13 federal and state laws, and waiver standards; and 14

WHEREAS, under the current administrative rules, 15 individuals are deemed ineligible for the Medicaid 1915(c) Home 16 and Community-Based Services Waiver if the individual's 17 impairments are due to any of several specified conditions, 18 including dementia, mental illness, emotional disorders, 19 substance abuse, sensory impairment, learning disabilities, 20 attention deficit hyperactivity disorder, spinal cord injuries, 21 22 or neuromuscular disorders; now, therefore,

BE IT RESOLVED by the Senate of the Thirty-third 24 Legislature of the State of Hawaii, Regular Session of 2025, 25 that the Med-QUEST Division of the Department of Human Services 26 and the Developmental Disabilities Division of the Department of 27 Health are urged to amend its eligibility criteria for the 28 Medicaid 1915(c) Home and Community-Based Services Waiver to 29 include individuals with an intellectual or a developmental 30 disability and a comorbid mental illness; and 31 32
