## SENATE RESOLUTION

REQUESTING THE OFFICE OF WELLNESS AND RESILIENCE TO DEVELOP A REPORT TO ADDRESS THE DEVELOPMENTAL NEEDS OF CHILDREN BORN DURING THE CORONAVIRUS DISEASE 2019 PANDEMIC.

WHEREAS, the coronavirus disease 2019 (COVID-19) pandemic 1 has had profound effects on children born between the years 2 2018-2025, disrupting their social, emotional, academic, and 3 health development during their most critical early years; and 4 5 WHEREAS, scientific evidence and expert testimonies 6 7 indicate that many children in this age group are experiencing developmental delays, including challenges in communication, 8 fine motor skills, emotional regulation, and social interaction; 9 10 and 11 12 WHEREAS, early childhood education and support during these formative years are crucial for long-term academic success and 13 overall well-being, yet these children may face compounded 14 challenges as they transition into middle and high school; and 15 16 WHEREAS, children who were born and raised during the 17 COVID-19 pandemic, especially those from birth to age five, are 18 at heightened risk for academic and developmental setbacks due 19 to the unique circumstances of their upbringing, including 20 reduced social interactions, increased screen time, and 21 22 disrupted routines; and 23 24 WHEREAS, families across the State endured significant challenges during the COVID-19 pandemic, including heightened 25 fear of contracting the virus, economic instability due to 26 inflation and loss of income, and increased food and housing 27 insecurity; and 28 29 WHEREAS, caregivers have faced the additional burden of 30 31 adapting to online education for their children while managing 32 toxic stress within households, which has adversely affected the

social and emotional well-being of children from birth to age 1 five, a critical period for early childhood development; and 2 3 WHEREAS, climate crisis, such as the 2018 Kilauea eruption 4 5 and 2023 Maui wildfires, have further compounded the trauma for 6 children in affected areas, leading to additional challenges in emotional and psychological well-being, especially for those who 7 8 were already vulnerable due to the COVID-19 pandemic; and 9 10 WHEREAS, trauma can have profound negative impacts on students' social, emotional, and behavioral needs; and 11 12 13 WHEREAS, disparities in developmental outcomes have been 14 observed, disproportionately affecting children from 15 economically disadvantaged, minority, rural, and remote communities, including Native Hawaiian communities; and 16 17 18 WHEREAS, recovery and catch-up interventions for these 19 children are essential to mitigate long-term impacts on their 20 educational and life trajectories; and 21 22 WHEREAS, educators and others who work with children have 23 also been profoundly impacted by the stressors of the COVID-19 24 pandemic, facing increased demands, and limited resources, as well as their own experiences of toxic stress, leading to a 25 record number of educators leaving the profession and fewer 26 individuals entering the field; and 27 28 WHEREAS, the cascading effects of trauma within families, 29 30 schools, and communities have placed a significant strain on community-based providers responsible for the care and 31 32 development of children, further challenging their ability to support the social-emotional needs of children and families; 33 34 now, therefore, 35 36 BE IT RESOLVED by the Senate of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, 37 38 that the Office of Wellness and Resilience is requested to develop a report to address the developmental needs of children 39 40 born during the coronavirus disease 2019 (COVID-19) pandemic; 41 and 42

BE IT FURTHER RESOLVED that the Office of Wellness and 1 Resilience is requested to include the following in its report: 2 3 (1)4 Trauma-informed care research and practices that: 5 (A) Identify the nature of trauma and the effects of 6 acute or chronic exposure to trauma; 7 8 9 Present interventions and strategies to resist (B) 10 re-traumatization for those impacted by trauma; and 11 12 13 (C) Recommend cultural practices and research-14 practiced, evidence-based interventions to support children's transitions into middle 15 school, high school, and post-high school life; 16 17 18 (2) An outline of the existing services offered by the Department of Education, Department of Health, 19 20 Department of Human Services, Office of Hawaiian Affairs, Executive Office on Early Learning, and key 21 22 non-profits and community groups to address social and 23 emotional learning loss experienced during the COVID-19 pandemic; 24 25 26 (3) A comprehensive analysis of the services available for individuals and families affected by the 2023 Maui 27 28 wildfires; 29 (4)Information on existing services to support educators 30 and those who work directly with children and families 31 who may suffer from secondary traumatic stress due to 32 the COVID-19 pandemic and 2023 Maui wildfires; and 33 34 (5) 35 Recommendations to strengthen efforts to support frontline workers' self-care plans and provide 36 interventions to promote resiliency and well-being; 37 38 and 39 BE IT FURTHER RESOLVED that the Office of Wellness and 40 Resilience is requested to submit its report, including any 41
