SENATE RESOLUTION

URGING THE DIRECTOR OF HEALTH TO ESTABLISH A WORKING GROUP ON HEALTH INSURANCE REFORM TO PROVIDE RECOMMENDATIONS FOR REDUCING THE IMPACT OF PRIOR AUTHORIZATION REQUIREMENTS ON THE TIMELY DELIVERY OF HEALTHCARE IN THE STATE.

WHEREAS, although health insurance providers' prior 1 authorization requirements are intended to ensure that medical 2 services are necessary, cost-effective, and eligible for 3 coverage, these requirements can cause critical medical 4 treatments and tests to be delayed; and 5 6 7 WHEREAS, the misapplication of prior authorization requirements can be especially harmful for rural and medically 8 underserved patients, who already face significant barriers to 9 10 accessing care; and 11 WHEREAS, the requirements can also create undue 12 administrative burdens for healthcare providers, including 13 providers in medically underserved areas; and 14 15 WHEREAS, the Centers for Medicare and Medicaid Services 16 have mandated changes to prior authorization rules that will 17 help reduce the burdens of prior authorization on certain 18 patients and physicians; and 19 20 WHEREAS, whereas these changes do not benefit private 21 payers in the State, who still require prior authorization for 22 23 many common services; and 24 25 WHEREAS, recommendations are needed to reduce the impact of prior authorization requirements on the delivery of healthcare 26 to all patients in the State; now, therefore, 27 28 29 BE IT RESOLVED by the Senate of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, 30 that the Director of Health is urged to establish a working 31 group on health insurance reform to provide recommendations for 32 reducing the impact of prior authorization requirements on the 33 timely delivery of healthcare in the State; and 34
