

Founded in 2009, the Hawaii Softball Foundation (HSF) is a Hawaii based 501 (c) (3) nonprofit organization dedicated to supporting the development of softball activities in the State of Hawaii. HSF does this by:

- Organizing, encouraging, and educating student-athletes, families, coaches, teams and organizations.
- Promoting all phases of amateur softball including youth, women, men, coed and seniors;

- Assisting Hawaii communities in developing softball programs and facilities through clinics and seminars.
- Assisting Hawaii communities in building and maintaining facilities for the safety and welfare of all participants; and
- Awarding academic and athletic based scholarships to deserving student-athletes.

Since 2021, HSF has served as the sole steward and lessee of a 10-acre six field softball complex located within the Sand Island Recreation Area under a 10-year lease agreement with the Department of Land and Natural Resources, State of Hawaii. Under the agreement, HSF provides general management and maintenance of the softball complex and immediate surrounding areas.

2. The goals and objectives related to the request;

Since 2021, HSF has served as the sole steward and lessee of a 10-acre six field softball complex located within the Sand Island Recreation Area under a 10-year lease agreement with the Department of Land and Natural Resources, State of Hawaii. Under the agreement, HSF provides general management and maintenance of the softball complex and immediate surrounding areas. Through this grant request, HSF is requesting funding from the State of Hawaii, through its Grant-in-aid program to:

- Provide ground covering for seating area behind the backstops for the safety of the participants and spectators and also be ADA compliance.
- Provide energy generation, 100% renewable energy such as a solar system and battery storage packs.
- LED Safety lights for common areas, part of our sustainable infrastructure.
- Scoreboards, including games clocks and pitch clocks.
- Mobile signs for our parking lots to provide safety precautions for our parking lots.
- Portable flushing restrooms
- Maintenance yard canopy cover and electrical system
- Upgrade press-boxes with rolling windows, video and audio systems.
- Maintenance vehicles such as an 8-passenger transport cart and a flatbed maintenance cart.
- Maintenance supplies to ensure the fields are playable, safe and cared for.

As relates to this request, HSF's organizational goals and objectives for the Sand Island Softball Complex include:

Goal 1 - Ensuring that all fields and surrounding areas are maintained properly for the safety of the softball participants and the community.

Goal 2 - Managing the facilities to ensure that all organizations and community groups are unbiasedly considered for the use of the softball complex.

Goal 3 - To promote all phases of amateur softball including youth, high school, college and senior programs by conducting sanctioned games, clinics, and seminars at the softball complex.

3. The public purpose and need to be served;

Over the past decade, college softball has grown faster in revenue and viewership than other college sports. Simultaneously, the State of Hawaii produced some of the top NCAA softball All Americans. The Hawaii Softball Foundation aims to create more opportunities and pathways for Hawaii female student athletes to college and beyond.

Once fully completed, the 10 acre, six field Sand Island Softball Complex will serve as a venue for teams across the State, from 8 under to college student-athletes to compete and train under regulation size fields and offer them batting cages, bull pens and public restrooms, as well as open areas for families to watch sanctioned games and enjoy the outdoors near the beach.

4. Describe the target population to be served; and

In 2025 Hawaii Softball Foundation provided opportunities to over 2,000 youth softball players through quality sports training and competition through several entities. HSF works collaboratively with entities such as Hawaii Special Olympics, providing them with training opportunities for their volunteers and fields and other venues where they are able to conduct practices and competition.

According to USA Softball of Hawaii, a nationally affiliated governing body, registered softball players come from all over the State. HSF is an ailed member of USA Softball and works in collaboration with the State of Department of Education, assisting community schools that do not have any softball facilities for their teams. HSF also works in collaboration with the Interscholastic League of Honolulu and provides practice and game venues for Maryknoll High School, Punahou School and other private schools. HSF also works in collaboration with United Softball in conducting their practices and games.

5. Describe the geographic coverage.

The 10-acre Sand Island Softball Complex is easily accessible to all communities across Oahu. Located a short 4.3-mile drive from Daniel K. Inouye International Airport (HNL), the Sand Island Softball Complex is ideally located to host state-wide and potentially national and international sanctioned events. As the gateway to the Pacific, HNL airport serves as a hub for international softball

teams as they travel across the Pacific enroute to final destinations. Hawaii student-athletes of all ages will benefit from a number of softball events to be held at the Sand Island Softball Complex.

III. Service Summary and Outcomes

The Grant-in-Aid funds will be used for the following purposes;

- Conduct general field maintenance. Requesting funding for fertilizer and infield additives and conditioners will be applied periodically throughout the year as part of the general maintenance schedule. The general maintenance schedule will ensure that the fields are highly playable, safe and cared for.
- Purchase and installation of turf for the seating area behind the backstops for the safety of the spectators while viewing the games.
- Purchase and installation of scoreboards with game clocks and pitching clocks
- Purchase and installation of a solar system and battery packs for scoreboards.
- Purchase and installation of LED safety lights in the common areas of the complex.
- Purchase and installation of 2 flushable stall restrooms.
- Purchase of signs and mobile bases for the parking lots.
- Purchase and installation of canopy cover for the maintenance yard.
- Purchase and installation of video and audio system in the press-boxes.
- Purchase and installation of roll off window covers for the press-boxes.
- Purchase of maintenance vehicles.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Upon receipt of Grant-in-aid funding, HSF will conduct the following actions resulting in the corresponding outcomes.

Month 1	Ground Cover. Order and install turf in the surrounding area around the backstops and press box areas.
Month 3	Maintenance yard cover and restrooms. Purchase and install wind cover for maintenance yard and purchase and installation of restrooms.
Month 5	Scoreboards. Purchase and install scoreboards with clocks on all 4 fields.
Month 7	Purchase and install solar system and LED safety lights.
Month 9	Purchase and install signs for parking lot and purchase maintenance vehicles.

Donald Meinel, Chair of Hawaii Softball Foundation, will be responsible for ensuring that the facilities are constructed and operating in accordance with the guidelines, standards, and timelines established by the HSF Board of Directors. In addition, HSF will establish a working committee comprised of the Board members and knowledgeable community volunteers to successfully manage the projected and coordinate with DLNR and private contractors.

V. Experience and Capability

1. Necessary Skills and Experience

In 2010, the Hawaii Softball Foundation entered into an adopt-a-park agreement with DLNR State Parks to renovate two derelict baseball/softball fields. HSF privately funded the renovations and in 2011 opened one field for practices and games and one field for practices. Over the past 14 years, HSF has illustrated its ability to manage the various responsibilities that will be required once the complex is completed. The Foundation has maintained the playability of the fields despite being in use 80% of the year, managed user profiles without public complaints, and have become a great asset to the park by driving away the criminal activities that existed in the public park.

Based on our past collaborative partnership under the adopt-a-park agreement with the State of Hawaii, DLNR, HSF presently has a ten (10) year lease agreement since 2021 with the State of Hawaii, Department of Land and Natural Resources for the Sand Island Complex site.

2. Facilities

Since 2021, HSF has maintained a 10-year lease agreement with State of Hawaii, Department of Land and Natural Resources. DLNR allocated \$3 million to the general renovation of the 6-field complex including the renovation of 5 softball fields, the parking lot and comfort station.

The 10-acre Sand Island Softball Complex will serve as the foundation for HSF's public programs. The facility will serve as the first youth softball and baseball complex on Oahu and provide youth programs for both girls and boys and help keep our youth engaged and on a positive path. The educational and programming opportunities that the Sand Island Softball Complex will bring will help further our mission to use softball as a vehicle to develop Hawaii's youth into contributing to members of our society and community leaders.

Additionally, the six-field complex will allow multi-generations of softball athletes to engage with one another in a safe and welcome setting. College student-athletes will have opportunities to engage with and inspire younger generations of softball student-athletes.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Hawaii Softball Foundation is comprised of community and business leaders who share a common goal. HSF's Board of Directors include:

Donald Meinel – Donald is the Chair and co-founder of the Hawaii Softball Foundation. He retired as the Chief Investigator of the Department of the Corporation Counsel, City and County of Honolulu. He also served after 33 years, as the State of Hawaii Commissioner for USA Softball, which is the governing body of softball for the United States of America. Donald was inducted into the Hawaii Sports Officials Hall of Fame in 2024. He continues to organize, manage and support all levels of softball in the State and plays an integral part in everything that involves the sport locally and nationally.

Mike Ching – Mike is the 1st Vice Chair of Hawaii Softball Foundation. Mike serves as a partner of Ernst & Young and was the former Chief Financial Officer for First Hawaii Bank. He has worked in Hawaii and served the broader community for 30 years. Mike is active in the community and serves numerous non-profit boards such as the Chamber of Commerce of Hawaii, Hawaii Humane Society, Aloha Council-Boys Scouts of America, Diamond Head Theatre and the Chinese Chamber of Commerce.

Jon Okada – Jon is the 2nd Vice Chair of Hawaii Softball Foundation. Jon is involved with the softball community for over 25 years and is a main factor in the Foundation regarding improvements in the softball complex at Sand Island by working collaboratively with community groups and the Department of Land and Natural Resources staff.

Dr. Bliss Acoba – Dr. Acoba is the secretary of the Hawaii Softball Foundation. Dr. Acoba is a graduate of the University of Hawaii Medical School and practices at Kapiolani Hospital for Women and Children. Dr. Acoba was an active softball player in high school and college and her daughter is an active softball player.

Erin Sakai – Erin is the Treasurer of Hawaii Softball Foundation. Erin joined the board in 2011 and immediately took over the role of treasurer. Erin is a CPA and the controller

for Road Builders. She brings a unique perspective to the foundation as she participated in Hawaii high school softball and went on to play college softball at Pacific University.

John Uekawa – John is a Director of Hawaii Softball Foundation. John is president of New City Nissan and has been with HSF since its inception. John founded the HSF scholarship program in 2009 and to date the Foundation has awarded over \$50,000 to help our softball student-athletes offset their post-secondary education. He created and continues to sponsor the Goodwill Softball Classic for Hawaii high school softball seniors. In its 16th year, the Classic is the most successful senior event in the State. John remain active in the softball coaching arena as he is in his 16th season as the varsity head coach at Maryknoll School. John was selected as the State Coach of the Year in 2022.

Kenneth Richardson – Ken is a Director of Hawaii Softball Foundation. Ken is president of Island Controls and is a co-founder of the Hawaii Softball Foundation. Ken continues to sit on the executive committee of the Hawaii Softball Foundation. Ken was involved with USA Softball Junior Olympic Program for 21 years and led the first group in creating girls' softball events in Hawaii that attracted mainland teams. Ken continues to work behind the scenes guiding the HSF board in the right direction.


