
A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State's food
2 system depends on cultivating a skilled, culturally grounded,
3 and resilient agricultural workforce, especially since the State
4 faces a shortage of young farmers and agriculture professionals.
5 The lack of a strong agricultural workforce pipeline limits the
6 ability of small farms to scale up production and impedes
7 sustainable growth in the State's agricultural sector.

8 The legislature further finds that Connecticut's
9 Agricultural Science and Technology Education program, which
10 provides high school students with hands-on technical training,
11 certifications, and direct job placement in a variety of
12 agriculture-related fields through its regional centers, has
13 demonstrated measurable success in building agricultural career
14 pathways. California has also launched the California AgTech
15 Alliance to establish a statewide platform to connect research,
16 industry, and farmers in a more coordinated way through its nine
17 regional innovation hubs by deploying cutting-edge technology



1 and training the next generation of agricultural workers,
2 ensuring that farms of all sizes, especially small- and
3 mid-scale operations, have access to the tools and partnerships
4 that keep them productive and sustainable. The State has a
5 unique opportunity to adapt this proven regional hub model into
6 a culturally grounded, island-specific career pathway system
7 that integrates Native Hawaiian agriculture, regenerative
8 practices, aquaculture, agroforestry, and entrepreneurship.

9 The legislature concludes that implementing a kuleana
10 agtech pathways program is a matter of statewide concern
11 pursuant to article X, section 6, of the Hawaii State
12 Constitution.

13 Accordingly, the purpose of this Act is to establish a
14 kuleana agtech pathways program in the university of Hawaii
15 system as a statewide initiative to prepare the State's youth
16 for meaningful careers in the fields of agriculture and
17 agricultural technology.

18 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
19 amended by adding a new section to part I, subpart B, to be
20 appropriately designated and to read as follows:



1 "§304A- Kuleana agtech pathways program; established.

2 (a) There is established a kuleana agtech pathways program, to
3 be administered by the university of Hawaii, to create clear,
4 supported career pipelines in the fields of agriculture and
5 agricultural technology in the State.

6 (b) The university of Hawaii shall work in conjunction
7 with the department of education, department of agriculture and
8 biosecurity, agribusiness development corporation, department of
9 labor and industrial relations, and appropriate community
10 organizations or entities to develop and administer the kuleana
11 agtech pathways program.

12 (c) The kuleana agtech pathways program shall:

13 (1) Expand agricultural science and technology into career
14 and technical education programs in public high
15 schools and the university of Hawaii system;

16 (2) Fund the professional development and establishment of
17 positions, including educators and career
18 coordinators, dedicated to sustaining program quality;

19 (3) Establish internship and apprenticeship opportunities
20 with farms, other businesses, and organizations for
21 program participants;



- 1 (4) Establish dual credit opportunities for program
2 participants pursuant to sections 302A-401 and
3 304A-803;
- 4 (5) Train program participants in climate-smart farming,
5 cultural stewardship, geographic information systems,
6 drone operations, hydroponics, and entrepreneurship;
- 7 (6) Establish an agtech regional hub in at least one
8 public high school or university of Hawaii system
9 campus in each county that provides program
10 participants with education that aligns with each
11 county's agricultural needs and day-to-day
12 coordination with local farmers, other businesses, and
13 organizations providing internships and apprenticeship
14 opportunities; and
- 15 (7) Establish a tiered certification system in the fields
16 of agriculture and agricultural technology at the high
17 school and community college levels.
- 18 (d) The university of Hawaii shall submit annual reports
19 of its findings and recommendations, including any proposed
20 legislation, on the kuleana agtech pathways program to the



1 legislature no later than twenty days prior to the convening of
2 each regular session."

3 SECTION 3. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$ or so
5 much thereof as may be necessary for fiscal year 2026-2027 for
6 the establishment and administration of the kuleana agtech
7 pathways program.

8 The sum appropriated shall be expended by the university of
9 Hawaii for the purposes of this Act.

10 SECTION 4. New statutory material is underscored.

11 SECTION 5. This Act shall take effect on July 1, 3000.
