
A BILL FOR AN ACT

RELATING TO PUBLIC SCHOOL LAND TRANSFER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. Act 307, Session Laws of Hawaii 2022, directed
3 the conveyance of the fee simple title to certain lands owned by
4 the department of land and natural resources, county of Kauai,
5 and county of Maui, to the department of education. Since that
6 time, further verification of information and changes in
7 circumstances require the revision of tax map key numbers
8 provided in Act 307, Session Laws of Hawaii 2022.

9 Accordingly, the purpose of this part is to revise certain
10 tax map key numbers set forth in section 2 of Act 307, Session
11 Laws of Hawaii 2022, for accuracy or changed circumstances.

12 SECTION 2. Act 307, Session Laws of Hawaii 2022, is
13 amended by amending section 2 to read as follows:

14 "SECTION 2. (a) Notwithstanding any other law to the
15 contrary, the fee simple interest to the parcels of land set
16 forth in this section, together with the existing improvements
17 thereon, but not including submerged land, accreted land, or any



1 land makai of the legal shoreline (collectively, the
2 properties), shall be conveyed by their respective owner or
3 owners to the department of education as grantee, as is, where
4 is. The department of education shall accept the properties in
5 their existing condition. All claims and liabilities against
6 the grantors, if any, that the department of education has, may
7 have had, or may have in the future, regarding any injury, loss,
8 cost, damage, or liability, including reasonable ~~[attorney's]~~
9 attorneys' fees, concerning the physical, environmental, soil,
10 economic, and legal conditions of the properties, shall be
11 released, waived, and extinguished.

12 (b) The transfer of a property pursuant to this Act shall
13 be effective by operation of law as of July 1, 2022. The
14 respective owner or owners of the properties shall prepare,
15 execute, and record, in the ~~[land court or bureau of~~
16 conveyances,] office of the assistant registrar of the land
17 court of the State of Hawaii or the bureau of conveyances, as
18 appropriate, a quitclaim deed ~~[to convey each of]~~ or other
19 conveyance instrument to evidence and formally document the
20 conveyance of each of the properties together with all existing
21 improvements. ~~[Work to initiate the conveyance of the~~



1 ~~properties shall commence no later than December 31, 2022. As~~
2 ~~an alternative to conveyance instruments for each parcel of~~
3 ~~state or county owned land, the transfer of such lands shall be~~
4 ~~completed by operation of law.]~~ Where applicable and in the
5 discretion of the department of education, the department of
6 education may elect to obtain all or a portion of each parcel
7 identified by this Act. If the department of education elects
8 to obtain a portion or portions of any parcel identified by this
9 Act, then the parties to the conveyance shall take all actions
10 necessary to legally effect the same.

11 (c) As these are conveyances in which the county and the
12 State and its agencies are the only parties, the tax imposed by
13 section 247-1, Hawaii Revised Statutes, shall not apply.

14 (d) Effective [~~on the date of transfer,~~] July 1, 2022,
15 every reference to the titleholder of the properties shall be
16 construed as a reference to the department of education[~~-~~]
17 irrespective of whether a quitclaim deed or other conveyance
18 instrument has been recorded in the office of the assistant
19 registrar of the land court of the State of Hawaii or the bureau
20 of conveyances.
