
A BILL FOR AN ACT

RELATING TO ARTIFICIAL INTELLIGENCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. The legislature finds that artificial
3 intelligence has the potential to support personalized learning,
4 reduce educator workload, and expand access for rural and
5 underserved communities. However, unregulated or inequitable
6 deployment may exacerbate existing disparities, undermine
7 student privacy, or reduce human interaction in the learning
8 process.

9 The purpose of this Act is to establish statewide guidance,
10 safeguards, and supports for the responsible integration of
11 artificial intelligence in Hawaii's public schools and public
12 institutions of higher education by establishing:

13 (1) An artificial intelligence in education task force;
14 and
15 (2) Procurement and use standards for artificial
16 intelligence tools.

17 PART II



1 SECTION 2. (a) There is established within the department
2 of education for administrative purposes an artificial
3 intelligence in education task force.

4 (b) The superintendent of education, or the
5 superintendent's designee, shall be the chair of the artificial
6 intelligence in education task force.

7 (c) The artificial intelligence in education task force
8 shall be composed of representatives from the following
9 entities, to be designated by the agency's executive officer or
10 designee:

11 (1) The university of Hawaii;
12 (2) Hawai'i P-20 Partnerships for Education;
13 (3) Hawaii State Teachers Association, including
14 representatives of rural communities and the neighbor
15 islands; and
16 (4) Public school administrators, including
17 representatives of rural communities and the neighbor
18 islands.

19 (d) The chair of the artificial intelligence in education
20 task force shall invite the following individuals to participate
21 in the task force:



(1) Students of department of education schools in the

State;

(2) Students of the university of Hawaii;

(3) A data-privacy expert or civil rights expert;

(4) A Native Hawaiian education specialist; and

(5) Technology and cybersecurity professionals.

(e) The artificial intelligence in education task force shall develop:

(1) Model statewide guidance on the use of artificial

intelligence as an instructional tool, including

recommended human-in-the-loop practices;

(2) Data privacy and vendor transparency standards,

including disclosure of training datasets, bias

testing, and audit provisions;

(3) Digital equity recommendations for rural schools and

campuses in the counties of Hawaii, Maui, and Kauai;

(4) Professional-development guidelines for educators

integrating artificial intelligence into teaching; and

(5) A framework for evaluating student learning outcome

in artificial intelligence-supported classrooms.



1 (f) The members of the artificial intelligence in
2 education task force shall serve without compensation but may be
3 entitled to reimbursement for expenses, including travel
4 expenses, necessary for the performance of their duties.

5 (g) The artificial intelligence in education task force
6 shall submit reports of its findings and recommendations,
7 including any proposed legislation, to the legislature no later
8 than December 1 of 2027, 2028, and 2029.

9 (h) The artificial intelligence in education task force
10 shall cease to exist on December 31, 2029.

11 SECTION 3. There is appropriated out of the general
12 revenues of the State of Hawaii the sum of \$ or so
13 much thereof as may be necessary for fiscal year 2026-2027 for
14 the artificial intelligence in education task force.

15 The sum appropriated shall be expended by the department of
16 education for the purposes of this Act.

PART TTT

18 SECTION 4. Chapter 302A, Hawaii Revised Statutes, is
19 amended by adding a new section to be appropriately designated
20 and to read as follows:



1 **"§302A- Artificial intelligence tools; procurement;**

2 **usage.** Before the procurement or use of an artificial
3 intelligence tool, the superintendent shall obtain from the
4 vendor for the artificial intelligence tool documentation
5 certifying:

6 (1) Student-data privacy compliance;
7 (2) Information on training datasets and bias-mitigation
8 testing;
9 (3) Auditability of outputs by demographic group; and
10 (4) Transparent reporting of limitations and risks."

11 SECTION 5. Chapter 304A, Hawaii Revised Statutes, is
12 amended by adding a new section to be appropriately designated
13 and to read as follows:

14 **"§304A- Artificial intelligence tools; procurement;**

15 **usage.** Before the procurement or use of an artificial
16 intelligence tool, the chief financial officer shall obtain from
17 the vendor for the artificial intelligence tool documentation
18 certifying:

19 (1) Student-data privacy compliance;
20 (2) Information on training datasets and bias-mitigation
21 testing;



1 (3) Auditability of outputs by demographic group; and
2 (4) Transparent reporting of limitations and risks."

5 SECTION 7. This Act shall take effect on July 1, 2026.

Report Title:

Department of Education; University of Hawaii; Artificial Intelligence; Task Force; Procurement Standards; Appropriation

Description:

Establishes an Artificial Intelligence in Education Task Force to develop guidelines and recommendations for the use of artificial intelligence in state public education. Requires the Superintendent of Education and Chief Financial Officer of the University of Hawaii to receive certain documentation from a vendor of an artificial intelligence tool before the procurement or use of the artificial intelligence tool. Appropriates funds.
