
A BILL FOR AN ACT

RELATING TO COMMON INTEREST COMMUNITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 421J-4, Hawaii Revised Statutes, is
2 amended by amending subsection (d) to read as follows:

3 " (d) If a proxy is a standard proxy form authorized by the
4 association, the proxy shall contain the following statement,
5 including boxes wherein the owner may indicate that the proxy is
6 given:

7 [(1) ~~For quorum purposes only;~~
8 (2) ~~To the individual whose name is printed on a line next~~
9 ~~to this box;~~
10 (3) ~~To the board of directors as a whole and that the vote~~
11 ~~be made on the basis of the preference of the majority~~
12 ~~of the directors present at the meeting; or~~
13 (4) ~~To those directors present at the meeting and the vote~~
14 ~~to be shared with each board member receiving an equal~~
15 ~~percentage;~~
16 ~~Provided that if]~~

19 SECTION 2. Section 421I-4, Hawaii Revised Statutes, is
20 amended by amending subsection (c) to read as follows:

1 "(c) A proxy [statement] form shall contain [at least the
2 ~~following information:~~], at minimum:

3 (1) The name of the corporation;
4 (2) The date of the meeting to which the proxy is
5 applicable;
6 (3) The printed name and the signature of the shareholder
7 giving the proxy; [and]
8 (4) The dwelling unit or units for which the proxy is
9 given[–]; and

10 (5) The following statement, including boxes wherein the
11 shareholder may indicate that the proxy is given:

12 "[] For quorum purposes only. In order for the
13 Corporation to legally conduct the Meeting, it
14 requires a Quorum percentage of Ownership. If this
15 box is selected, this proxy counts towards the quorum
16 number requirement. Quorum Purposes Only has no
17 voting actions.

18 [] To the individual whose name is printed on a line next
19 to this box: .

20 If you are unable to attend the Meeting or think you
21 may not be able to attend the Meeting, you can select



1 this box and name an individual to represent you as a
2 proxy. If, on the day of the Meeting, you do attend
3 and check in at the Meeting, this proxy shall become
4 void and you will be directly participating in the
5 voting ballot process.

6 To the Board as a whole. This selection means the
7 proxy is presented to the entire Board, not just to
8 individual Directors. The Board is voting together as
9 one. If you are happy with the composition of the

8 SECTION 3. Section 514B-123, Hawaii Revised Statutes, is
9 amended by amending subsection (e) to read as follows:

10 "(e) If a proxy is a standard proxy form authorized by the
11 association, the proxy shall comply with the following
12 additional requirements:

13 (1) The proxy shall contain the following statement,
14 including boxes wherein the owner may indicate that
15 the proxy is given:

16 ~~(A) For quorum purposes only;~~
17 ~~(B) To the individual whose name is printed on a line~~
18 ~~next to this box;~~
19 ~~(C) To the board as a whole and that the vote is to~~
20 ~~be made on the basis of the preference of the~~



1 majority of the directors present at the meeting;

2 or

3 (D) To those directors present at the meeting with
4 the vote to be shared with each director
5 receiving an equal percentage;]

6 "[] For quorum purposes only. In order for the

7 copy of the annual audit report required by section
8 514B-150."

9 SECTION 4. This Act does not affect rights and duties that
10 matured, penalties that were incurred, and proceedings that were
11 begun before its effective date.

12 SECTION 5. Statutory material to be repealed is bracketed
13 and stricken. New statutory material is underscored.

14 SECTION 6. This Act shall take effect upon its approval.
