
A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that an estimated
2 twenty-five thousand elderly individuals in Hawaii require
3 in-home health care or support services, do not qualify for
4 existing programs, such as medicare, and yet cannot afford
5 in-home care services.

6 Accordingly, the purpose of this Act is to establish the
7 KupunAloha program within the department of health to provide
8 in-home health care and support services for individuals who do
9 not qualify for existing government programs and cannot
10 otherwise afford these services.

11 SECTION 2. There is established within the department of
12 health the KupunAloha program to provide in-home health care and
13 support services for eligible individuals who do not otherwise
14 qualify for government assistance for these services. In
15 implementing the program, the department shall create a plan of
16 care for each eligible applicant. The department may refer
17 eligible applicants to health care providers. The program may



1 enter into contracts with health care providers to effectuate
2 the purposes of this Act. The contracts executed pursuant to
3 this Act shall be subject to chapter 103F, Hawaii Revised
4 Statutes.

5 Individuals are not eligible for the program if:

- 6 (1) The individual is covered by medicare;
7 (2) The individual does not meet the income requirements
8 for the program established by the department; or
9 (3) The individual does not meet the need requirements for
10 the program established by the department.

11 SECTION 3. The department of health shall submit a report
12 on the effectiveness of the KupunAloha program established
13 pursuant to this Act to the legislature not later than twenty
14 days prior to the convening of the 2027 regular session. The
15 report shall also include recommendations to improve the
16 efficiency of the KupunAloha program and whether the program
17 should be made permanent.

18 SECTION 4. There is appropriated out of the general
19 revenues of the State of Hawaii the sum of \$2,000,000 or so much
20 thereof as may be necessary for fiscal year 2026-2027 for the
21 KupunAloha program.




