# A BILL FOR AN ACT

RELATING TO NEIGHBORHOOD SAFETY.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that volunteer  
2 neighborhood security watch and neighborhood citizen patrol  
3 groups provide localized support to safety efforts but often  
4 lack access to affordable space for meetings, training, and  
5 administrative coordination. Limited, short-term assistance for  
6 the rental of existing government-owned facilities like schools  
7 can enhance the organizational capacity of these groups in  
8 efforts to build community, promote safe space, and deter  
9 criminal activity.

10       The purpose of this Act is to establish and appropriate  
11 funds for a grant program to help fund certain activities and  
12 rental payments of established neighborhood security watch  
13 groups and neighborhood citizen patrol groups that rent  
14 government-owned facilities for a fee.

15       SECTION 2. Chapter 371K, Hawaii Revised Statutes, is  
16 amended by adding a new section to be appropriately designated  
17 and to read as follows:



1        "§371K-        Neighborhood security watch grant program.        (a)

2        There shall be established within the office of community  
3        services the neighborhood security watch grant program to help  
4        fund certain activities and rental payments of neighborhood  
5        security watch groups and neighborhood citizen patrol groups  
6        that rent government-owned facilities for a fee.

7        (b)        Grants provided pursuant to this section may be used  
8        to pay for costs to conduct meetings, training, administrative  
9        coordination activities, or community events and for rental  
10       payments to use federal, state, or county facilities that offer  
11       public accommodation for a fee; provided that grants shall not  
12       be used for:

13       (1)        Long-term or exclusive lease agreements for real  
14       property;

15       (2)        Equipment rentals; and

16       (3)        Insurance requirements imposed as a condition of a  
17       facility use agreement or policy.

18       (c)        Applicants to whom a grant has been awarded shall  
19       agree to comply with the following conditions before receiving  
20       the grant:



- 1        (1) Be, employ, or have under contract persons who are  
2        qualified to engage in the program or activity to be  
3        funded by the State; provided that for nonprofit  
4        organizations, no two or more members of a family or  
5        kin of the first or second degree shall be employed or  
6        under contract by the organization unless specifically  
7        permitted in writing by the office of community  
8        services;
- 9        (2) Comply with applicable federal and state laws  
10       prohibiting discrimination against any person on the  
11       basis of race, color, national origin, religion,  
12       creed, sex, age, or physical handicap;
- 13       (3) Agree not to use public funds for purposes of  
14       entertainment or perquisites;
- 15       (4) Comply with other requirements as the office of  
16       community services may prescribe to ensure adherence  
17       to federal, state, and county laws by the grant  
18       recipient; and
- 19       (5) Allow the office of community services, the  
20       legislative bodies, and the legislative auditor full  
21       access to records, reports, files, and other related



1           documents so that the program, management, and fiscal  
2           practices of the grant recipient may be monitored and  
3           evaluated to assure the proper and effective  
4           expenditure of public funds.

5           (d) The office of community services shall adopt rules  
6           pursuant to chapter 91 to administer the grant program.

7           (e) For purposes of this section:

8           "Neighborhood citizen patrol" means a community-based,  
9           volunteer group patrol coordinated by a county police department  
10          that meets and has fulfilled all of the requirements of the  
11          police department.

12          "Neighborhood security watch" means a community-based,  
13          volunteer group organized for the purpose of promoting  
14          neighborhood safety that participates in, or is formally  
15          recognized by, a neighborhood security watch program  
16          administered by a county police department."

17          SECTION 3. There is appropriated out of the general  
18 revenues of the State of Hawaii the sum of \$75,000 or so much  
19 thereof as may be necessary for fiscal year 2026-2027 to  
20 administer the neighborhood security watch grant program  
21 established under this Act.




1       The sum appropriated shall be expended by the department of  
2 labor and industrial relations for the purposes of this Act.

3       SECTION 4.   New statutory material is underscored.

4       SECTION 5.   This Act shall take effect on July 1, 2026.
