## A BILL FOR AN ACT

RELATING TO PROTECTIVE ORDERS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that Hawaii is home to a  
2 large and diverse military population, including active duty  
3 personnel, reservists, and their families. While military  
4 families contribute significantly to the social and economic  
5 fabric of the State, they may also face distinct challenges when  
6 navigating the civilian justice system, particularly in  
7 situations involving protective orders.

8       The legislature further finds that enhancing coordination  
9 and communication between civilian law enforcement agencies and  
10 the military is critical to ensuring the safety of victims,  
11 promoting accountability, and preventing further harm. Timely  
12 notification to the security forces of each branch of the  
13 military of protective orders can support command-level  
14 interventions, ensure compliance, and provide a more integrated  
15 response to abusive behavior involving military members or their  
16 dependents.

17       The purpose of this Act is to require information sharing  
18 between the judiciary, the county police departments, the

1 department of law enforcement, and the security forces of each  
2 branch of the military in cases involving protective orders.  
3 This Act is intended to support early intervention, reduce the  
4 risk of repeated violence, and strengthen community safety  
5 through improved collaboration while upholding confidentiality  
6 and due process protections.

7 SECTION 2. Section 586-10, Hawaii Revised Statutes, is  
8 amended to read as follows:

9 "**§586-10 Copy to law enforcement [~~agency-~~] agencies and**  
10 **the security forces of each branch of the military.** (a) Any  
11 order for protection granted pursuant to this chapter shall be  
12 transmitted by the clerk of the court within twenty-four hours  
13 to the appropriate county police department ~~[--]~~, the department  
14 of law enforcement, and the security forces of each branch of  
15 the military.

16 (b) Each county police department shall make available to  
17 other law enforcement officers in the same county, through a  
18 system for verification, information as to the existence and  
19 status of any order for protection issued pursuant to this  
20 chapter.

21 (c) The judiciary, the county police departments, and the  
22 department of law enforcement shall establish policies and

1 procedures, in consultation with the security forces of each  
2 branch of the military, for interagency communications and  
3 training on the implementation of this section, while  
4 safeguarding victim confidentiality, due process, and compliance  
5 with applicable federal and state law.

6 (d) For purposes of this section, the following  
7 definitions apply:

8 "Military" refers to all branches of the United States  
9 Armed Forces responsible for national defense; further defined  
10 as the Army, Marine Corp, Navy, Air Force, Space Force, and  
11 Coast Guard.

12 "Security forces of each branch of the military" refers to  
13 the Army Criminal Investigation Division and U.S. Army Garrison  
14 Hawaii, the Marine Corps Criminal Investigation Division, the  
15 Naval Criminal Investigative Service, the Air Force and Space  
16 Force through the Air Force Office of Special Investigations,  
17 and the Coast Guard Investigative Service."

18 SECTION 3. Statutory material to be repealed is bracketed  
19 and stricken. New statutory material is underscored.

Protective Orders; Law Enforcement; Military; Judiciary;  
Coordination; Notification

**Description:**

Requires notification to the security forces of each branch of the military when a protective order is issued in a case involving a military-affiliated individual.

JUSTIFICATION SHEET

DEPARTMENT: Business, Economic Development, and Tourism

TITLE: A BILL FOR AN ACT RELATING TO PROTECTIVE ORDERS.

PURPOSE: To strengthen protective order enforcement and victim safety by requiring coordination and information sharing between the Judiciary, the county police departments, the Department of Law Enforcement, and the security forces of each branch of the military in cases involving military-affiliated individuals and protective orders.

MEANS: Amend section 586-10, Hawaii Revised Statutes (HRS).

JUSTIFICATION: Chapter 586, HRS, does not currently require notification to the security forces of each branch of the military when protective orders are issued in cases involving military-affiliated individuals. This bill would require timely notification to the security forces of each branch of the military in these specific cases and require the Judiciary, the county police departments, and the Department of Law Enforcement to establish procedures for information sharing in consultation with the security forces of each branch of the military.

Impact on the public: Increases accountability and improves safety for victims with protective orders involving military-affiliated individuals.

Impact on the department and other agencies: No impact on the Department. The Judiciary, the county police departments, the Department of Law Enforcement, and the security forces of each branch of the military will need to update protocols for information sharing and interagency

coordination. No significant fiscal impact is anticipated. Military commands will benefit from more consistent awareness of protective orders involving personnel under their jurisdiction.
