# A BILL FOR AN ACT

RELATING TO PUBLIC NOTICE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that section 1-28.5,  
2 Hawaii Revised Statutes, requires publication of government  
3 notices in newspapers of general circulation. These  
4 requirements were adopted before widespread electronic access  
5 and no longer reflect the most efficient or accessible means of  
6 informing the public.

7 The legislature further finds that posting notices on  
8 official state and county websites provides greater  
9 transparency, accessibility, and timeliness. Aligning public  
10 notice requirements with the sunshine law under section 92-7(b),  
11 Hawaii Revised Statutes, will modernize state communications and  
12 ensure consistent public access to government information.

13 The purpose of this Act is to update the requirements for  
14 publication of public notices by allowing electronic posting on  
15 official government websites, while preserving traditional  
16 publication options when necessary.



1 SECTION 2. Section 1-28.5, Hawaii Revised Statutes, is  
2 amended to read as follows:

3 **"§1-28.5 [Publication of] Public notice.** (a)

4 Notwithstanding any other statute, law, charter provision,  
5 ordinance, or rule to the contrary, whenever a government agency  
6 is required to give public notice or to publish notice, the  
7 notice shall be given [~~only~~] as follows:

8 (1) For statewide [~~publication~~] notice:

9 (A) [~~In a daily or weekly publication of statewide~~  
10 ~~circulation~~] By posting the notice on an  
11 electronic calendar or website maintained by the  
12 State; or

13 (B) [By] In a daily or weekly publication of  
14 statewide circulation, or by publication in  
15 separate daily or weekly publications whose  
16 combined circulation is statewide; and

17 (2) For county-wide [~~publication, by~~] notice:

18 (A) By posting the notice on an electronic calendar  
19 or website maintained by the appropriate county;  
20 or



1                   (B) By publication in a daily or weekly publication  
2                    in the affected county.

3                   (b) ~~For purposes of this section, the comptroller~~  
4                   pursuant to chapter 103D shall determine a publication for all  
5                   government agencies to enable the public to go to one source of  
6                   publication for published public notice on each island.

7                   (c) ~~Whenever a public notice is published in a newspaper~~  
8                   ~~or other publication described in subsection (a), proof of the~~  
9                   ~~publication shall be the affidavit of the printer, publisher,~~  
10                   ~~principal clerk, or business manager of the newspaper or other~~  
11                   ~~publication or of the designated agent of the group that~~  
12                   ~~published the notice.~~

13                   (d) ~~This section shall not apply to notices required by~~  
14                   ~~chapters 103D, 103F, 127A, and 523A.~~

15                   (e) ~~For purposes of publishing a proposed, revised, or~~  
16                   ~~final reapportionment plan pursuant to section 25-2, public~~  
17                   ~~notice shall be permitted in a short form; provided that each~~  
18                   ~~short form public notice shall include the following~~  
19                   ~~information:~~

20                   (1) ~~Whether the reapportionment plan has been either~~  
21                   ~~proposed, revised, or adopted;~~



1                   (2) ~~The online location to view the reapportionment plan;~~  
2                   (3) ~~A list of the location of each public office where the~~  
3                   ~~hard copies of the reapportionment plan and maps are~~  
4                   ~~available; and~~  
5                   (4) ~~The public hearing dates.]~~

6                   (b) Unless otherwise provided by law, notice shall be  
7                   posted or published no less than six calendar days before the  
8                   required action, meeting, or effective date.

9                   (c) Each agency shall maintain a physical copy of all  
10                  public notices in its office for public inspection during  
11                  regular business hours.

12                  (d) Additional supplemental notice may also be given  
13                  through Hawaii FYI, the State's interactive computer system[–],  
14                  or other electronic means.

15                  [–] (e) For purposes of this section, "government  
16                  agency" means each department, board, commission, or officer of  
17                  the State or any of its political subdivisions."

18                  SECTION 3. Statutory material to be repealed is bracketed  
19                  and stricken. New statutory material is underscored.

20                  SECTION 4. This Act shall take effect upon its approval.
