

# A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE  
NINETEENTH REPRESENTATIVE DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

SECTION 1. The director of finance is authorized to issue general obligation bonds in the sum of \$60,200,000 or so much thereof as may be necessary and the same sum or so much thereof as may be necessary is appropriated for fiscal year 2026-2027 for the purpose of capital improvement projects for the nineteenth representative district, as follows:

7 1. Maunalua Bay beach park

8 Plans, design, and construction for  
9 phase 2 repairs to boat launch, parking  
10 lot, and beach park at Maunalua Bay  
11 beach park.

13 broadcast studio; scene shop; science,  
14 technology, engineering, and  
15 mathematics innovation space; dance  
16 studio; art gallery; and graphics arts  
17 classroom.

18 Design \$5,250,000

19 Construction \$44,250,000

20 Total funding \$49,500,000



1       The sum appropriated for this capital improvement project  
2 shall be expended by the department of education.

3   6.   Kalaupahoi fishpond (Lucas Spring)

4       Construction for unforeseen costs to  
5       complete restoration of fresh artesian  
6       water flow to the fishpond.



12       SECTION 2. The appropriation made for the capital  
13 improvement projects authorized by this Act shall not lapse at  
14 the end of the fiscal year for which the appropriation is made;  
15 provided that all moneys from the appropriation unencumbered as  
16 of June 30, 2028, shall lapse as of that date.

17       SECTION 3. This Act shall take effect on July 1, 2026.
