## A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE TWENTY-SIXTH REPRESENTATIVE DISTRICT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The director of finance is authorized to issue  
2 general obligation bonds in the sum of \$3,060,000 or so much  
3 thereof as may be necessary and the same sum or so much thereof  
4 as may be necessary is appropriated for fiscal year 2026-2027  
5 for the purpose of capital improvement projects for the twenty-  
6 sixth representative district, as follows:

7 1. Queen Ka‘ahumanu elementary school

8 Plans and construction for a six foot  
9 fence and gates around the perimeter of  
10 the school.

11 Plans \$200,000

12 Construction \$500,000

13 Total funding \$700,000

14 The sum appropriated for this capital improvement project  
15 shall be expended by the department of education.

16 2. McKinley high school





1 student transportation, cultural  
2 learning excursions, athletic events,  
3 and community engagement activities.

4 Equipment \$320,000

5 Total funding \$320,000

6 The sum appropriated for this capital improvement project  
7 shall be expended by the department of education.

8 5. Halau Ku Mana new century public  
9 charter school

10 Construction for a permanent wastewater  
11 system installation and new lunch and  
12 outdoor classroom areas.

13 Construction \$90,000

14 Total funding \$90,000

15 The sum appropriated for this capital improvement project  
16 shall be expended by the department of education.

17 6. Papakōlea Community Development  
18 Corporation

19 Plans for Pūowaina NHECC Phase II to  
20 complete detailed design and  
21 construction drawings needed to

15 SECTION 2. The appropriation made for the capital  
16 improvement projects authorized by this Act shall not lapse at  
17 the end of the fiscal year for which the appropriation is made;  
18 provided that all moneys from the appropriation unencumbered as  
19 of June 30, 2028, shall lapse as of that date.

**20** SECTION 3. This Act shall take effect on July 1, 2026.
