A BILL FOR AN ACT

RELATING TO LUNG CANCER SCREENING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that, according to the
2 American Lung Association, lung cancer is the leading cause of
3 cancer death in the State, with the disease disproportionately
4 affecting Asian Americans, Native Hawaiians, and other Pacific
5 Islanders. The legislature additionally finds that early stage
6 diagnosis through annual low-dose computed tomography screening
7 increases survival rates by detecting and treating the cancer
8 early.

9 Accordingly, the purpose of this Act is to:

10 (1) Require the department of health to develop no later
11 than December 31, 2026, standardized educational
12 materials relating to lung cancer screening and
13 language on lung cancer screening information to be
14 included in signage and written notices to be used by
15 retailers of tobacco products; and
16 (2) Beginning January 1, 2027, require retailers engaged
17 in the retail sale of tobacco products to display



1 signage on lung cancer screening at each point of sale
2 and provide written notice on lung cancer screening to
3 each buyer of a tobacco product.

4 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
5 amended by adding a new subpart to part XVIIA to be
6 appropriately designated and to read as follows:

7 " . Retail Sale of Tobacco; Signage and Notices

8 **§321-** **Lung cancer screening awareness, signage and**
9 **notice.** (a) No later than December 31, 2026, the department of
10 health shall develop and make available to the public:

11 (1) Standardized educational materials describing:

12 (A) Eligibility criteria for lung cancer screening
13 using low-dose computed tomography;

14 (B) Locations of federally qualified health centers
15 and hospitals offering lung cancer screening; and
16 (C) The benefits and importance of early detection of
17 lung cancer;

18 (2) Language on lung cancer screening to be included in
19 signage to be displayed at each point of sale of
20 tobacco products; and



1 (3) Language on lung cancer screening to be included in
2 written notice to be provided to each buyer of a
3 tobacco product.

4 (b) Beginning January 1, 2027, every retailer engaged in
5 the retail sale of tobacco products shall:

6 (1) Prominently display signage including language
7 developed pursuant to subsection (a)(2) at each point
8 of sale of a tobacco product, including on vending
9 machines; and

10 (2) Provide to each buyer of a tobacco product a written
11 notice including language developed pursuant to
12 subsection (a) (3).

13 (c) If this section or any provision of this section
14 conflicts at any time with federal law, then the federal law
15 shall prevail and this section or the relevant provisions of
16 this section shall become ineffective and invalid. The
17 ineffectiveness or invalidity of this section or any of its
18 provisions shall not affect any other provisions or applications
19 of this section which shall be given effect without the invalid
20 provision or application, and to this end, the provisions of
21 this section are severable.



1 (d) For the purposes of this section:

2 "Retailer" has the same meaning as defined in section
3 245-1.

4 "Retail sale of tobacco products" has the same meaning as
5 "retail sale" or "tobacco retailing" as those terms are defined
6 in section 245-1.

7 **§321- Rules.** The department of health may adopt rules
8 in accordance with chapter 91 for the purposes of implementing
9 this subpart."

10 SECTION 3. Chapter 321, Hawaii Revised Statutes, is
11 amended as follows:

12 1. By designating section 321-211 as subpart A, and
13 inserting a title before section 321-211 to read:

14 "A. General Provisions"

15 2. By designating sections 321-212 to 321-214 as subpart
16 B, and inserting a title before section 321-212 to read:

"B. Possession or Consumption of Tobacco Products"

18 SECTION 4. Section 321-213, Hawaii Revised Statutes, is
19 amended to read as follows:

20 "[§]S321-213[§] **Exemptions.** This part subpart shall not
21 apply to:



1 (1) Any person under twenty-one years of age, with
2 parental authorization, who is participating in a
3 controlled purchase as part of a law enforcement
4 activity or a study authorized by the department of
5 health under the supervision of law enforcement to
6 determine the level of incidence of tobacco sales to
7 persons under twenty-one years of age; or
8 (2) Possession of tobacco products by a person under
9 twenty-one years of age in the course of delivery,
10 pursuant to the direction of the person's employer
11 lawfully engaged in business necessitating the
12 delivery."

13 SECTION 5. Statutory material to be repealed is bracketed
14 and stricken. New statutory material is underscored.

15 SECTION 6. This Act shall take effect upon its approval.

Report Title:

DOH; Lung Cancer Screening; Educational Materials; Signage; Written Notice; Cigarettes; Tobacco Products; Retailers

Description:

Requires the Department of Health to develop by 12/31/2026, standardized educational materials relating to lung cancer screening and language on lung cancer screening information to be included in signage and written notices to be used by retailers of tobacco products. Beginning 1/1/2027, requires retailers engaged in the retail sale of tobacco products to display signage on lung cancer screening at each point of sale and provide written notice on lung cancer screening to each buyer of a tobacco product.
