## A BILL FOR AN ACT

RELATING TO SOLID WASTE MANAGEMENT.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that the permit for the  
2 Waimanalo Gulch Sanitary Landfill in Kapolei on Oahu expires in  
3 2028.

4 The legislature also finds that the city and county of  
5 Honolulu has not identified any sites for a new landfill that  
6 the Honolulu board of water supply finds acceptable because the  
7 sites identified are located above aquifers and therefore  
8 development of a new landfill in those locations has the  
9 potential to contaminate ground water.

10 The legislature further finds that the United States  
11 Department of Defense holds that federal lands controlled by the  
12 military are not available for landfill use under federal rules.

13 The legislature further finds that if no alternate landfill  
14 site is identified, the city and county of Honolulu will be  
15 forced to pursue a legally prohibited expansion of the Waimanalo  
16 Gulch Sanitary Landfill.



1       The legislature further finds that a new landfill on Oahu  
2 is inherently problematic and is not necessarily the best way  
3 that communities in the State can reduce and handle the solid  
4 waste produced by their linear extract, package, and throw-away  
5 economy.

6       Accordingly, the purpose of this Act is to establish a  
7 temporary working group in the office of the governor to address  
8 and inform policies and programs to reduce solid waste.

9       SECTION 2. (a) The governor shall convene a temporary  
10 solid waste management working group, whose membership shall  
11 comprise the following:

- 12       (1) A representative from the department of health;
- 13       (2) A representative from the department of environmental  
14                services of the city and county of Honolulu;
- 15       (3) A representative from each county, as designated by  
16                the mayor of that county;
- 17       (4) A representative from the Honolulu board of water  
18                supply;
- 19       (5) A representative from the recycling industry, to be  
20                invited by the governor;



- (6) A representative from the composting industry, to be invited by the governor;
- (7) A representative from the reuse industry, to be invited by the governor;
- (8) A representative from the deconstruction industry, to be invited by the governor;
- (9) A representative from Zero Waste USA, to be invited by the governor;
- (10) A representative from a Hawaii-based environmental nonprofit organization advocating for zero waste priorities, to be invited by the governor;
- (11) A landfill expert with specialization in landfill liner leakage, to be invited by the governor;
- (12) An expert in unit-based pricing, to be invited by the governor;
- (13) An expert in pyrolysis, to be invited by the governor;
- (14) An expert in plasma arc gasification, to be invited by the governor; and
- (15) A representative from the United States Armed Forces, to be invited by the governor.



12 (1) Information on materials management policies and  
13 programs that reduce solid waste and protect the  
14 environment, which includes the groundwater, earth,  
15 and air; and

16 (2) A list of alternative technologies to address solid  
17 waste management of waste that cannot typically be  
18 recycled or composted.

19 SECTION 3. This Act shall take effect upon its approval  
20 and shall repeal on June 30, 2027.

**Report Title:**

Governor; Department of Health; Honolulu Board of Water Supply; Solid Waste Management; Working Group; Counties; Report

**Description:**

Establishes a temporary solid waste management working group in the Office of the Governor to examine materials management policies and programs that reduce solid waste and protect the environment, and to present a list of alternative technologies to address solid waste management. Requires a report to the Legislature. Repeals 6/30/2027.
