
A BILL FOR AN ACT

RELATING TO RENEWAL OF DRIVER'S LICENSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-107, Hawaii Revised Statutes, is
2 amended by amending subsection (e) to read as follows:

3 "(e) No driver's license shall be renewed by the examiner
4 of drivers unless:

5 (1) The examiner of drivers is satisfied of the
6 applicant's fitness to continue to operate a motor
7 vehicle;

8 (2) If the applicant has received a moving violation
9 within the previous five years from the date that the
10 applicant files for renewal, completes an educational
11 course that includes:

12 (A) An online road safety video developed by the
13 department of transportation; and

14 (B) A written road safety examination that tests an
15 applicant's:

16 (i) Ability to understand highway signs
17 regulating, warning, and directing traffic;



1 (ii) Knowledge of the rules of the road based on
2 the state traffic laws and county traffic
3 ordinances where the applicant resides or
4 intends to operate a motor vehicle,
5 including any new or amended state traffic
6 laws and county traffic ordinances;

7 (iii) Knowledge and understanding of information
8 relating to driver safety and collision
9 reduction as determined by the department;
10 and

11 (iv) Any other knowledge of the rules of the road
12 that the department of transportation deems
13 necessary to determine the applicant's
14 fitness to continue to operate a motor
15 vehicle;

16 [~~+2~~] (3) The fee required by subsection (d) is tendered
17 together with the application for renewal;

18 [~~+3~~] (4) The applicant complies with section 286-102.5;

1 [~~4~~] (5) The examiner of drivers is satisfied that the
2 applicant does not have outstanding charges and fines
3 relating to the disposition of an abandoned vehicle.

4 For the purposes of this subsection, "moving violation"
5 means a violation of state traffic laws or county traffic
6 ordinances committed by a driver while the motor vehicle is in
7 motion, including moving violations under chapter 291C. "Moving
8 violation" does not include parking violations and violations
9 that do not involve the operation of a motor vehicle in motion."

10 SECTION 2. Statutory material to be repealed is bracketed
11 and stricken. New statutory material is underscored.

12 SECTION 3. This Act shall take effect on July 1, 2027.
