S.B. NO. 3015

A BILL FOR AN ACT

RELATING TO PERSONAL INFORMATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the safety of public
2 servants and candidates for public office is essential to the
3 functioning of a democratic society. In recent years, threats,
4 harassment, and acts of violence directed at public officials
5 and their families have increased nationwide, often facilitated
6 by the easy public availability of personal identifying
7 information, such as home addresses.

8 The legislature further finds that the targeted
9 assassination of Melissa Hortman and her husband underscore the
10 real and grave dangers posed when malicious actors are able to
11 locate and target public servants at their homes. Such acts of
12 violence not only endanger the lives of those who serve, but
13 also chill civic participation and deter qualified individuals
14 from seeking or continuing public service.

15 The legislature recognizes the need to balance transparency
16 in government with the fundamental right to personal safety. By
17 establishing a process to obtain such information, it protects



1 public officials, candidates, and their families from harm,
2 while maintaining government transparency.

3 Accordingly, the purpose of this Act is to limit public
4 access to the home addresses of public servants and candidates
5 by establishing procedures for redaction and disclosure, and
6 providing a mechanism for objection when disclosure would place
7 individuals or their families in imminent danger.

8 SECTION 2. Chapter 92H, Hawaii Revised Statutes, is
9 amended by adding two new sections to be appropriately
10 designated and to read as follows:

11 "§92H- Home address; removal. (a) Every government
12 agency that maintains, uses, collects, or possesses the home
13 address of a covered public servant or candidate shall ensure
14 that the home address is not publicly accessible.

15 (b) Each government agency shall redact or otherwise
16 remove home addresses from:

- 17 (1) The agency's website;
18 (2) Online searchable databases of the agency;
19 (3) Printed documents or publications that are made
20 publicly available by the agency; and
21 (4) Any other publicly accessible source of information.



1 §92H- Requests for disclosure; home address;
2 notification; objection to disclosure. (a) An individual may
3 submit a request to an agency for the home address of a covered
4 public servant or candidate; provided that the agency shall
5 first:

6 (1) Notify the covered public servant or candidate of the
7 request;

8 (2) Provide the name, mailing address, telephone number,
9 and electronic mailing address of the individual
10 requesting the information; and

11 (3) Provide a copy of the request.

12 (b) A covered public servant or candidate may object to
13 the disclosure of their home address by submitting an objection
14 to the government agency within business days of receiving
15 notice under subsection (a). An objection shall include a
16 statement that disclosure of the covered public servant or
17 candidate's home address would place them, a household member,
18 or their property in imminent danger. If no objection is
19 received within the time allotted under this section, the
20 government agency may disclose the information.



(c) For purposes of this section, "candidate" has the same meaning as in section 11-302."

SECTION 3. Section 92H-1, Hawaii Revised Statutes, is amended by amending the definition of "covered public servant" to read as follows:

"Covered public servant" means:

- ~~[(1) The governor;~~
- ~~(2) The lieutenant governor;~~
- ~~(3) The administrative director appointed pursuant to section 26-3;~~
- ~~(4) Any head of a department established under section 26-4;~~
- ~~(5) Any member of the legislature;~~

14 who resides in the State, formerly resided in the
15 State while serving as a federal judge, or owns real

Report Title:

Personal Information; Covered Public Servants; Candidates; Home Address; Removal

Description:

Requires every government agency that maintains, uses, collects or processes the home address of a covered public servant or candidate, to ensure that their home address is not publicly accessible. Requires every government agency to redact or otherwise remove home addresses from certain websites, databases, and printed documents or publications. Authorizes an individual to request disclosure of the home address, under certain circumstances. Allows a covered public servant or candidate to object to the disclosure of their home address.
