## A BILL FOR AN ACT

RELATING TO AGRICULTURAL GRANT ADMINISTRATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1       SECTION 1. The legislature finds that federal agricultural  
2 grants provide financial support to Hawaii's agricultural  
3 industry. The department of agriculture and biosecurity  
4 actively pursues these federal grants and has recently hired a  
5 grant writer, whose efforts have yielded great results. Since  
6 November 2024, \$8,899,450.16 in federal grant funds have been  
7 obtained from the United States Department of Agriculture and  
8 another \$5,285,000 in grants have applications in process. Many  
9 of the federal grants being pursued by the department provide  
10 for indirect overhead reimbursements or an allowable management  
11 fee to reimburse the State for costs associated with management  
12 of certain federal grants. The establishment of a formal  
13 agricultural grant program and a revolving fund would allow the  
14 department to retain these funds and cover a portion of the  
15 program costs. Funds from the revolving fund would be used to  
16 search for additional grant opportunities, develop program  
17 applications to monitor grant execution, ensure compliance with  
18 grant requirements, and to audit grant expenditures. Moneys in

1 the fund will also be used for consultant services and  
2 operational expenses.

3 SECTION 2. Chapter 141, Hawaii Revised Statutes, is  
4 amended by adding to part I, two new sections to be  
5 appropriately designated and to read as follows:

6 "§141- Agricultural grant program; established. (a)

7 There is established in the department of agriculture and  
8 biosecurity an agricultural grant program to search, apply, and  
9 administer federal agricultural grant opportunities that could  
10 benefit the Hawaii agricultural industry.

11 (b) The department of agriculture and biosecurity may  
12 retain and expend federal indirect overhead reimbursements for  
13 grants as determined by the chairperson of the board of  
14 agriculture and biosecurity.

15 §141- Agricultural grant revolving fund. (a) There is  
16 established in the state treasury an agricultural grant  
17 revolving fund into which shall be deposited the department of  
18 agriculture and biosecurity's share of federal indirect overhead  
19 reimbursements, pursuant to section 141- . The department of  
20 agriculture and biosecurity may expend funds in the agricultural  
21 grant revolving fund to search for discretionary grants, develop  
22 program applications to secure additional revenues for the


department of agriculture and biosecurity, monitor grant  
execution, ensure compliance with grant requirements, and audit  
grant expenditures. Moneys in the revolving fund may be  
expended for consultant services and operational expenses,  
including the hiring of temporary staff.

(b) The department of agriculture and biosecurity shall  
prepare and submit an annual report on the status of federal  
agricultural grants revolving fund to the legislature. The  
annual report shall include but not be limited to a list of the  
grant applications to federal agencies and the grant awards  
received."

SECTION 3. New statutory material is underscored.

SECTION 4. This Act, upon its approval, shall take effect  
on July 1, 2026.

## JUSTIFICATION SHEET

DEPARTMENT: AGRICULTURE AND BIOSECURITY

TITLE: A BILL FOR AN ACT RELATING TO AGRICULTURAL GRANT ADMINISTRATION.

PURPOSE: To establish an agricultural grant program and revolving fund to retain and expend federal grant indirect overhead reimbursements.

MEANS: Add two new sections to part I of chapter 141, Hawaii Revised Statutes.

JUSTIFICATION: Federal agricultural grants are an important resource for Hawaii farmers, ranchers, and processors and provide additional financial support for the agricultural industry. The Department currently seeks federal grant opportunities, and the proposed revolving fund provides the mechanism to allow the Department to retain and expend federal overhead reimbursement moneys to seek additional grant opportunities, develop program applications to monitor grant execution, ensure compliance with grant requirements and to audit grant expenditures.

Impact on the public: Increased federal grant opportunities.

Impact on the department and other agencies: The Department will have increased ability to seek federal grants with greater resources for grant management and audits.
