## **A BILL FOR AN ACT**

RELATING TO EDUCATION.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that, until June 30,  
2       2020, section 302A-431.9, Hawaii Revised Statutes, authorized  
3       the department of education to award high school diplomas to  
4       qualified persons who did not receive a high school diploma as a  
5       result of compulsory induction into active service in the armed  
6       services of the United States, or any person whose high school  
7       education was interrupted due to wartime practices such as  
8       internment during World War II.

9       The purpose of this Act is to authorize the department of  
10      education to award a high school diploma to a qualified person  
11      who did not receive a high school diploma as a result of  
12      compulsory or voluntary induction into active service in the  
13      armed services of the United States or whose high school  
14      education was interrupted due to wartime practices during World  
15      War II, the Korean War, or the Vietnam War.

16      SECTION 2. Chapter 302A, Hawaii Revised Statutes, is  
17      amended by adding to part II a new section to be appropriately  
18      designated and to read as follows:

1        "§302A-    High school diploma for armed services veterans  
2 and other qualified persons.    (a)    The department is authorized  
3 to establish a program to award a high school diploma to any  
4 qualified person who:

5        (1)    Did not receive a high school diploma as a result of  
6                compulsory or voluntary induction into active service  
7                in the armed services of the United States during  
8                World War II, the Korean War, or the Vietnam War; or

9        (2)    Did not receive a high school diploma and whose high  
10               school education was interrupted due to wartime  
11               practices during World War II, the Korean War, or the  
12               Vietnam War.

13        (b)    A qualified person seeking a high school diploma shall  
14 submit information establishing eligibility for the award of a  
15 high school diploma pursuant to subsection (a) to the  
16 department, on forms prescribed by the department.

17        (c)    For purposes of this section, a "qualified person"  
18 means any individual who:

19        (1)    Was enrolled in a high school in the State or the  
20               Territory of Hawaii between:

21               (A)    December 1, 1941, and August 30, 1945;

22               (B)    June 1, 1950, and July 31, 1953; or

- 1            (C) August 1, 1964, and January 31, 1973;  
2            (2) Was compulsorily or voluntarily inducted into the  
3            armed services of the United States or whose high  
4            school education was interrupted; and  
5            (3) Did not complete a high school curriculum and  
6            receive a high school diploma."

7            SECTION 3. New statutory material is underscored.

8            SECTION 4. This Act shall take effect upon its approval.

**Report Title:**

DOE; Veterans; High School Diploma

**Description:**

Authorizes the Department of Education to award a high school diploma to qualified persons who did not receive a high school diploma as a result of compulsory or voluntary induction into the armed services of the United States or whose high school education was interrupted due to wartime practices during World War II, the Korean War, or the Vietnam War.

JUSTIFICATION SHEET

DEPARTMENT: Education

TITLE: A BILL FOR AN ACT RELATING TO EDUCATION.

PURPOSE: To authorize the Department to award high school diplomas to qualified individuals whose education was interrupted due to compulsory or voluntary military service in World War II, the Korean War, or the Vietnam War, or due to wartime practices such as internment.

MEANS: Add a new section to part II of chapter 302A, Hawaii Revised Statutes (HRS).

JUSTIFICATION: Section 302A-431.9, HRS, previously authorized the Department to award high school diplomas to qualified persons who did not graduate due to compulsory induction into active military service or interruption caused by wartime practices. That authority expired on June 30, 2020.

This bill restores that authority, and adds those individuals who were voluntarily inducted into the armed services as qualified persons. Many individuals left school to serve in the armed forces or were impacted by wartime conditions and were unable to complete their education.

Awarding diplomas to these qualified individuals acknowledges their sacrifice and provides recognition for their contributions and hardships.

Impact on the public: Families and communities will benefit from the recognition afforded to these individuals.

Impact on the department and other agencies: Minimal administrative impact on the Department. No impact on other agencies.
