# A BILL FOR AN ACT

RELATING TO EMERGENCY MEDICAL SYSTEMS OF CARE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that the State's current  
2 emergency medical services statutes were designed for an earlier  
3 era and do not reflect the complexities of modern time-  
4 sensitive, emergency medical systems of care. Recent emergency  
5 events across the State have exposed significant gaps in  
6 coordination, integration, and resource deployment across  
7 emergency medical services, acute care facilities, and the  
8 trauma system. These events underscored the vulnerability of  
9 Hawaii's geographically isolated rural communities and  
10 highlighted the urgent need for modernization.

11       The legislature further finds that contemporary models of  
12 emergency and acute care prioritize integrated systems that  
13 address time-sensitive emergencies such as trauma, heart  
14 attacks, strokes, sepsis, and burns with the same urgency and  
15 structure as traditional emergency response. By adopting a  
16 time-sensitive emergency medical systems of care model, Hawaii  
17 can improve patient survival, reduce long-term disability, and  
18 strengthen statewide resilience in times of disaster or public

1 health crisis.

2 Aligning Hawaii's emergency medical services statutes with  
3 national best practices in systems integration will:

4 (1) Ensure coordinated, evidence-based care for time-  
5 sensitive emergencies across all islands;

6 (2) Modernize emergency medical services and trauma  
7 systems to meet current and future challenges;

8 (3) Improve patient outcomes through standardized,  
9 statewide protocols; and

10 (4) Enhance preparedness for future natural disasters,  
11 mass casualty incidents, and public health threats.

12 Accordingly, the purpose of this Act is to update Hawaii's  
13 emergency medical services statutes to establish a  
14 comprehensive, time-sensitive, emergency medical systems of care  
15 model that strengthens the State's capacity to respond  
16 effectively to emergencies and safeguard the health of our  
17 residents, living on all islands.

18 SECTION 2. Section 321-221, Hawaii Revised Statutes, is  
19 amended to read as follows:

20 "**§321-221 Findings and purpose.** The legislature finds  
21 that the establishment of [a] state emergency medical [~~services~~  
22 ~~system~~] systems of care, including emergency medical services,

1 emergency medical services for children, and trauma and critical  
2 care services is a matter of compelling state interest and  
3 necessary to protect and preserve public health. A system  
4 designed to reduce medical emergency deaths, injuries, and  
5 permanent long-term disability through the implementation of a  
6 fully integrated, cohesive network of components, the  
7 legislature further finds, will best serve public health  
8 needs. Accordingly, the ~~[purpose]~~ purposes of this part ~~[is]~~  
9 are to establish and maintain ~~[a]~~ state emergency medical  
10 ~~[services system]~~ systems of care in communities that can be  
11 most effectively served by the State, and to fix the  
12 responsibility for the administration of ~~[this]~~ state ~~[system]~~  
13 emergency medical systems of care, which shall provide for the  
14 arrangement of personnel, facilities, and equipment for the  
15 effective and coordinated delivery of health care services under  
16 emergency conditions, whether occurring as the result of a  
17 patient's condition, from natural disasters, or from other  
18 causes. The ~~[system]~~ emergency medical systems of care shall  
19 provide for personnel, personnel training, communications,  
20 emergency transportation, facilities, coordination with  
21 emergency medical and critical care services, coordination and  
22 use of available public safety agencies, promotion of consumer

1 participation, accessibility to care, mandatory standard medical  
2 recordkeeping, consumer information and education, independent  
3 review and evaluation, disaster linkage, mutual aid agreements,  
4 and other components necessary to meet the purposes of this  
5 part."

6 SECTION 3. Section 321-222, Hawaii Revised Statutes, is  
7 amended to read as follows:

8 **"§321-222 Definitions.** As used in this part, unless the  
9 context clearly requires otherwise:

10 "Advanced emergency medical technician" means a health  
11 professional certified by the National Registry of Emergency  
12 Medical Technicians and licensed by the State of Hawaii as an  
13 advanced emergency medical technician to provide basic and  
14 limited advanced emergency medical care and transportation for  
15 critical and emergency patients to access the emergency medical  
16 systems of care.

17 "Advanced life support" means initiating all basic life  
18 support care as well as invasive patient care designed to  
19 stabilize and support a patient's condition due to sudden  
20 illness or injury. The care rendered, excluding basic life  
21 support, constitutes the practice of medicine.

1        "Advisory [~~committee~~] council" means the Hawaii emergency  
2        medical [~~services~~] systems of care advisory [~~committee.~~]  
3        council.

4        "Air-medical services" means medical care and transport of  
5        patients by aircraft, provided by a licensed air ambulance  
6        operator with qualified medical personnel, and regulated as part  
7        of the statewide emergency medical systems of care.

8        "Basic life support" means initiating noninvasive emergency  
9        patient care designed to optimize the patient's chances of  
10       surviving the emergency situation. The care rendered consists  
11       of all first aid procedures needed, but does not include  
12       invasive procedures [~~which~~] that constitute the practice of  
13       medicine; provided that state-approved basic life support  
14       personnel may use fully automatic external defibrillators,  
15       initiate intravenous lines, place tourniquets, and perform  
16       manual external defibrillation under the direction and personal  
17       supervision of a [~~mobile intensive care technician~~] state-  
18       licensed clinician and in accordance with rules adopted by the  
19       department.

20       "Department" means the department of health.

21       "Emergency [~~aeromedical~~] air-medical services" means a  
22       [~~secondary~~] response system that provides immediate critical

1 care and transport [~~by rotary-wing aircraft~~] of a patient by  
2 aircraft to a facility that provides specialized medical care.

3 "Emergency medical responder" means a person certified by  
4 the National Registry of Emergency Medical Technicians.

5 "Emergency medical services for children" means emergency  
6 medical services, including preventive, pre-hospital, hospital,  
7 rehabilitative, and other post-hospital care for children.

8 "Emergency medical services personnel" means any [~~mobile~~  
9 ~~intensive care technician or~~] paramedic, advanced emergency  
10 medical technician, emergency medical technician, emergency  
11 medical responder, or other healthcare worker who is certified  
12 or licensed by the State.

13 "Emergency medical systems of care" means a fully  
14 integrated and cohesive statewide network of components that  
15 provide timely and effective care to individuals experiencing  
16 crisis situations. Components of an emergency medical systems  
17 of care include, but are not limited to, community-based  
18 services, pre-hospital care, emergency response, facility-based  
19 care, disaster response, and other post-hospital services that  
20 support stabilization, treatment, and transport.

21 "Emergency medical technician" means a person certified by  
22 the National Registry of Emergency Medical Technicians and

1 licensed by the State of Hawaii whose primary focus is to  
2 provide immediate lifesaving care to patients while ensuring  
3 access to the emergency medical systems of care.

4 "First responder personnel" means a person who [~~has~~  
5 ~~successfully completed a United States Department of~~  
6 ~~Transportation approved First Responder Course of training in~~  
7 ~~emergency basic life support.~~] provides initial assistance until  
8 emergency medical services personnel arrive.

9 "Medicom" means the emergency medical systems of care  
10 medical communications that monitor statewide resource  
11 availability, emergency dispatch, hospital notifications,  
12 interfacility transfers, and disaster communications.

13 "Medicom center" means the centralized coordination place  
14 for medicom functions.

15 "Paramedic" means a mobile intensive care technician who is  
16 an allied health professional certified by the National Registry  
17 of Emergency Medical Technicians whose primary focus is to  
18 provide advanced emergency medical care for critical and  
19 emergent patients who access the emergency medical systems of  
20 care.

21 "Service area" means the State, excluding any county having  
22 a population of five hundred thousand or more.

1 "State system" means the state [~~pre-hospital~~] emergency  
2 medical [~~services system~~] systems of care.

3 "Statewide" means all counties in the State."

4 SECTION 3. Section 321-223, Hawaii Revised Statutes, is  
5 amended to read as follows:

6 "**\$321-223 State emergency medical [~~services system~~]**  
7 **systems of care, establishment**. The department shall establish,  
8 administer, and maintain the state emergency medical [~~services~~  
9 ~~system~~] systems of care to serve the emergency health needs of  
10 the people in the service area. All emergency medical services  
11 or ambulance services contracted by or under the authority of  
12 the department or any county within the service area shall be  
13 consistent with this part."

14 SECTION 4. Section 321-224, Hawaii Revised Statutes, is  
15 amended by amending subsection (a) to read as follows:

16 "(a) In addition to other functions and duties assigned  
17 under this part, the department shall:

18 (1) Regulate ambulances and ambulance services statewide;

19 (2) Establish emergency medical services throughout the

20 service area, including emergency [~~aeromedical~~] air-

21 medical services, which shall meet the requirements of

22 this part, subject to section 321-228;

- 1           (3) Review and approve the curricula and syllabi of  
2           training courses offered to emergency medical services  
3           personnel statewide who provide basic, intermediate,

8           medical services training, regarding the training for

19          national disaster plans, and participation in  
20          exercises to test these plans;  
21          (6) Establish, administer, and maintain a communication

Oversee the development and implementation of a

consultation necessary for the implementation of this  
part, subject to section 321-230;

(9) Implement public information and education programs to  
inform the public of the statewide system and its use,  
and disseminate other emergency medical information,  
including appropriate methods of medical self-help and  
first-aid, and the availability of first-aid training  
programs statewide;

(10) Establish standards and provide training for  
dispatchers in the state system, and maintain a  
program of quality assurance for dispatch equipment  
and operations; provided that individuals acting as  
dispatchers in the State as of July 1, 2022, shall  
obtain emergency medical dispatch certification by

2           thereafter;
- 3           (11) Establish a program that will enable emergency service  
4           personnel statewide to provide early defibrillation;
- 5           (12) Establish [~~within the department the~~] and maintain

7           children statewide;
- 8           (13) Consult with the advisory [~~committee~~] council on  
9           matters relating to the implementation of this part;  
10          and
- 11          (14) Establish and maintain statewide standards for  
12          emergency medical services course instructor  
13          qualifications and statewide requirements for  
14          emergency medical services training facilities."

15          SECTION 5. Section 321-225, Hawaii Revised Statutes, is  
16          amended to read as follows:

17          "**§321-225 The [~~state~~] Hawaii emergency medical [~~services~~]**  
18          **systems advisory [~~committee~~] council.** (a) There is  
19          established within the department of health for administrative  
20          purposes only the [~~state~~] Hawaii emergency medical [~~services~~]  
21          systems advisory [~~committee~~] council, which shall sit in an  
22          advisory capacity to the department of health on all matters

1 relating to the state system. The advisory [~~committee~~] council  
2 may advise the department of health upon request of the  
3 department or upon its own initiative with regard to the state  
4 system. The advisory [~~committee~~] council shall:

5 (1) Monitor, review, and evaluate on an ongoing basis the  
6 operations, administration, and efficacy of the state  
7 system or any components thereof, to determine  
8 conformity with and maximum implementation of this  
9 part[~~-~~];

10 (2) Prepare and submit periodic assessments, reports, and  
11 other documents relating to the state system to ensure  
12 the implementation of this part, as deemed necessary  
13 or desirable in the discretion of the advisory  
14 [~~committee-~~] council;

15 (3) Seek the input of the public in relation to the state  
16 system to ensure adequate fulfillment of the emergency

21 regard to the state system, and seek the participation

8 of care, including medicom, the "911" system, and  
9 other components necessary to meet the emergency

19 experienced in the conduct and delivery of trauma or  
20 acute care services.

16 amended to read as follows:

17 "**§321-228 Emergency medical services; counties.** The  
18 department shall determine, in consultation with the advisory  
19 committee under section 321-225, the levels of emergency medical  
20 services that shall be implemented in each county within the  
21 state service area. The department may contract to provide  
22 emergency medical services, including emergency ~~[aeromedical]~~

1 air-medical services, or any necessary component of the  
2 emergency [~~services system of~~] medical systems of care within a  
3 county within the service area in conformance with the state  
4 system. If any county within the service area shall apply to

8 services. The department shall operate emergency medical  
9 ambulance services or contract with a private agency in those

19 **evaluation.** (a) The department may contract for technical  
20 assistance and consultation, including categorization, data  
21 collection, and evaluation appropriate to the needs of the  
22 statewide emergency medical [~~services system.~~] systems of

1 care. The collection and analysis of statewide emergency  
2 medical [~~services~~] systems of care data, including pediatrics,  
3 trauma, cardiac, stroke, burn, medical, and behavioral medical  
4 emergencies, shall be for the purpose of improving the quality  
5 of services provided.

6 The department may implement and maintain a trauma registry  
7 for the collection of information concerning the treatment of  
8 critical trauma patients at state designated trauma centers, and  
9 carry out a system for the management of that information. The  
10 system may provide for the recording of information concerning  
11 treatment received before and after a trauma patient's admission  
12 to a hospital or medical center. All state designated trauma  
13 centers shall submit to the department periodic reports of each  
14 patient treated for trauma in the state system in the manner as  
15 the department shall specify.

16 For the purposes of this subsection, "categorization" means  
17 systematic identification of the readiness and capabilities of  
18 hospitals and their staffs to adequately, expeditiously, and  
19 efficiently receive and treat emergency patients.

20 (b) The department shall establish, administer, and  
21 maintain an [~~aeromedical~~] emergency [~~medical~~] air-medical  
22 services system designed to collect and analyze data to measure

1 the efficiency and effectiveness of each phase of the statewide  
2 emergency [~~aeromedical~~] air-medical program.

3 The department shall monitor [~~aeromedical~~] air-medical  
4 emergency ambulance service flights statewide to include date of  
5 service, patient demographics, transport diagnosis, and medical  
6 outcomes. The department medicom center shall work with each  
7 air-medical service provider and health care facility as the  
8 intermediary to arrange emergency transport of [~~bariatric~~]  
9 patients by licensed air-medical service providers, or by the  
10 United States Coast Guard, and maintain a registry of all  
11 emergency transports provided [~~by the United States Coast~~  
12 ~~Guard~~]. All statewide [~~aeromedical~~] air-medical providers shall  
13 submit their data to the department as specified and requested  
14 by the department.

15 The statewide [~~aeromedical~~] emergency [~~medical~~] air-medical  
16 services system shall serve the emergency health needs of the  
17 people of the State by identifying:

- 18 (1) The system's strengths and weaknesses;
- 19 (2) The allocation of resources; and
- 20 (3) The development of [~~rotary-wing~~] emergency  
21 [~~aeromedical~~] air-medical services standards;

1 provided that emergency helicopter use, including triage  
2 protocols, shall be based on national [~~aeromedical~~] air-medical  
3 triage and transport guidelines established by the Association  
4 of Air Medical Services, the American College of Surgeons, the  
5 National Association of Emergency Medical Service Physicians, or  
6 other department-approved national [~~aeromedical~~] air-medical  
7 accreditation agency. The department, in the implementation of  
8 this subsection, shall plan, coordinate, and provide assistance  
9 to all entities and agencies, public and private, involved in  
10 the statewide system.

11 (c) The department shall use an emergency [~~aeromedical~~  
12 ~~services~~] air-medical quality improvement committee comprised of  
13 representatives of trauma, emergency, and tertiary care  
14 physicians and providers to analyze information collected from  
15 the [~~aeromedical~~] air-medical quality improvement performance  
16 measures as established by the [~~American College of Surgeons,~~  
17 department, and to recommend system standards and resources to  
18 maintain and improve [~~the~~] Hawaii emergency [~~aeromedical~~] air-  
19 medical services [~~system~~]."

20 SECTION 8. Statutory material to be repealed is bracketed  
21 and stricken. New statutory material is underscored.

22 SECTION 9. This Act shall take effect upon its approval.



JUSTIFICATION SHEET

DEPARTMENT: Health

TITLE: A BILL FOR AN ACT RELATING TO EMERGENCY MEDICAL SYSTEMS OF CARE.

PURPOSE: To update the wording of statutes governing the State's emergency medical services systems to use modern and consistent terminology.

MEANS: Amend sections 321-221, 321-222, 321-223, 321-224(a), 321-225, 321-228, and 321-230, Hawaii Revised Statutes.

JUSTIFICATION: Hawaii's emergency medical services (EMS) system has been instrumental in ensuring a degree of equity to critical health services for residents on all islands due to its comprehensive reach and 100 percent full-time professional staffing.

Technologies related to healthcare, communication, and transportation have evolved exponentially, but implementation has been uneven due to resource constraints and a cumbersome governance framework.

A comprehensive modernization of EMS-related statutes that aligns with national best practices and streamlines program governance is required to ensure that the State's EMS system is managed more strategically.

Impact on the public: Improved emergency medical services that better integrate with healthcare, social services, and other integrated community assets.

Impact on the department and other agencies: The Department will experience improved oversight, planning, and coordination of emergency services-related activities. County first responders will benefit from the improved flexibility to respond and

deploy new technologies consistent with  
national best practices.
