# A BILL FOR AN ACT

RELATING TO AGRICULTURE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that the State's  
2 agricultural lands, watersheds, and working landscapes are  
3 essential to the State's long-term food security, climate  
4 resilience, and environmental health. Farmers and land stewards  
5 face persistent barriers to adopt conservation agricultural  
6 practices including limited access to technical assistance,  
7 underinvestment in farm-level conservation infrastructure, and a  
8 lack of coordinated statewide support for soil health,  
9 regenerative agriculture, and climate-smart stewardship.

10       The legislature further finds that although federal  
11 conservation programs provide important resources nationally,  
12 many of these programs were developed for large-scale,  
13 continental agricultural systems and do not align well with  
14 Hawaii's small, diversified farms or Indigenous and community-  
15 based aina restoration practices. The United States Natural  
16 Resources Conservation Service's practice standards, timelines,  
17 and engineering requirements often reflect temperate-climate,



1 acreage-intensive farming models and can be difficult for the  
2 State's producers to access or implement within tropical  
3 agroecosystems, mixed land-tenure arrangements, and culturally  
4 grounded stewardship methods. As a result, Hawaii lacks a  
5 conservation agriculture support structure tailored to the  
6 State's unique ecological conditions, production systems, and  
7 aina-based restoration needs. While individual state-level  
8 programs currently offer elements of training, cost-share, and  
9 conservation support, Hawaii lacks a unified, statewide system  
10 that integrates conservation agriculture training, on-the-ground  
11 implementation, and infrastructure development. A coordinated  
12 statewide approach will strengthen environmental stewardship,  
13 expand local food production, reduce greenhouse gas emissions,  
14 improve soil and water health, and build long-term resilience in  
15 the State's food systems.

16 Accordingly, the purpose of this Act is to establish a  
17 conservation and agriculture environmental stewardship pilot  
18 program.

19 SECTION 2. Chapter 141, Hawaii Revised Statutes, is  
20 amended by adding a new section to be appropriately designated  
21 and to read as follows:



"§141- Conservation and agriculture environmental  
stewardship pilot program; established. (a) There is  
established within the department of agriculture and biosecurity  
a conservation and agriculture environmental stewardship pilot  
program to expand access to funding and technical assistance for  
training incentives, infrastructure support, and cost-share  
incentives for farmers, ranchers, land managers, and  
conservation partners with the goal of supporting agricultural  
production.

(b) The pilot program shall include but not be limited to:

(1) Training incentives and capacity building that shall  
include:

(A) Small stipends for farmers and stewards who  
complete conservation and planning trainings; and

(B) Workshops on topics including but not limited to,  
soil health, climate-smart agriculture,  
agroforestry, composting, water conservation, and  
farm planning;

(2) Stewardship implementation cost-share that provides:

(A) Direct support for implementing conservation  
practices, including but not limited to cover



cropping, soil amendments, erosion control,  
nutrient management, compost use, riparian  
buffers, and biodiversity improvement; and

(B) Cost-share availability to working farms,  
ranches, cooperatives, and community-based  
conservation partners; and

(3) Infrastructure development funding for small-scale  
conservation infrastructure, including but not limited  
to composting systems, improved irrigation efficiency,  
stormwater management features, equipment for soil  
health implementation, and other projects that advance  
regenerative practices.

(c) The department of agriculture and biosecurity may  
contract with or award grants to a nonprofit, or a consortium of  
nonprofits with experience in administering statewide food  
systems funds, agriculture and conservation cost-share programs,  
and delivering conservation agriculture training and technical  
assistance.

(d) Eligible participants shall include Hawaii-based  
farmers, ranchers, producers, landowners, cooperatives,



1 conservation organizations, community-based agriculture projects  
2 and aina restoration and stewardship organizations."

3 SECTION 3. The department of agriculture and biosecurity  
4 shall submit a report of its findings and recommendations,  
5 including any proposed legislation, to the legislature no later  
6 than twenty days prior to the convening of the regular session  
7 of 2027, regarding the conservation and agriculture  
8 environmental stewardship pilot program, which shall include:

9 (1) The number and types of participants;

10 (2) Acres and areas impacted by conservation  
11 implementation;

12 (3) Types of conservation practices funded and completed;

13 (4) Environmental, social, and cultural outcomes,  
14 including soil health improvements, compost use, water  
15 efficiency, and other documented benefits, community  
16 participation, education, and awareness about  
17 conservation and agriculture; and

18 (5) Recommendations regarding expansion, modification, or  
19 continuation of the program.



1       SECTION 4. The department of agriculture and biosecurity  
2 may adopt rules pursuant to chapter 91, Hawaii Revised Statutes,  
3 to effectuate the purposes of this Act.


4       SECTION 5. There is appropriated out of the general  
5 revenues of the State of Hawaii the sum of \$3,000,000 or so much  
6 thereof as may be necessary for fiscal year 2026-2027 to  
7 implement the conservation and agriculture environmental  
8 stewardship pilot program.

9       The sum appropriated shall be expended by the department of  
10 agriculture and biosecurity for the purposes of this Act.

11       SECTION 6. New statutory material is underscored.

12       SECTION 7. This Act shall take effect on July 1, 2026, and  
13 shall be repealed on June 30, 2028; provided that the department  
14 of agriculture and biosecurity shall retain the authority to  
15 complete reporting requirements and close-out activities.
