Madam and Sir:

Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2271, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT MAKING EMERGENCY APPROPRIATIONS FOR PUBLIC EMPLOYMENT COST ITEMS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to make emergency appropriations for collective bargaining cost items associated with grievances filed under agreements negotiated for the members of Bargaining Units 1 and 10, and their excluded counterparts, to resolve issues concerning temporary hazard pay for fiscal year 2025-2026.

Your Committee on Conference has amended this measure by:




- (1) Inserting the appropriate figures for fiscal year 2025-2026 based upon the amounts for Bargaining Units (1) and (10) and appropriate provisions as indicated in Governor's Message No. 8, dated April 23, 2026;
- (2) Changing the effective date to upon approval; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of H.B. No. 2271, H.D. 2, S.D. 1, as amended herein, and recommends that it pass Final Reading in the form attached hereto as H.B. No. 2271, H.D. 2, S.D. 1, C.D. 1.





