SUMMARY

Dr. Daniels is the Director of the Rehabilitation Counselor Education Program and professor at the University of Hawaii. She has been a counselor educator for over 34 years working in the areas of school, community, and rehabilitation counseling. She has held many leadership positions within the counseling profession and she is a Fellow of the American Counseling Association. She is a founding member of the American Counseling Association's (ACA) division of Counselors for Social Justice (CSJ) and a past president of CSJ. She was also elected to be the ACA Governing Council representative for CSJ (2012-2018). She has served as the Special Advisor to the ACA President on the Pandemic & Social Justice Concerns for the Governing Council (2020-2021) and has been the Parliamentarian (2018-2019) and Process Observer (2019-2020). Dr. Daniels was the Chair of the ACA Task Force on Climate Change and Mental Health and served on the New Professional/Early Career Issues taskforce. She has been the Co-Chair of the ACA taskforce on Professional Identity and Membership Employment, served as a member of the ACA Portability Task Force, and was the liaison to the ACA Human Rights Committee for 5 years. In the 1990's she was the president of the Hawaii ACA state

branches of AMCD and ACES and served on the board of Hawaii Counselors Association. Dr. Daniels has received numerous awards in the areas of teaching, research, and community service. During her career as a counselor educator, she has been recognized with national awards from the American Counseling Association (ACA) and in 2002 she received the prestigious ACA Wrenn award which is also referred to as the Counselor of the Year award. She has published over 50 articles/book chapters, several books, numerous other scholarly works, video's and counseling assessment instruments, and conducted over 100 national and international presentations. She has worked in both paid and volunteer capacities with, students in K- 12 schools; adolescents and families in community mental health agencies; adults in psychiatric rehabilitation counseling and addictions rehabilitation settings, and with chronically unemployed individuals on welfare. For over 15 years she has worked with student athletes and teams at the University of Hawaii. Currently she volunteers for Hawaii Fi Do an organization that trains and provides service dogs to persons with disabilities.

### TEACHING ENDEAVORS AT THE UNIVERSITY OF HAWAII

Qualitative teaching evaluations generally identify the following common themes: "Experienced, knowledgeable, sincere, compassionate, collaborative, prepared, available, approachable, enthusiastic, caring, flexible, inspirational, fair, confident, dedicated, organized, hands-on, focused, clear, capable, "punahele-favorite," open, global, fabulous, mentor, skillful, authentic, caring, supportive, motivated, and passionate."

From 1990-2008 I taught the following courses in the department of Counselor Education with a mean teaching evaluation of 4.7 on a 5 point scale: Counseling: Group theory and practice; Practicum in elementary school; Practicum in intermediate school; Practicum in high school; Internship in elementary school; Internship in intermediate school; Internship in high school; Counseling in schools; Seminar in school counseling; Problems of school adjustment; Contemporary Issues in Counseling: Conflict Resolution; Seminar in contemporary perspectives in Educational Psychology; Research; and Cross cultural counseling.

From 2008 to present an electronic evaluation system was implemented with poor student responses rates. Additional courses taught from 2008 to present include: Counseling theory and practice; Human growth and development across the lifespan; Case management; Vocational evaluation and assessment in rehabilitation; Medical and psychosocial aspects of disability; Seminar in rehabilitation counseling, and Career counseling.

Undergraduate courses taught include: Personal Health and Wellness; Life skills; and Psychosocial Aspect of Sport.
