

Aloha Chair Takayama, Vice-Chair Keohokapu-Loy and fellow committee members,

I am writing in strong support of House Bill 1452 on behalf of the Hawai'i State Lesbian, Gay, Bisexual, Transgender, Queer Plus (LGBTQ+) Commission, which was established by the 2022 Hawai'i State Legislature to

"improve the State's interface with members of the lesbian, gay, bisexual, transgender, queer, plus community; identify the short- and long-range needs of its members; and ensure that there is an effective means of researching, planning, and advocating for the equity of this population in all aspects of state government."

The Hawai'i State LGBTQ+ Commission submits this testimony in **strong support** of House Bill 1452, which expands the types of licensed health care providers authorized to submit an affidavit for the issuance of a new certificate of birth for certain registrants.

The Commission was established by the Hawai'i State Legislature to improve the State's interface with māhū and LGBTQIA+ communities and to advocate for equity across all aspects of state government. HB 1452 directly advances that mission by removing unnecessary administrative barriers that prevent transgender and gender-diverse people from obtaining identity documents that accurately reflect who they are.

Birth certificates are foundational documents. They are required for employment, education, housing, travel, healthcare, and countless routine interactions with government and private institutions. When a person's birth certificate does not align with their lived identity, it exposes them to discrimination, delays, and harm—often in moments when privacy and dignity should be respected.

Current limitations on who may provide an affidavit create inequitable access, particularly for individuals living in rural communities, those with limited financial resources, or those whose care is provided by qualified professionals outside of narrowly defined categories. HB 1452 addresses this gap by recognizing the full spectrum of licensed health care providers who are competent to attest to a person's gender-related care. This change reflects modern healthcare delivery and respects the professional judgment of providers who are already serving these communities.

Importantly, this bill does not lower standards or undermine the integrity of vital records. Instead, it streamlines an existing process in a way that is practical, medically sound, and rooted in respect for lived experience. It acknowledges that there is no single path or provider type that defines gender identity or gender-affirming care.

For māhū, transgender and gender non-confrming people—especially keiki, kūpuna, and those most vulnerable—having accurate identity documents can reduce harassment, improve safety, and support mental well-being. HB 1452 is a commonsense measure that affirms that government systems should work for the people they serve, not against them.



Testimony in Strong Support of House Bill 1452 Relating to Birth Certificates

Aloha Chair, Vice Chair, and esteemed Members of the Committee:

My name is Abby Simmons, Chair of the Stonewall Caucus of the Democratic Party of Hawai'i, and I am submitting testimony on behalf of our Caucus in **strong support of HB1452**.

HB1452 is a necessary and compassionate measure that modernizes Hawai'i's process for updating birth certificates so they reflect a person's authentic gender identity. This bill is fundamentally about dignity, safety, and equal treatment under the law.

For transgender and gender-diverse people, having identity documents that do not match who they are creates real and lasting harm. This bill is therefore not only a matter of civil rights — it is also a matter of public health and community well-being.

Importantly, HB1452 does not harm anyone else. It does not infringe on the rights of others, alter existing records inappropriately, or compromise public systems. It simply ensures that

Thank you for the opportunity to testify in strong support of HB1452, legislation that would allow transgender and gender-diverse people to update the sex designation on their birth certificates in a way that affirms their authentic selves.

This bill is about dignity, inclusion, and equity. Today, too many transgender people in Hawai‘i still struggle with outdated policies that make it difficult, if not impossible, to have a birth certificate that reflects their lived gender. Modernizing this process honors the lived experiences of transgender residents and aligns Hawai‘i with best practices nationwide.

Under current law, some transgender people have faced requirements that are unnecessary barriers, such as invasive medical or surgical conditions, simply to update a vital identity document. These requirements are not grounded in current medical science or the lived realities of transgender individuals, many of whom cannot or choose not to undergo such interventions.

Hawai‘i Health & Harm Reduction Center (HHHRC) strongly supports HB 1452, which adds advanced practice registered nurses (APRNs) to the list of health care providers who can submit an affidavit for a new birth certificate.

This bill is needed to expand the opportunities for trans persons to obtain birth certificates that comport with their gender identity. HHHRC has APRN’s on staff who serve members of our island’s trans community.

As noted by a recent opinion article in the *American Journal of Public Health*, “LGBTQ public health is public health. It embodies the field’s most notable principles: evidence guided by empathy, science grounded in justice, and policy shaped by humanity. To marginalize it is to misunderstand what public health is meant to be. In this moment—when the rights and health of LGBTQ people are under [attack—] the stakes could not be higher.” (Halkitis PN, Krause KD. LGBTQ Public Health Is Public Health: Advancing Equity When Institutions Falter. *Am J Public Health*. 2026 Feb;116(2):159-161.)

In contrast to the oppositional posture of the current federal government and other state governments, Hawai‘i should continue to ensure that trans persons and other sexual and gender minorities are able to access needed care and social services and participate fully in civic and economic life.

HHHRC’s mission is to reduce harm, promote health, create wellness, and fight stigma in Hawai‘i and the Pacific. We work with many individuals impacted by poverty, housing instability, and other social determinants of health. Many have behavioral health problems, including those related to substance use and mental health conditions, and have also been deeply impacted by trauma related to histories of physical, sexual, and psychological abuse.

We are an officially recognized constituency group of the AFL-CIO that organizes mutual support between the organized Labor Movement and the LGBTQIA+ Community to further social and economic justice. We write in **strong support of House Bill 1452**.

HB 1452 makes a necessary and thoughtful update to Hawai'i law by expanding the types of licensed health care providers who may submit an affidavit for the issuance of a new certificate of birth for certain registrants. This change ensures that transgender and gender-diverse people can access accurate identity documents through a process that reflects modern medical practice and lived reality—rather than outdated assumptions or unnecessary gatekeeping.

Accurate identity documents are essential to navigating everyday life. When a birth certificate does not align with a person's sex designation, it can expose them to repeated scrutiny, discrimination, and forced disclosure in settings such as employment, housing, education, travel, and health care. These barriers place transgender people—especially workers—at heightened risk of harassment and economic insecurity.

Current limitations on who may submit the required affidavit are arbitrary and harmful. They restrict access based on provider type rather than professional competence, disproportionately impacting people in rural communities, those with limited provider options, and those whose care is managed by fully licensed professionals who are excluded under existing law. HB 1452 removes these barriers without compromising the integrity of Hawai'i's vital records system.

This legislation is especially urgent **now**. At the federal level, **H.R. 22, the SAVE Act, continues to advance**, threatening to impose restrictive documentation requirements that would disproportionately harm transgender people and others whose identity documents do not align due to systemic barriers. Alarmingly, **Hawai'i's own Congressman Ed Case voted in favor of this measure**, underscoring the real and present risk that federal actions may further marginalize our communities.

Aloha Chair Takayama, Vice-Chair Keohokapu-Lee Loy and fellow committee members,

This testimony on behalf of **HOKU PAC**, Hawai'i's LGBTQ+ political action committee dedicated to building queer political power and advancing policies that protect our communities. We stand in **strong support of House Bill 1452**.

HB 1452 takes an important and necessary step to modernize Hawai'i's process for issuing updated birth certificates by expanding the types of licensed health care providers who may submit an affidavit for certain birth registrants. This change removes unnecessary and outdated barriers that prevent māhū, transgender and gender-diverse people from obtaining identity documents that accurately reflect who they are.

Accurate identity documents are not a luxury—they are essential to safety, stability, and full participation in public life. When a person's birth certificate does not align with their sex designation, they may be subjected to repeated questioning, forced disclosure, and discrimination in employment, housing, education, travel, and health care. These harms fall disproportionately on māhū and transgender people and create real risks to economic security and personal safety.

Existing restrictions on who may provide the required affidavit serve no legitimate purpose. They limit access based on provider category rather than medical competence, creating inequities for people in rural areas, those with limited health care options, and individuals receiving care from fully licensed providers excluded under current law. HB1452 corrects this by aligning state policy with modern medical practice while preserving the integrity of Hawai'i's vital records system.

The need for this bill is **more urgent than ever**. At the federal level, **H.R. 22, the SAVE Act, continues to move forward**, threatening to impose restrictive documentation requirements that would disproportionately harm māhū and transgender people and others whose identity documents do not align due to systemic barriers. It is deeply concerning that **Hawai'i's own Congressman Ed Case voted in favor of this legislation**, underscoring that federal protections cannot be assumed.

In this moment, Hawai'i must lead. HB 1452 provides a critical state-level safeguard, ensuring that residents can obtain accurate identity documents that allow them to live, work, vote, and access services without fear of unnecessary exposure or discrimination.

Aloha e Chair Takayama, Vice Chair Keohokapu-Lee Loy, and Members of the Committee,

Lambda Law Student Association of Hawai'i is a Registered Independent Organization at UH Mānoa's William S. Richardson School of Law. **We support HB1452**, and offer the following suggestions/comments.

We appreciate the intent to ensure access to amended birth certificates for transgender individuals, particularly in the current climate of heightened uncertainty surrounding gender-affirming documentation. In recent years, transgender people have faced increased scrutiny, inconsistent agency practices, and shifting legal standards related to identity documents. These inconsistencies create tangible barriers to daily life (such as obtaining employment, housing, health care, education, and travel), and increase the risk of discrimination, harassment, or denial of services when identity documents do not accurately reflect a person's gender. **Clear, inclusive statutory language governing birth certificate amendments is therefore essential not only for administrative efficiency, but also for ensuring equal access to legal recognition, personal safety, and full participation in civic life.** In reviewing the language of the proposed bill, our members identified concerning language that could lead to problems in implementation and a fundamental misunderstanding of the medical science on transgender people and the process of transitioning.

We suggest that the bill language should be changed to address:

- The named process in subsection (a) (1) of **“paternity” should properly be changed to “parentage,”** in order to be aligned with the passage of the amendments to the Uniform Parentage Act passed in the 2025 session ([Act 298](#)).
- The phrase **“completed transition to the new gender” in subsection (a) (4) (C) is imprecise and potentially harmful language** that fails to include the range of experiences and medical interventions sought after by transgender patients. Per a Senate Committee report from the legislative history of this statute, **“the majority of transgender individuals do not choose to undergo sex reassignment surgeries for various reasons, including prohibitive costs and other medical and personal reasons.”** [SCR1524](#) of 2015. This conclusion is consistent with prevailing medical evidence. Major medical organizations, including the American Medical Association and the American Psychiatric Association, recognize that **gender transition is not a single, finite process and does not require any particular surgical procedure to be considered medically appropriate or complete.** Clinical guidelines emphasize that transition-related care is individualized and may include social transition, hormone therapy, counseling, or other treatments, depending on the patient's needs and circumstances. No recognized medical authority defines “completion” of gender transition as a prerequisite for legal recognition. **We suggest striking the end of this clause entirely, so that subsection (a) (4) (C) would read, “The birth registrant has had appropriate clinical treatment for gender transition”.**

- While we appreciate adding that Advanced Practice Registered Nurses (APRNs) to the list of medical professionals authorized to issue necessary affidavits, we would love to see this section also include any “licensed mental health provider” so as to increase accessibility, as per suggestions from past Representatives that worked on amending this bill in previous years. See [SCR572](#) of 2015.

We humbly ask that you please support HB1452 and consider our suggested changes. Mahalo nui for the opportunity to testify.

I am weighing in on this bill to remind Committee Members that Birth Certificates need to be updated for a variety of reasons, some common and some less common, but deserve equal consideration and support to make the process as pain-free as possible. At the beginning of this month, we had to amend the birth certificate of the baby I recently birthed to remove me as his mom, as I am not in any way related to him. I wish this could have taken place at the hospital immediately after birth, but due to the policies in place I had to be added to his birth certificate initially and then we had to go through court to remove me. This process took about 5 months to complete. Neither me, nor my husband, nor the baby's parent and provider of DNA were in any sort of disagreement that we wanted this change to happen. Even with a straight forward (non-contested) case like this, it was complicated and time consuming.

I am strongly in favor of allowing APRNs to participate in this process to help create a quicker, easier, and less invasive process to amend birth certificates for those who need to amend them. My name is Danielle Lum, a resident of Honolulu, and I am representing myself. My testimony is in support of HB1452.

It is of utmost importance for a transgender person to have their birth certificate match their gender identity. The list of reasons is long, but since this legislation is about who can attest to a person being transgender I will limit my remarks to that subject.

I am a pediatrician and have practiced for 40 years. For most of that time I have had an advanced practice registered nurse (APRN) working in my office. More recently I have also had PAs working in my office. I can tell you that both APRNs and PAs are highly skilled and can do many of the things that a physician can do, including the diagnosis of gender dysphoria.

Both PAs and APRNs have advanced degrees and at a minimum, 6-8 years of training. They often function in similar roles in various healthcare settings. Given that PAs already have the authority to attest to a person's gender dysphoria (for the purpose of changing a birth certificate), it is logical that APRNs should have that same authority.

Moreover, APRNs can and do function independently in Hawai'i, whereas PAs cannot. In some rural parts of our state, the APRN may be the only provider for that area. Allowing APRNs to have this authority will provide better access to this necessary care for transgender individuals.

It is critical that all people have access to all the health care services that they need, and APRNs are not only fully capable of providing care but also may be the only source of care. These are the reasons that I support HB1452.

The current law in Hawai‘i allows transgender people to change their gender marker on their birth certificate with a form signed by a doctor or physician assistant, but NOT nurse practitioners. I believe this was an oversight that HB1452 can correct.

As a primary care Nurse Practitioner, I take care of patients all day. I prescribe medications, order labs and imaging testing, refer to specialists, and sign death certificates. This is called "Full Practice Authority." In Hawai‘i, nurse practitioners have had full practice authority since 1995. Because of this, I do not need a medical doctor in order to care for my patients. No one co-signs my charts or oversees my patient care. I am fully responsible for my patients' medical treatment.

I am writing in strong support of HB1452, a bill to expand the types of providers who can submit an affidavit for a new birth certificate.

Since 1995 APRNs, advanced practice nurse practitioners, have had full practice authority in Hawai'i. Unfortunately, under current law their patients need to have a physician or physician assistant complete the affidavit to amend the gender marker on the patient's birth certificate.

This bill, HB1452, would address that oversight and allow APRNs to submit the affidavit themselves, no longer requiring someone else (often outside of the practice) to involve themselves in a patient's care. This would make the process easier and quicker for those trying to amend their birth certificate's that are under the care of an APRN.

Thank you for the opportunity to testify in support of HB1452.

The current law in Hawai'i allows transgender individuals to change their gender marker on their birth certificates with a form signed by physicians or physician associates (PAs), but NOT by advanced practice registered nurses (APRNs). APRNs include nurse practitioners (NPs), clinical nurse specialists (CNSs), certified nurse midwives (CNMs), and certified registered nurse anesthetists (CRNAs), and they play an essential role in healthcare systems. According to the Hawai'i State Center for Nursing, there are 1,545 licensed APRNs in our state.

In Hawai'i, Advanced Practice Registered Nurses (APRNs) are licensed to practice independently and serve a vital role in addressing physician shortages, which have worsened in recent years. This is especially critical in rural communities, where shortages of primary care providers and specialists are more severe. I can attest to this through my firsthand experience serving as a nurse practitioner at a federally qualified health center in West Oahu for the past 10 years. Therefore, APRNs should be included in the law to allow them to provide the Affidavit needed for gender marker changes, as well as their physician and PA colleagues.

My name is Dr Matthew Mitschele. I am a husband, father of four and family physician here in the great state of Hawai'i. I decided to submit testimony not in an attempt to change anyone's mind or preach about my personal beliefs on the matter, but rather to share how I came to providing gender affirming care and how that relates to your decision.

I had no prior formal training in gender affirming care. I can't imagine the topic was ever brought up in the 7 years of my medical training. I also had no personal experience with friends or family. My only passing experience was like many, through crass depictions and jokes of transgender persons in movies and TV. I only entered into this space through the bravery of my patients. Patients who had the courage to share their life's story to someone they did not know. A doctor they had no relationship with, a stranger. A 6'2", white, cisgender male. It still shocks me that they would take that leap of faith.

During that first patient visit I had a choice. Looking across at another human being who is telling me their life story, their truth. Do you stand as a barrier or obstruction to their hopes of living their full life or do you help. That is the power held by health care providers. Even in inaction you hold great power over others. And that is the power of the State. You hold great power whether it be by action or inaction. You can be a barrier or obstruction to someone living their full life and truth or an ally. So I ask you to be mindful of that power over another human being's feelings of completeness and acceptance.
