

- 1    **Fiscal Implications:** The Department of Health requests that this measure be considered as a vehicle to provide the needed funding, provided it does not supplant the priorities and requests outlined in the Governor's Executive Budget. Additionally, we emphasize the importance of securing a funding source to support integration into the Emergency Medical Service (EMS) Computer-Aided Dispatch (CAD) system and the EMS electronic Patient Care Record (ePCR) system, with estimated costs of \$500,000 for implementation and \$200,000 annually for subscriptions.
- 8    **Department Position:** The Department of Health supports this measure offering comments and proposed amendments.
- 10    **Department Testimony:** The Emergency Medical Services & Injury Prevention System Branch (EMSIPSB) provides the following testimony on behalf of the Department of Health.
- 12    We support the intent of this measure to enhance emergency response capabilities and improve public safety. However, we respectfully offer the following considerations to ensure successful implementation and minimize potential risks.
- 15    The proposed statewide safety profile system must be fully integrated with the State of Hawaii, Department of Health Emergency Medical Services dispatch system, Medical Communication

1 System (MEDICOM), and the EMS electronic ePCR systems currently in use. Without seamless  
2 integration, critical patient information may not be readily available to EMS providers during  
3 emergencies, creating liability concerns for the State and potentially compromising patient  
4 care.

5 Integration should ensure real-time data availability for EMS Dispatch, Emergency Medical  
6 Technicians (EMTs), Paramedics/Mobile Intensive Care Technicians (MICTs), and EMS medical  
7 direction at the point of care. The system must comply with national public safety and  
8 cybersecurity standards to protect sensitive health information. Additionally, there should be  
9 end-to-end integration for EMS Public Safety Answering Points (PSAP), including both primary  
10 PSAP and secondary EMS PSAP, to CAD and ePCR systems, ensuring seamless information flow  
11 across platforms.

12 The bill should also clarify responsibility for integration costs with existing Department of  
13 Health EMS, CAD, MEDICOM, and ePCR systems. The Department of Health, in partnership with  
14 the 911 Board, should lead project integration into the EMS CAD, MEDICOM, and ePCR system,  
15 including vendor coordination, and ongoing maintenance. These details are critical to avoid  
16 unfunded mandates and ensure accountability, while maintaining compliance with 911 patient  
17 care and EMS regulatory data standards.

18 We strongly support the inclusion of public education and outreach, particularly for kūpuna and  
19 individuals with disabilities or functional needs, to maximize participation and effectiveness.  
20 The system should incorporate Advance Directives (including medical orders not to treat) into  
21 the safety profile system to support patient autonomy and clinical decision-making during  
22 emergencies.

23 Finally, we recommend that this measure be amended to include explicit indemnification and  
24 liability protections for participating entities and emergency care providers



#### House Bill 1577 – Relating to 911 Services

The Disability and Communication Access Board (DCAB) supports the intent of House Bill 1577 – Relating to 911 Services. This bill requires the 911 Board to establish, implement, and maintain a statewide emergency safety profile system that allows residents to voluntarily create and manage secure personal profiles containing information relevant to emergency responses.

DCAB values the privacy of sensitive information especially disclosure of a disability, medical or health conditions. There is concern regarding how long the information stays stored in the application, who has access to the information, and what preventive measures are taken to secure the information. Should the 911 Board contract with a vendor, we request the vendor ensures their application meets the accessibility requirements for people with disabilities.

- 3 **Purpose:** The purpose of this bill is to require a statewide, voluntary safety profile system like
- 4 Smart911 to be integrated into Hawaii's 911 services. SMART911 is a free, voluntary based,
- 5 secure service that allows users to create a personal profile to significantly improve emergency
- 6 response. This person-centered system is particularly valuable for people with disabilities or
- 7 dementia. Smart911 profiles can highlight health conditions, communication preferences,
- 8 mobility constraints, cognitive impairment, medications, behavioral triggers, sensory sensitivities
- 9 and more. Providing this critical information in advance gives first responders the context
- 10 needed to respond quickly, safely, and compassionately.

- 1        During disasters, SMART911 can save lives and help emergency managers identify
- 2        vulnerable individuals who may need extra assistance. Smart911 strengthens public safety by
- 3        enabling faster, more informed, and more person-centered emergency response across the state.

**SUBJECT: HB1577 Relating to 911 Services**

The Hawai'i Self-Advocacy Advisory Council strongly supports HB1577.

This bill would require the 911 Board to create and maintain a statewide system where people can voluntarily set up a secure emergency safety profile. These profiles would let residents share important personal, medical, or accessibility information that could help during an emergency.

HB1577 would help 911 dispatchers and first responders get the information they need right when someone calls for help. This could include details about a person's mobility, how they communicate, medical conditions, or any support they rely on. Having this information ahead of time helps responders prepare before they arrive.

Emergency situations can be especially risky for people with intellectual or developmental disabilities and others with access or functional needs. Without the right information, misunderstandings or unmet medical needs can make emergencies worse and may even lead to unnecessary harm or trauma.

By giving dispatchers access to information that people choose to share, HB1577 supports safer, more effective, and more respectful emergency responses. Responders can communicate better, adjust their approach, and support people in a way that honors their needs and dignity.

This bill also promotes disability inclusion. It recognizes that emergency response should not be one-size-fits-all. People with disabilities are better served when systems are designed to understand and accommodate their needs from the start.

For these reasons, the Hawai‘i Self Advocacy Advisory Council urges strong support for HB1577.

As a mother, a Special Olympics team leader, and the manager of a home for young adults with Intellectual disabilities, I strongly support the passage of HB1577. It will save lives.

People with Intellectual Disabilities are more likely to have significant medical, mental or physical concerns that set them apart from the general population in the care they require. Certainly in an emergency they would not be able to convey these to responders. Even the caretakers present might not be able to report the full scope of issues the person in need faces.

Sometimes the caregiver will have on hand a written report of the needs of the person in their charge. But I have witnessed an incident in which it took several precious minutes, in a life or death emergency, for the paper to be located. It took additional time for the responders to search the paper for the specific information they needed. HB1577 would eliminate this wasted time by making information instantly available to responders in a uniform fashion, so they would be able to access needed information and start treatment immediately. In cases where time is of the essence, this efficiency would save lives.
