Purpose of Bill: Appropriates funds to the Department of Education to support community schools.

Department's Position:

The Hawai'i State Department of Education (Department) supports HB 1896, provided its passage does not adversely impact the priorities established in the Board of Education's approved budget.

The Department recognizes community schools as one of several effective strategies for fostering community and family engagement. Currently, these programs exist in approximately 22 Department schools. These models are established at the discretion of individual campuses, as school leaders are best positioned to identify the specific resources and partnerships necessary to support their unique student populations. Community schools adopt a "whole child" approach, integrating high-quality educational opportunities with robust community partnerships. Successful implementation relies on the synergy between school staff, families, and local stakeholders. These relationships not only enrich the academic experience but also strengthen the surrounding community.

Should the Legislature be inclined to pass this measure, we respectfully request that it supplement, rather than displace, existing departmental priorities. Thank you for the opportunity to provide testimony.

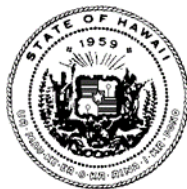
Chair Woodson, Vice Chair La Chica, and Members of the Committee:

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of the measure, defers to the Department of Education, and provides comments. DHS respectfully requests that any appropriation not reduce or replace priorities identified in the executive budget.

DHS shares the same vision through school-based family resource centers, a component of community schools. Community schools build trusted relationships with students and families that improve student achievement, and well-resourced family resource centers have been shown to reduce reports of child abuse and neglect.

Family resource centers use a multigenerational, strengths-based, and family-centered approach. Families may access services in a place they are comfortable in that reflects and is responsive to the community's needs and interests. Services are generally at no or low cost and aim to build communities of peer support and increase social connections. Schools, families, and communities benefit from these models that support student learning, reduce chronic absenteeism, and strengthen communities.

Dear Chair Woodson, Vice Chair La Chica, and Members of the Committee,

I am writing to you today as the Principal of Waikoloa Elementary and Middle School to express my strong support for HB 1896, which seeks to appropriate funds to the Department of Education for the implementation and sustainability of community schools in Hawaii, provided its passage does not adversely impact the priorities established in the Board of Education's approved budget.

At Waikoloa, we see firsthand that a student's success is inextricably linked to their health, well-being, and sense of belonging within their community and 'aina. HB 1896 recognizes that schools are more than just academic centers; they are hubs where staff, families, and community partners work in reciprocity to help every child thrive.

The community schools strategy outlined in this bill is vital for several reasons:

- **Integrated Support Systems:** It moves us away from fragmented services and toward a coordinated effort that leverages existing community resources toward shared goals.
 - At Waikoloa this has meant coordinating many efforts to increase student attendance and overall success including: Food Basket distribution for our families in need, School Based Health Center mobile unit so that students can get the medical care that they need while at school to break down transportation barriers, weekly visits to our low income housing sites with our Bilingual School Home Assistant to engage with families and build a bridge between home and school, and so much more.
 - On the other side of the spectrum, our community coordinator has been vital is our ability to put on an Amazing Shake competition where community partners work with us to improve students' professional skills like poise under pressure, the ability to think on their feet, be problem solvers and so much more. This has provided opportunities for some of our students to compete on the global level in Atlanta, GA. For some of them, it was their first trip outside the state of Hawaii. This could not have been possible without the support and organization of our community coordinator.
- **Addressing Chronic Absenteeism:** By fostering stable relationships and meaningful family engagement, this approach creates the necessary conditions for learning and directly addresses the root causes of barriers to attendance. We began implementing the

community school strategy three years ago and it has helped us to reduce our chronic absenteeism rate from 41% to 32%.

- **Proven Return on Investment:** Research cited in this bill shows that for every dollar invested in a community school coordinator, there is a return of approximately \$7.11 in net benefits. I personally visited the New Mexico school district to learn more about how to make this successful in Waikoloa and came back with many ideas which have helped our school to make improvements and allowed us to engage with 90% of our families last school year.
- **Collaborative Leadership:** This bill empowers families and students as co-designers of solutions, ensuring that our school culture is built on trust and shared power.

The appropriation of **\$2,152,500** for fiscal year 2026-2027 will provide the technical assistance, evaluation, and administrative support necessary to make this vision a reality across our islands. This investment will yield long-term dividends in the form of higher graduation rates, increased teacher retention, and improved academic achievement.

I respectfully urge your committee to pass HB 1896 to ensure our schools have the tools to support the "whole child" and strengthen the fabric of our communities.

The Hawai'i Afterschool Alliance supports HB1896, which would appropriate funds to the Department of Education for community schools.

In Hawai'i, a community school is a place where school staff, families, students, and the community work together to help every child thrive.

Community schools are a proven, time-tested strategy that can bring forth short-term results like improving family engagement and attendance and decreasing behavioral referrals. It is also proven to show long-term results like closing the achievement gap, improving academic scores, and graduation rates.¹

There are currently 22 community schools in Hawai'i across three islands that are mobilizing their community partners, families, students, and school staff to ensure that all students thrive in their school community. Each school has a Community School Coordinator who facilitates the co-creation of innovative strategies and is building a system of support to address the barriers students and families face. These innovative strategies fall under the following key practices:

- Collaborative leadership, shared power, and voice;
- Expanded, enriched learning opportunities;
- Rigorous, community-connected classroom instruction;
- Culture of belonging, safety, and care;
- Powerful family and student engagement; and
- Integrated systems of support.²

The needs and assets assessments completed by our current Community School Coordinators reveal the deep need to have more resources and support organized to address our students'

HOUSE BILL 1896, RELATING TO COMMUNITY SCHOOLS

FEBRUARY 17, 2026 · EDN HEARING

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus supports HB 1896, relating to community schools, which appropriates funds to the Department of Education to support community schools.

Policymakers should promote education programs that deliver wraparound care for students and deal with educational “inputs” that impact student success, like poverty and access to healthcare. An example of such a program is the community schools model of education, which as noted in Hawai'i's Consolidated State Plan under the Every Student Succeeds Act, is a research-based strategy for school improvement that emphasizes high-quality teaching, culturally relevant curricula, wraparound student supports, positive disciplinary practices and restorative justice, parent and community engagement, and inclusive school leadership.

In prioritizing student wellness, community schools have been shown to increase learning growth and graduation rates, while decreasing behavioral referrals and chronic absenteeism. In New York City, for example, community schools that highlight mental health counseling and consistent family outreach have seen chronic absenteeism rates fall by 7.8 percent as of 2017, with graduation rates rising 4.8 percent. Engaged learners are more like to acquire the skills necessary to become active citizens and productive members of the workforce. Additionally, since even the

most affluent and well-adjusted children face challenges in their maturation processes, guaranteeing that schools have the resources to respond to childhood pressures and trauma with compassion and sensitivity may make the difference between sending a student to college or losing them to social threats, like substance abuse or our state's prolific sex trade.

As the National Education Association states, "Community Schools transform traditional public schools into neighborhood hubs that mobilize students, staff, families and community members to reimagine education and co-construct a shared vision for their school and community. Community Schools are developed with the understanding that every community is different." Community schools rely on integrated student supports, expanded and enriched learning opportunities, active family and community engagement, and collaborative leadership to strengthen educational outcomes. Currently, 25 community schools exist in our state.

Dear Chair Todd, Vice Chair Takenouchi, and members of the Committee,

I am writing in strong support of HB 1896. I serve as the Executive Director of Ceeds of Peace, the lead agency for seven community schools in Hawai‘i. This bill would appropriately fund the Department of Education to sustain and strengthen the community schools framework that is transforming outcomes for our keiki and their families.

Community schools matter deeply to me because I have seen firsthand how they change the trajectory of entire neighborhoods. In the communities we serve — many of which face high poverty rates, housing instability, and limited access to healthcare — schools are often the most trusted and consistent institutions. Through the community schools model, we coordinate academic supports, afterschool enrichment, family engagement, food access, mental health services, and health partnerships directly on campus.

Community schools are not an add-on program. They are an organizing strategy that aligns public and private resources around student success. Without sustained funding, schools lose coordinators, partnerships weaken, and momentum stalls. We have also built strong partnerships that directly support our families. In partnership with 'Elepaio Social Services, families went home with over 50 pounds of groceries in December and enjoyed a free dinner prepared by the Wai‘anae High School Culinary Program. Through our partnership with Kamehameha Schools Community Learning Centers, ‘ohana receive five pounds of kalo and are able to ku‘i together, strengthening connections to one another and to Hawaiian culture. These events do more than provide resources — they build relationships, community pride, and cultural connection.

Additionally, as a Community School, we provide hygiene items, household essentials, school supplies, and backpacks to students whenever there is a need. These supports remove barriers to learning and allow our students to come to school ready to focus and succeed.

Our school has worked tirelessly to raise achievement, build trust with families, support student mental health, and create safe, engaging learning environments. But we cannot maintain — let alone expand — these critical services when funding is removed the moment progress is made.

I, Dr. Beth King, the community school coordinator at the Hawaii School for the Deaf and Blind supports HB 1896 which would appropriate funds to the Department of Education for community schools.

Passing this bill will help the Hawaii School for the Deaf reach the families who are raising Deaf and hard of hearing keiki across the State. On each island there are individual programs and placements for parents to choose in order to match an educational practice or mode with the unique needs of children with hearing loss; however, there is no community based support that truly educates parents at all stages on the knowledge needed, nor provides all the resources available at the national, state and county level directly to the families in a manner that is received with grace, respect and empathy to bilingual bicultural needs of our diverse community. Community Schools now have the

potential to connect American Sign Language instructors, Deaf advocacy groups, local Deaf community based social groups and leaders in a dual-capacity framework that values the input and encourages the participation of parents to an elevated degree that what has occurred prior. Community Schools in the fine thread that tightens the gap between family needs and effective support. Passing this bill can finally address the limits of language deprivation to which deaf keiki suffer when born into families that have no access to sign language nor those competent in this mode of communication. Community School programs can also aim to address the need to “grow our own ASL interpreters” by connecting the caregivers and family members of Deaf children to engage in potential work related professions that surround dDeaf citizens.



In the small community of Naʻalehu, with a population of approximately 900 people, sits a small elementary school serving about 420 students in grades pre-K through sixth. Naʻalehu School is located in the Kaʻū district, which spans 922 square miles. The distance from one end of the district to the other is 53 miles and takes nearly an hour to drive.

Many of our students make this commute to school every single day. Some must rely on family members or friends just to reach their bus stop, which can be up to five miles from their home—before they even begin their bus ride to school. On many mornings, temperatures are in the 50s, requiring students to wear extra layers just to stay warm. All of this happens before our students even begin their school day and their learning.

Being a community school allows our students to thrive because the community comes together to support them. Community partners play a vital role in our students' success. They help organize carpools so students can get safely to their bus stops. They provide resources for students and families, such as thrift closets for children who forget a jacket or lose their slippers on the way to school. Food donation services support families experiencing food insecurity, ensuring students can focus on learning rather than hunger.

Our family resource center offers families a place to seek assistance, access needed resources, and participate in family-strengthening classes. Students also benefit from additional learning opportunities both in school and throughout the community that promote wellbeing, foster a strong sense of belonging, and help students feel confident and valued.

Most importantly, these opportunities help our students learn about Hawaiʻi, Hawaiian culture, and the place they call home. Community schools do more than educate—they uplift entire communities. At Naʻalehu School, the community school model ensures that despite distance, geography, and challenges, our students are supported, cared for, and given every opportunity to succeed.


