

### **HB1934 – Relating to Libraries**

The Hawai'i State Public Library System (HSPLS) **supports the intent** of H.B. 1934 to require the State Librarian to establish an Imagination Library of Hawai'i Program to provide one free book each month to children from birth through five years of age who reside in the State.

Currently, Hawai'i has an affiliate program of Dolly Parton's Imagination Library called 'Ohana Readers. Hawai'i's former first lady Dawn Amano-Ige, in partnership with state and non-profit partners, launched the program on Moloka'i on October 19, 2019. Since then the program has expanded to 10 additional zip codes on Kaua'i, Lāna'i, Maui and Hawai'i Island. Families are encouraged to enroll their newborn to five-year-old children at their local public library. The program encourages children to develop a love of reading by building their own library of books at home.

The expansion of this program statewide is an investment that will help improve literacy starting with our youngest readers. To ensure the success of this ongoing literacy initiative, the program will need a consistent and sustained source of funding.

We respectfully request the Legislature's support for:

- Full State funding in the first two years of the program, and in years three to five of the program, State funding could be reduced on a sliding scale to no less than 50% of the estimated total cost in the fifth and subsequent years of the program. The funding may also be utilized for administrative costs incurred by the non-profit organization to establish and maintain the program. Full funding in the first two years will provide sufficient time for a non-profit to develop community awareness and identify long-term funding strategies to ensure future sustainability of the program; and
- One permanent position for HSPLS to coordinate and manage the statewide program in conjunction with the non-profit organization.

We note that at this time, current fundraising by the Friends of the Library of Hawai'i supports a variety of statewide HSPLS programs, including the annual Summer Reading Program. HSPLS would have concerns if fundraising for the Imagination Library to address the reduced State match in future years were to impact fundraising that supports HSPLS programs.

With the support of the Legislature, this program could help create a Hawai'i where every child grows up reading books from their first library at home and being prepared to learn when they enter school. This program will help to build pathways to that future.

Aloha Chair Woodson, Vice Chair La Chica, and Members of the Committee,

Friends of the Library of Hawai‘i (FLH) **supports** HB1934 with requested amendments. FLH strongly supports the intent of the bill to establish statewide access to Dolly Parton’s Imagination Library. This proven early literacy program provides matching funds to deliver high-quality, age-appropriate books to children each month from birth to age five, helping families build home libraries and support early childhood learning. The program operates through affiliate partners who enroll families and enhance the impact of each book through programming and other educational opportunities.

Friends of the Library of Hawai‘i currently serves as the nonprofit administrator of the ‘Ohana Readers affiliate. ‘Ohana Readers was established in 2019 by the Office of the Governor under then First Lady Dawn Amano-Ige, in partnership with the Hawai‘i State Public Library System with funding from the Learning to Grow program of the University of Hawai‘i Center on the Family and the Hawai‘i Department of Human Services. Our affiliate later expanded to include a hui of funders and community partners. Our affiliate currently serves the islands of Moloka‘i and Lāna‘i, the west and north communities of Kaua‘i, the Ka‘ū region of Hawai‘i, and Hāna on Maui, focusing on rural and underserved communities with limited access to books. Demand across the state far exceeds current funding. According to the Imagination Library cost estimator, there are 82,021 keiki in Hawai‘i who are eligible for this program.

Friends of the Library of Hawai‘i respectfully requests clarification and amendment of the funding provisions in the bill. As currently written, the bill currently states that a nonprofit partner provide 50 percent of funding for the program. At this time, FLH does not have access to funding sources sufficient to meet this match, nor are we aware of existing funding streams that could immediately satisfy this requirement.

To ensure a successful statewide launch, FLH recommends that the State fully fund the program during the first two years of implementation, with a gradual reduction in state funding to a 50 percent match by year five. This phased approach would allow time to build local partnerships, secure sustainable funding, and develop the infrastructure necessary to support enrollment growth. Achieving the goal of 65 percent of eligible keiki by year five will require a significant investment, estimated at approximately \$800,000 for the 50 percent match in that year alone. Total program costs should include administrative fees, allowances for a dedicated staff member, and travel expenses necessary to conduct outreach, attend community events, and register families statewide. Demonstrated program success during this initial period will strengthen efforts to secure long-term, sustainable funding.

Statewide implementation of this program would ensure equitable access for all keiki in Hawai‘i, strengthening families and improving school readiness. We respectfully urge the Hawai‘i State Legislature to support HB1934, with amendments, and invest in this cost-effective, globally proven program.

My name is Dr. Amy Bossler. I am a former licensed and highly qualified Hawai'i DOE educator and completed a Doctorate of Education in Exceptionalities Studies at the University of Hawai'i at Manoa in 2015.

I am testifying on behalf of the O'ahu Inclusive Co-op, a group of 194 families located in central O'ahu. We STRONGLY support H.B. 1934.

Supporting the Imagination Library isn't just "donating to books." It's investing in kids before the world tells them who they are.

Here's why it matters:

#### 1. It Builds Literacy From the Start

Children enrolled receive one free, high-quality book every month from birth to age five. That's up to 60 books in a child's home before kindergarten.

Early book access is strongly linked to:

- Stronger vocabulary
- Better kindergarten readiness
- Higher reading proficiency in elementary school

And literacy affects everything — graduation rates, job opportunities, even long-term health outcomes.

#### 2. It Helps Families Who Might Not Otherwise Have Books

Aloha Chair, Vice Chair, and Esteemed Committee Members,

I am writing in **strong and enthusiastic support of HB1934**, which establishes the Imagination Library of Hawaii Program to provide a free, age-appropriate book each month to every keiki in our state from birth to age five.

As a public school librarian working with our haumāna and ‘ohana each day, I see firsthand how powerful early access to books can be. When keiki grow up surrounded by stories, language, and ‘ike, they enter school not only better prepared academically, but more confident, curious, and connected. Programs like this help us build a culture of reading across our pae ‘āina — from our rural valleys to our urban neighborhoods.

In many of our rural communities, especially on neighbor islands and in more remote areas, there is a significant dearth of certified public school librarians. Too many of our schools operate without a trained library professional to guide information literacy, research skills, and equitable access to resources. These communities can become what experts call “information deserts” — places where access to high-quality books, digital tools, and literacy support is limited or inconsistent. As we attempt to solve the problems that lead to the creation of the information deserts by addressing the ever-evolving needs of public schools and libraries, we can also respond with aloha to fill the need.

HB1934 is one way we can respond with aloha. By ensuring that every keiki receives books at home — regardless of income, geography, or circumstance — we affirm that literacy is not a privilege, but a right. We strengthen ‘ohana as the first kumu. We nurture pilina through shared reading. We cultivate a love of mo‘olelo that reflects both global perspectives and the unique cultural heritage of Hawai‘i.

When keiki receive books in the mail, it sends a powerful message: *You matter. Your education matters. Your imagination matters.* That steady, predictable access helps level the playing field long before kindergarten begins.

Educators committed to equity and Nā Hopena A‘o — to belonging, responsibility, excellence, aloha, total well-being, and Hawai‘i — know that early literacy is foundational. Investing in universal book access is an investment in our collective future.
