Bill No. and Title: House Bill No. 2062, H.D. 1, Relating to Gun Violence Prevention.

Purpose: Appropriates funds to the Judiciary for the enforcement of gun violence protective orders. Appropriates funds to the Department of Law Enforcement to conduct public awareness campaigns on gun violence protective orders.

Judiciary's Position:

The Judiciary takes no position on House Bill No. 2062, H.D. 1, and thanks the House Committee on Judiciary & Hawaiian Affairs for incorporating our suggested amendment clarifying that the purpose of the Judiciary appropriation is to support the efficient processing of temporary restraining orders and gun violence protective orders, rather than the enforcement of such orders.

Upon further review, and in light of statewide budgetary constraints, the Judiciary has determined that it does not require additional appropriations at this time to effectuate the intent of this measure. We appreciate the Legislature’s consideration in proposing this funding and will

Opposition to HB2062 (HD1)

Hawaii Firearms Coalition respectfully submits testimony in strong opposition to HB2062 (HD1).

This measure seeks to dramatically expand funding and infrastructure for the State’s red flag law system, despite the fact that the existing law has seen limited use since its passage. Rather than addressing demonstrable failures or gaps in current statutes, this bill appears to be driven by frustration that more petitions have not been filed. The solution proposed is not improved due process or clearer standards — it is increased spending and active promotion of firearm confiscation procedures.

HB2062 would appropriate taxpayer funds to advertise and encourage the public to utilize red flag petitions. It would also dedicate additional court resources specifically to process these cases. This is concerning. When government begins funding public campaigns designed to encourage citizens to initiate firearm confiscation proceedings against others, it shifts from neutral adjudication to active promotion.

Red flag laws are fundamentally different from other judicial tools. Unlike temporary restraining orders, which are tied to defined disputes and typically involve prompt adversarial hearings, red flag orders allow firearms to be seized first — and only afterward does the owner bear the burden of fighting to restore their rights. In some cases, these orders can be extended or made effectively permanent, resulting in the loss of constitutional rights despite the absence of any criminal conviction.

HB2062 does not reform these due process concerns. Instead, it seeks to expand the scale and funding of the system.

The State of Hawai‘i already has mechanisms in place to address individuals who pose a genuine threat to themselves or others, including criminal statutes, emergency mental health holds, and protective orders. Before expanding a program that removes constitutional rights without a

criminal finding, the Legislature should demand clear evidence of necessity, effectiveness, and constitutional durability.

Public safety is a serious matter. So are constitutional rights.

Hawaii Firearms Coalition urges the Legislature to reject HB2062 (HD1) and instead focus on policies that address violent crime directly, respect due process, and uphold both public safety and the fundamental right to keep and bear arms.

HB 2062, appropriates funds to the Judiciary for the efficient processing of temporary restraining orders and gun violence protective orders, also known as extreme risk protection orders, or “ERPOs”. It also appropriates funds to the Department of Law Enforcement to conduct public awareness campaigns on gun violence protective orders.

ERPOs are court orders that allow the temporary removal of firearms from individuals at highest risk to themselves or others before tragedy strikes. Extreme risk laws are evidence-based solutions currently enacted in 21 states and Washington D.C. that give law enforcement and the courts an avenue to prevent an individual in crisis from harming themselves or others by temporarily removing guns and prohibiting the purchase of other firearms.¹ These laws effectively target various forms of gun violence we see on a daily basis in the United States, including interpersonal violence, homicides, intimate partner violence, some unintentional shootings, and importantly suicide, the most common type of gun violence. The presence of a gun turns what is frequently an impulsive act—that is usually not repeated if the person survives—into an almost always fatal act. People who choose a firearm over other methods typically do not have the opportunity or ability to summon help or reconsider.

By temporarily removing firearms or making them more difficult to access for individuals in the midst of a crisis, those with suicidal ideation are more likely to survive and get a second chance at life. That second chance is critical: *the vast majority—about 90 percent—of people who make a suicide attempt and survive do not ultimately go on to die by suicide later in life.*² This is why laws like extreme risk protection orders are so important.

Extreme risk laws are an important tool that can prevent tragedies because people closest to an individual in crisis are likely to see signs before the person acts. Research shows that gun violence is frequently preceded by an escalation in problematic behavior - threats (whether physical, verbal, or online), exhibiting inappropriate behavior with firearms, misuse of controlled substances or alcohol, violating prior restraining or protective orders, and/or stalking or harassing others.³ In many cases, family members or law enforcement are the witnesses to the troubling escalation of behaviors that typically precede an act of gun violence - whether that violence ultimately results against one's self or another individual. Extreme risk protection orders provide a way for the courts and law enforcement to temporarily remove guns from the situation and save lives.

Public education and awareness campaigns on ERPOs would have a measurable impact in reducing gun deaths across the state. ERPOs are an effective tool for preventing gun violence, but research shows that this effectiveness is limited due to a lack of public awareness around the existence of these laws, and their uses.

Hawai'i's ERPO law has the potential to prevent accidental gun deaths and save lives, but its effectiveness will be determined by how the state implements this law. Providing funding for a statewide public education campaign will ensure awareness and compliance, and will bolster the policy's effectiveness in reducing gun violence.

I stand in OPPOSITION to this bill, as Red Flag Orders, also known as Gun Violence Protection Orders, are flawed and they quite often violate the 5th Amendment of the Constitution. Such Orders are in essence Trails in Absentia without a chance for the subject of the order to counter accusations made against them in a court of law and face their accuser. Red Flag Orders are often used maliciously and have gotten people killed over them.

One example was after a heated political debate between a Niece and her Uncle during a holiday dinner. The Niece then filed a GVPO against her uncle, making false claims of her Uncle mentally unstable and likely to hurt himself. After a Judge issued the GVPO, Local Law Enforcement showed up banging at his door with a SWAT team in the early morning hours without properly announcing themselves. When the Uncle answered the door armed with a firearm in hand, he was gunned down by police. This was all over a dinner argument between a Conservative and a Liberal.

GVPOs, while well meaning, are too easily abused. There are other ways for credible threats to be handled through legal means and less onerous means that do not violate due process.

I am a resident of Hawaii concerned about the state's fiscal health and the efficient use of taxpayer dollars. I am submitting this testimony in strong opposition to HB 2062, which appropriates unspecified sums from the general revenues of the State of Hawaii for fiscal year 2026-2027 to fund additional staffing and administrative costs in the Judiciary for processing temporary restraining orders and gun violence protective orders, as well as community-based gun violence intervention initiatives and public awareness campaigns through the Department of Law Enforcement. While the intent to address gun violence may seem well-meaning, this bill represents an unnecessary and potentially burdensome financial commitment that could exacerbate Hawaii's already strained budget without delivering measurable results. Hawaii's state budget is under immense pressure, with ongoing challenges in areas like affordable housing, education, healthcare, and disaster recovery from events such as the Maui wildfires. The latest fiscal projections indicate that the state is facing a potential shortfall in the coming years due to rising costs, inflation, and slower tourism recovery post-pandemic. Allocating blank-check funding—literally, as the bill leaves the appropriation amounts unspecified ("\$ or so much thereof as may be necessary")—to new programs without clear cost estimates or proven efficacy is fiscally irresponsible. This open-ended approach invites unchecked spending, potentially adding hundreds of thousands or even millions to the state's expenditures for hiring personnel, administrative overhead, and marketing campaigns, all drawn from general revenues that could otherwise support critical infrastructure or tax relief for residents. Consider the financial implications in detail:

- **Judiciary Funding:** The bill would require hiring additional personnel across each circuit to handle gun violence protective orders under Chapter 134, HRS. Based on similar judicial staffing expansions in recent years, this could cost upwards of \$500,000 annually per circuit just for salaries, benefits, and training, not including ongoing operational costs. With no cap specified, these expenses could balloon, straining the Judiciary's budget which already relies heavily on state appropriations amid rising caseloads.
- **Department of Law Enforcement Initiatives:** Funding public awareness campaigns and intervention programs is another vague commitment. Comparable state-funded awareness efforts, such as those for traffic safety or public health, have historically ranged from \$200,000 to \$1 million per campaign, often with questionable return on investment. In a state where the cost of living is among the highest in the nation, diverting funds to these initiatives means less money for essential services like policing core crimes or emergency response, potentially leading to higher taxes or cuts elsewhere.

- Overall Budget Impact: Hawaii's general fund is projected to face deficits if new spending isn't carefully controlled. This bill, even in its amended form (HD1), lacks fiscal notes detailing exact costs or cost-benefit analyses, making it a risky proposition during a time of economic uncertainty. Taxpayers should not be saddled with funding programs that may duplicate existing efforts, such as federal grants for violence prevention or current law enforcement resources, without evidence of their necessity or effectiveness.

Instead of approving this bill, I urge the committee to prioritize fiscal restraint and redirect any potential funds toward high-impact areas that directly benefit Hawaii's families, such as reducing property taxes, bolstering public schools, or investing in renewable energy to lower utility costs. Approving HB 2062 would only add to the financial burden on residents without guaranteeing safer communities. Thank you for considering my testimony. I respectfully request that you hold or vote **no** on HB 2062.

State and county agencies already have the ability to conduct outreach and public education using existing resources and communication channels. Earmarking additional funds specifically for public awareness campaigns risks unnecessary spending without clear evidence of improved outcomes.

Hawaii residents already face one of the highest overall tax burdens in the nation. At a time when the cost of living remains a serious concern for many families, it is critical that the Legislature prioritize fiscal discipline and ensure that limited public funds are directed toward core functions that deliver measurable impact.

In this context, I strongly support prioritizing:

- Enhanced training for law enforcement and first responders
- Efficient and timely judicial processes
- Coordination across agencies to ensure cases are handled effectively and consistently

These investments directly affect outcomes and help ensure that vulnerable individuals receive protection and services when they need them most.

By contrast, public awareness campaigns while well-intentioned should not be funded as a standalone priority when agencies can incorporate outreach into their existing operations.

I respectfully urge the Committee to amend the measure to remove funding for public awareness campaigns and instead prioritize operational effectiveness, training, and system efficiency.

Hawai'i has some of the nation's strongest firearm laws, but since the passage of the gun violence prevention order (GVPO) law, **the state has seen an increase in firearm suicides**. Evidence shows that temporarily removing guns from people in crisis can reduce the risk of firearm suicide.

As part of an effort to drive down firearm suicides, the state should dedicate resources to make sure law enforcement, courts, and the public know about the GVPO law and have the training to use it effectively.

These resources are needed to implement the law and save lives. According to a recent Civil Beat article:

"Honolulu and Kaua'i police haven't filed any petitions since the law was enacted. The Honolulu Police Department doesn't train all of its staff on the law and information on how to file the petitions is tough to find publicly available online, even for police."

These laws can also be utilized if someone is determined to be a danger to others; in other states these laws have been used to avert violence against others.

Aloha Chair and Members of the House Finance Committee,

My name is Michael Brown, and I submit this testimony in strong opposition to HB206 due to its wasteful spending, redundancy, and lack of demonstrated need.

HB206 would expand and fund Hawai‘i’s existing “red flag” framework by allocating additional taxpayer money for **court processing** and **public promotion** of firearm confiscation petitions. This bill prioritizes growing and advertising a program rather than addressing core concerns such as due process safeguards, transparency, effectiveness metrics, and real-world outcomes.

From a fiscal perspective, this is the wrong direction. **Court systems are already strained**, and taxpayer funds should be directed toward urgent, measurable priorities—such as public safety resources that are already proven, mental health crisis response, victim services, and improving the efficiency of existing court operations. HB206 adds administrative and promotional costs while increasing workload pressures, creating an ongoing funding obligation without clear evidence of public demand or benefit.

Just as important, **Hawai‘i already has established legal mechanisms** to disarm individuals who pose a legitimate danger, including criminal statutes, restraining orders, and protective orders—tools that come with more established procedural standards and due process protections. Expanding an additional, parallel system is **redundant** and risks duplicating efforts rather than improving outcomes. If gaps exist, the better approach is to strengthen and properly resource the systems already in place—not build and market an additional one.

At a time when Hawai‘i faces serious budget pressures and competing needs, **spending more taxpayer money to expand and promote a program that is duplicative and not clearly utilized is not responsible governance**. HB206 asks taxpayers to fund more processing and public outreach for confiscation petitions without first demonstrating a compelling need, measurable effectiveness, or cost-benefit justification.

For these reasons, I respectfully urge the Committee to **HOLD HB206**.

Responsible governance requires careful prioritization of limited resources. Taxpayer dollars should be directed toward clear, demonstrated needs — not toward expanding bureaucracy or promoting programs that have not shown measurable demand or effectiveness.

For these reasons, I respectfully urge you to vote NO on HB206.

Good afternoon, Chair Todd and Vice Chair Takenouchi, and Members of the House Committee on Finance. I am providing testimony in **Support of H.B. 2062, H.D. 1**. This Bill proposes an appropriation for the Judiciary to help underwrite the costs for an anticipated increase in the usage of Gun Violence Protective Orders (GVPO) that are projected to occur in connection with educational efforts by the State Department of Law Enforcement promoting the use of GVPOs through another appropriation to DLE for that purpose also incorporated into the Bill. GVPOs are an effective tool to quickly remove firearms from the possession of individuals determined by a judge to be an imminent danger to themselves or others. While this important violence prevention tool has been available since 2019 its usage has been very limited due primarily to the lack of awareness by the public. This is indeed unfortunate in the face of an increasing number of gun violence incidents in Hawai'i including a disturbing increase in the number of gun related suicides. There is clear evidence from other states in which GVPOs are more extensively used that they can effectively help to prevent gun deaths and injuries. As has been said so many times, an ounce of prevention is worth a pound of cure. H.B. 2062, H.D. 1 represents a significant and worthwhile investment in violence prevention in Hawai'i that would hopefully pay big dividends in saved lives.

I strongly urge the members of this Committee to support H.B 2062, H.D. 1 as a concrete contribution to reducing gun violence in our state. Thank you for your time and consideration.



I am writing today in **strong support of HB 2062, HD1**, Relating to Gun Violence Prevention, which appropriates funds to the Judiciary for the efficient processing of temporary restraining orders and gun violence protective orders, and appropriates funds to the Department of Law Enforcement to conduct public awareness campaigns on gun violence protective orders.

In the mid-1990's, I was involved with the Hawai'i Firearms Control Coalition and the Keiki Injury Prevention Coalition which were lead organizations in working to address gun violence as a public health crisis. I am proud that the efforts of the coalitions succeeded in passing substantive gun violence prevention measures at that time that have continued to place Hawai'i amongst the leaders nationwide in the effort to minimize the morbidity and mortality associated with guns.

Unfortunately, the use of firearms in domestic violence continues to be a threat for victims of domestic abuse. In the US, **more than 25 million adults have been threatened or nonfatally injured by an intimate partner with a firearm and access to a gun makes it five times more likely that a woman will be killed by an abusive intimate partner.** House Bill 2062, HD1 is common sense legislation to improve processing of temporary restraining orders and gun violence protective orders that has the potential to save lives and prevent harm.

I respectfully request that you vote in **support of HB 2062, HD1** and help protect victims of domestic violence.
