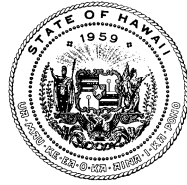

1 The Department of Health (Department) supports this resolution and appreciates the
2 Legislature's efforts to better address behavioral health needs on the Waianae Coast.

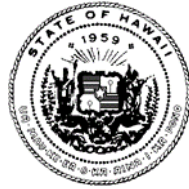
3 The Department believes that treating and assisting people where they are is often the
4 most effective. It allows them to stay in their community, close to their social structure and in
5 an environment where they are comfortable. The Department also recognizes that this
6 approach is not always economically feasible. Therefore, the Department appreciates the
7 approach in this resolution, which seeks to consider data-driven needs, economic feasibility and
8 budgetary constraints.

9 Behavioral health and substance use disorders are unique to the individual and can be
10 responded to in a multitude of ways depending on the individual's need. This resolution
11 addresses that by including different considerations in the feasibility analysis.

12 While the Department is not named in this resolution, it remains committed to working
13 with the City and County of Honolulu and the Statewide Office on Homelessness and Housing
14 Solutions for the data under the control of the Department needed to complete the required
15 plan.

AGENCY'S POSITION: The Statewide Office on Homelessness and Housing Solutions (SOHHS) supports this resolution and offers comments. This resolution urges the City and County of Honolulu (City) and SOHHS to develop a coordinated, place-based strategic action plan to address behavioral health and homelessness response needs on the Wai'anae coast. The coordinating agencies are requested to engage with community-based service providers serving the Wai'anae Coast region when developing this strategic action plan, and are requested to submit a report of findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2027.

SOHHS welcomes the opportunity to continue to partner with county and community-based organizations to identify resource gaps and opportunities for increased investment in homeless services and housing programs, including resources focused on individuals with

behavioral health needs. SOHHS, the City, and other State and community partners work together to coordinate responses to homelessness on O'ahu, including low-barrier shelter, behavioral health stabilization resources, and long-term housing programs. We welcome the opportunity to continue to collaborate with the City on specialized interventions that will break the cycle of homelessness for people with behavioral health needs.

Chair and Members of the Committee:

Aloha Independent Living Hawaii (AILH) **strongly supports HCR116**, which requests the City and County of Honolulu and the Statewide Office on Homelessness and Housing Solutions to develop a coordinated, place-based strategic action plan to address behavioral health and homelessness response needs on the Waianae Coast.

AILH is a Center for Independent Living serving people with all types of disabilities statewide. Our mission is to support disabled people to live independently in their communities, including those who are unhoused or experiencing behavioral health challenges.

Disability, Homelessness, and Waianae

According to the 2024 Point in Time Count, there have been significant increases in both the total number of houseless individuals and the number of unsheltered individuals on Oahu since 2023. Of the 4,494 people experiencing homelessness on Oahu on January 22, 2024, the largest concentration was on the Waianae Coast, and over half of those individuals were classified as chronically homeless. Chronic homelessness is highly

correlated with disability, including serious mental illness, substance use disorders, and physical and cognitive disabilities.

Despite this concentration, the resolution notes there are only six shelter programs operating in the Waianae Coast region. This mismatch between need and available resources creates serious risk for disabled residents who lack access to housing, crisis services, and ongoing behavioral health supports.

Independent Living Lens on the Strategic Action Plan

AILH strongly supports the call for a unified, intergovernmental, place-based plan with shared priorities and improved coordination. The requested plan elements—analysis of behavioral health emergency calls and response times, evaluation of ER utilization for psychiatric crises, assessment of crisis stabilization bed capacity, identification of high-need zones and service gaps, and evaluation of coordination among outreach, providers, and first responders—are all critical to building a disability-responsive system on the Waianae Coast.

We also support the feasibility analysis of a regional crisis stabilization or triage center, including potential sites, partnership models, and funding sources, as well as identification of needed statutory or budgetary changes. From an Independent Living perspective, crisis responses must prioritize voluntary, community-based supports, trauma-informed practice, cultural safety for Native Hawaiian communities, and clear pathways to permanent, accessible housing—not just short-term crisis beds.

Centering Disability and Community Voice

The resolution requests engagement with community-based service providers in developing the plan. AILH respectfully recommends that this engagement explicitly include:

- Organizations led by people with lived experience of a disability and houselessness; and
